



People on the Move – Society Chatelaine Appointed

The Board of Directors is pleased to appoint Michele Hays (Baroness Jeanne-Marie la Verriere, OL) as Society Chatelaine.

Court will take place at Their Royal Majesty's or Their Excellency's discretion, with tournaments to begin directly after court. All attendees are required to sign-in with the Waiver Secretary. Golden Sun A&S Competition – Entrant's Display Options

The Kingdom Arts and Science Office would like to provide an opportunity for all artisans who desire to display their works of art and share their scientific discoveries with the Crown and Populace of Atenveldt a forum by which to do so.

There are many ways in which to display one's art works and receive feedback. For our April A&S Event, we provide the following categories:

- **Champion Display** : Competing to become Kingdom A&S Champion. Eligible for Populace Choice, Laurel's Choice, King's, Queen's, Prince's or Princesses' Choice. The CROWN OR CROWN HEIRS of the Kingdom of Atenveldt shall select this Champion to serve for the period of one reign. Duties of the Champion shall be determined by the CROWN OR CROWN HEIRS OF ATENVELDT.
- **Youth Champion Display**: Competing to become Kingdom A&S Youth Champion. Eligible for Populace Choice, Laurel's Choice, King's, Queen's, Prince's or Princesses' Choice. The CROWN OR CROWN HEIRS of the Kingdom of Atenveldt shall select this Champion to serve for the period of one reign. Duties of the Champion shall be determined by the CROWN OR CROWN HEIRS OF ATENVELDT.
- **Showcase Display**: Showing art or science works only – not eligible for the title of Kingdom A&S Champion or Kingdom Youth Champion. Eligible for Populace Choice, Laurel's Choice, King's, Queen's, Prince's, or Princesses' Choice.
- **Heraldic Competition**: Come to the event and represent your Barony, your Kingdom, or your personal arms and win an award for each category. You should be wearing or holding your representation and be prepared to do a walk through the crowd to drum up support.

Coronation Saturday at the Klein Center for the Performing Arts (aka Buena High School) site opens at 9am and closes at 5pm. You are encouraged to come fill the indoor halls of the grand theater as we bid a fond retirement to our current King and Queen, and witness Their Heirs take station in the thrones of Atenveldt!

Refreshments showcasing culinary skills will be provided between courts.

Champions Sunday at Arbenz Park, This site opens at 9am and closes at 5pm

King's and Queen's Champion – King's Cut and Thrust Champion – Archery Champions – Thrown Weapons (Yes, all in one location on one field).

There are shaded areas, but you are encouraged to carry parasols, wear hats, and sunscreen as we expect the Aten sun to greet us with its rays. The southern lands are also known for its windy, spring days. Chairs or picnic blankets are also encouraged. No staking allowed on the field. Hard suit fighters will vie for the title of King's Champion and Queen's Champion whilst the rapier combatants compete to be King's Cut & Thrust Champion! (Styles and formats to be determined by the Crown. Pick-ups allowed at the discretion of the marshals).

All, it is time for Atenveldt to have a new Kingdom Rapier Marshal. It has been an honor to serve in this office and I look forward to passing it on to new leadership. This position is mostly administrative and requires some familiarity (or willingness to learn) Google Suite, and also with managing two low-activity Facebook groups (Atenveldt Rapier Marshals and Aten Rapier). At events the Kingdom Rapier Marshal may arbitrate disputes regarding the rules or assist with marshaling, site setup, etc. but for the most part leaves managing Rapier activities to the designated marshal in charge.

The following is a comprehensive list of the responsibilities of the office:

- Reporting to the Society Marshal of Fence on time, on a quarterly basis
- Participating in Kingdom marshalate meetings and special projects
- Serving as Rapier Marshal in Charge at the request of Kingdom event organizers
- Representing the Rapier marshalate to the Crown and Kingdom Seneschal
- Communicating rules changes from Society to the Kingdom
- Ensuring local group marshals are trained and qualified to authorize Rapier fighters in their group
- Maintaining a list of Kingdom Deputy marshals, some "at large," who may authorize Rapier, Cut and Thrust, and/or Rapier Spear fighters
- Providing guidance to local marshals regarding rules interpretations
- Moderating disputes regarding rules interpretations, instances of misconduct on the Rapier field, and other interpersonal conflicts pertaining to Rapier combat.
- Receiving and responding to Adverse Event Reports, and passing on relevant information to Society
- Responding to request for information from Society
