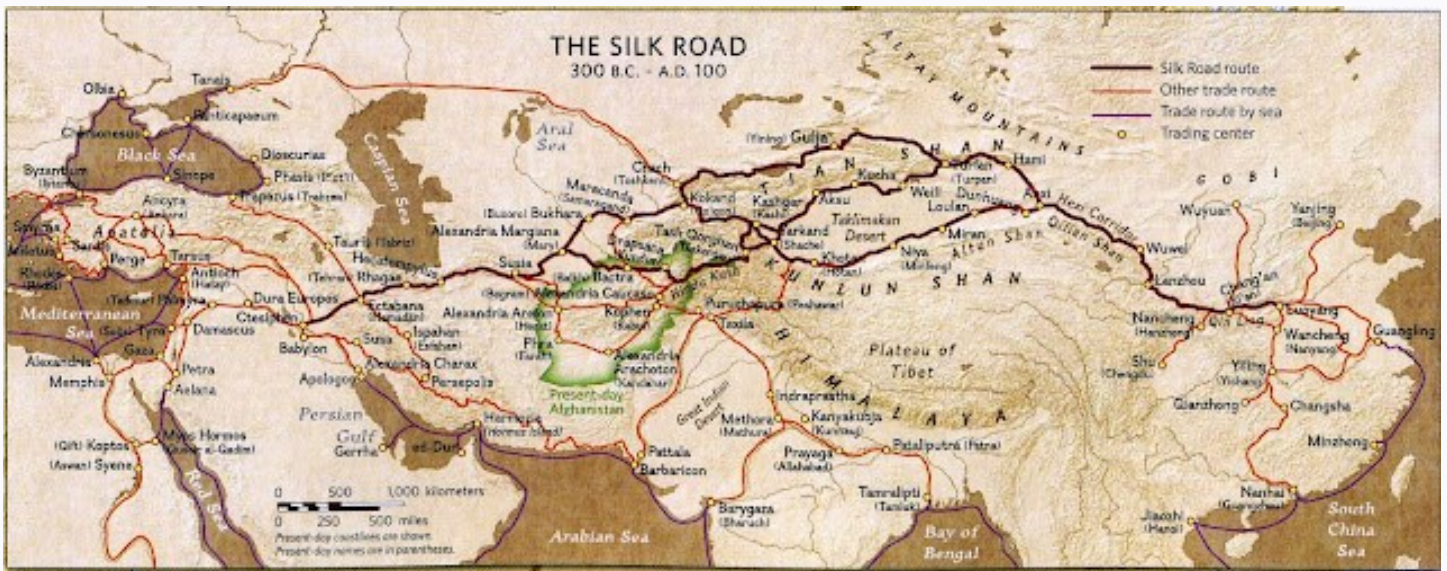

- **Group name** • Name of the group hosting the event. Must be an official group.
- **Location and directions** • Name and directions to the legal address of the site.
- **Autocrat** • Autocrat's Society name, a contact phone number with area code, and email address. **Mundane name and address are no longer required.**
- **Registration** • Member & non-Member for event, with deadlines (for pre-registration) as necessary. If there is a Registration for the event, the following statement must be included beneath the \$ amounts: "Make checks payable to SCA, Inc./(group name)." If the event is free, say so!
- **Activities** • Brief synopsis of event, site restrictions, handicapped accessibility, etc.
- **Duration** • Start and stop time of the event.

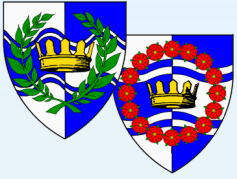

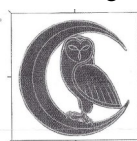

Atlantia Curia – March 26, 2023  
 Zoom Meeting – 7:00 p.m.

**Maistre Cian** opened the meeting with a reminder of who may speak during Curia; Their Majesties, Their Highnesses, Territorial Barons and Baronesses, Great officers of State, Officers of State and all Branch Seneschals.

**Dame Morwenna** – noted that the Branch Seneschals were omitted in the Acorn announcement. Maistre Cian stated that was an oversight and the Branch Seneschals are in fact included.

Maistre Cian explained that he would conduct the review by identifying the change, why the change was made, Their Majesties would expand on this, then questions would be allowed. We are going to do a pairing here.

*First Change was identified –*

**7.6 Protected Kingdom Events and Their Weekends**

Protected Kingdom Events are:

- Twelfth Night – held on the second Saturday in January
- Spring Coronation – held on the first Saturday in April, unless this is an Easter weekend, then it is moved to the second Saturday in April
- Spring Crown Tournament – held on the first Saturday in May. This event may not be virtual
- **Summer University\* - held on the second Saturday in June**
- **Fall University\* - held on the third Saturday in September**
- Fall Coronation - held on the first Saturday in October
- Fall Crown Tournament – held on the first Saturday in November, unless the first Saturday falls on November 1st, then it is moved to the second Saturday in November. This event may not be virtual
- War of the Wings - held on the third week of October.

\*The University Chancellor, after consultation with the Kingdom Minister of Arts and Sciences and the Crown, may choose to cancel one University session in a year.

\* The University Chancellor, after consultation with the Kingdom Minister of Arts and Sciences and the Crown, may choose to cancel one University session in a year.

Maistre Cian explained that this change was made to encourage University attendance. He invited Their Majesties to make comments.

**K** - The rationale for this started with the University staff members coming to us to expand attendance at University. We love University. We think teaching is a big part of what we do here and we think that University a great time for that. We were a little bit hesitant at first but they brought to us detailed analysis of event conflictions of over a decade and not only did the University dates rarely conflict with anything, when they did conflict with small one off events, those events significantly impacted negatively the attendance at University. So, it makes sense for us to protect those weekends as Cian says. Of course if there is something that HAS to happen that weekend there are variance options to do that written into the law but we are hoping that it encourages University attendance and it didn't seem like there was any real legitimate reason NOT to protect those weekends. And so we are hoping that University will be well attended and as we step down we'll be attending those events and hope to see you there.

Cian - We did verify that those events in the past that have conflicted are not long running continuing events. They were one off events.

**Audience Question** - Cian selected – **Baroness Marie-Therese, Baroness Ponte-Alto** who said she was in agreement with that change but wanted to know why Winter University was not included as well?

**Q** – That is a great Question, thank you! Winter University as it stands right now is online exclusive. We felt like it was a good compromise to protect the two in-person University sessions and then leave the solely online University unprotected to give folks who really like the online experience flexibility to attend that. There are folks that do not like events that are solely online. So, we wanted to give them the flexibility to NOT attend.

**K** – It came to our attention also, we are aware that Winter University has not always been online and that was a Covid contingency. That continued for a cycle and our original thinking was that was a good compromise as Her Majesty said and that will give everybody the best of all things.

**Q** – There is a comment in the Chat : *Genevieve d'Aquitaine, Deputy Registrar* : *University did not have the data to back up asking for protecting Winter University. Thank you for that chat contribution.*

**Maistre Cian** – Any more questions or comments on this change. <crickets> Okay, moving on.

### Appendix C - Charter of the University of Atlantia

**In order to increase accessibility for members of the populace across the Kingdom, each University session must have an online component. If a just cause is presented, after consultation with the University of Atlantia Chancellor and Staff, the required online component may be waived by the Crown.**

Maistre Cian asked Their Majesties to address this change –

**Q** - This change was really to again bridge the gap in accessibility for multiple people and wanting to ensure the online component is incorporated. Not that we are relying solely on online, because there are people who really do not like 100% solely online events. But there are people for who it greatly increases their accessibility so we really wanted to have that in there. There is a provision where the crown can waive if necessary. I see a hand up.

**Maistre Cian** called upon - **Baron Harald Brandarm Olafsson, Baron of Dun Carraig** – I am concerned about an undue burden it will put on people to host a University because now they have to take into account an online component. I think making that optional or highly suggested, but I don't like making it mandatory.

**Q** – I'll speak to that then I'll turn it over to our KMOAS, Sophia. This was suggested by University staff, the folks that would be holding and facilitating the event and facilitating the online component. We were concerned at first that it added an additional burden so we talked through it, and we don't want it to be a complex online component, it just has to be an online component. If it is incredibly burdensome, if there is justification that can be provided we do have the provision to waive that.

**Sophia** called upon by the Queen to speak to this – Sophia said, Like our University Chancellor put in the chat: *Jeane Kilmenny (she/her), University Chancellor* : *University staff provides it (online component)*.

**Sophia**: So, your Excellency Harald, if your group wants to host a university you don't have to worry about a thing. The University staff takes care of this and has for the past 3+ years and will continue to. The burden is not undue, we are handling it, we are on top of it. Anything else? Kilmenny anything to add?

**Kilmenny** – No you covered it, but correct me if I am wrong Sophia and Your Majesties, we were including this to insure that if it becomes necessary the Kingdom can help the University insure that we have the Kingdom resources available to help us maintain this service to the Kingdom and the populace without putting undue burden on the hosting group for the hybrid sessions. Would that be a correct understanding of what we were all intending?

**KMOAS** – Sophia - Yes Ma'am

**Maistre Cian** – This puts it on the Kingdom to be sure we have the resources. Baron Harald your concern was certainly a good one, we don't want to put undue pressure on anyone wanting to host the University. As they said the University will take care of that. They handle all that and the local group hosting does not have to worry about that. And we do have the option if it is not possible at that site it can be canceled.

I see a hand up for Ishmael.



**Baron Ishmael Stedfast**, Seneschal Roxbury Mill – One of my members requested we make a small and meaningful suggestion to further amend the University charter to change the language in the charters mission statement from ‘Medieval and Renaissance period’ to ‘Pre 17<sup>th</sup> century’ in line with other changes made elsewhere in the SCA to expand the starting time of the SCA. It’s just one other place we can make that language change. Maistre Cian – that is a good suggestion but we cannot change it this time because all changes must be published 30 days before changes, but if you send it to me I will present it to Their Highnesses for their curia if they decide to have one, so we can get that taken care of. That is a very valid point, Thank you.

Another hand is up – **Baroness Geneve Wolfilin, Steirbach** – I just wanted to go back real quick to the idea of flexibility because it is a valid point that we don’t have endless resources and we need to be careful where we put our energy, but I also feel like the kind of event University is that accessibility is such a big issue and I know that in our local group there are people very active in our A&S community that are also very hesitant to attend an in-person event. I hear from multiple people multiple times how nice it is to have this online component to the University and how accessible it makes it, I really think this is a good idea.

**Maistre Cian** - Thank you your excellency, that was really the whole point of it, to make it accessible. I personally enjoy the in-person activity, but when there is a University in Maryland, I live in South Carolina and that’s a long drive from here. So having this make it accessible not only for the distance but for other issue it makes it easy for folks to attend.

Maistre Cian called on KMOAS - Sophia – Spoke words to assure people that the Kingdom has resources to help those who feel daunted if they are hosting an online University. She requested that they reach out to her because she has your back.

Maistre Cian - Any more comments to change that portion of the Charter? <crickets> There is another line being added to the charter that just states Their Majesties names and the date the changes their Majesties made to the charter.

**And amended this 26<sup>th</sup> day of March, AS LVII, by Abran I and Anya I**

**Maistre Cian** - The last change in the law is looking at **6.3 Tenure and Renewal Terms of Territorial Baronage**

The initial term of office is hereby defined as three (3) years. The term may be renewed for two (2) years; however, no more than two (2) renewal terms of two (2) years will be granted, (i.e. no more than seven (7) consecutive years).

- **Territorial Baronage may choose to step down prior to the expiration of their initial term.** Should they choose to step down prior to the end of their initial term, **this shall not constitute a successful conclusion to their term , and it will be at Their Majesties’ discretion whether the term shall be considered successful or not.**

**Maistre Cian** - We had a couple cases where we had to get variances because somebody had to step down, mostly because of Covid scheduling, to get things back on track those years of Baronages you understand how Covid messed up everything and investitures were happening different times of the years, so we’re changing it so instead of automatically not being a successful term it will be up to their Majesties. If someone just up and rage quits yeah, pretty much assured Their Majesties will say that is not successful. But if something major has come up and they have to step down depending on when it is, they still may count it as a successful term. Mainly to limit the time we have to go to the BOD for a variance. The Bod does not like to issue variances so we don’t have to follow our own law.

**K** – That’s absolutely right Cian. The main issue there is to protect hard working people that are doing a lot. And things come up, real life comes up. If somebody does 2 years of a three year term and something life changing comes up and they can’t finish I think we should have to adjust for that without go around the society. As Cian said we’ve learned from several other issues that have arisen trying to get a variance that are in our laws that didn’t seem like an issue but have become an issue, and so I think that’s a good change that will prevent us from dealing with that situation.

**Q** -I agree. Giving us flexibility when it is needed and appropriate.

Maistre Cian - Are there any comments or questions regarding that change. <crickets> That is all the changes we have for this curia. I’ll ask one more time. Any comments from anyone on these? If not, then we will call it a night.

**K** - I would like to make one quick statement for those who are here, I see a lot of faces I recognize and have gotten to know in the last year. I don’t know if everyone will be at the event next weekend but I have a tickle in my throat and may not last, so it’s been really awesome and I have enjoyed meeting all you guys, keep doing your good work and I look forward to seeing you in the future and I wanted to thank you all for your support this year because it comes from all kinds of places from many of you and many of your communities and I just want to thank you and I want you to spread that word to people who can’t make it this weekend. Atlantia rocks and you guys are awesome!

**Q**- It rocks because of you all. It’s been our honor and our privilege so thank you all for everything you do for making Atlantia what it is. Baroness of Ponte Alto, Marie Therese – Speaking for myself and Ponte Alto you guys have been fantastic and thank you for your reign!

**Maistre Cian** – Alright! If there is nothing else, I thank you all for attending Curia and taking the time out of your busy day and your weekend before we all go back to the grind tomorrow.

*-there was clapping*

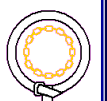

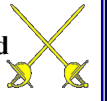
