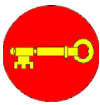

Greetings, all!

As is customary in our kingdom, rules for a Crown Tournament are published early in order to have ample time for those who seek the throne to meet all special conditions and submit letters of intent. We have published on the internet and had some conversations surrounding expectations; however, as our official publication in the newsletter, these are our rules and format for Crown 37.

Letters of Intent are due in hand by Coronation by email, mail, or hand-delivery.

Special request for this tournament:

If you are not a royal peer, we encourage you take the opportunity to participate in person for either Guenievre's and Tom's reign or Mary's and Lars' heirship and reflect on it in your letter of intent. Please write of your experience and thoughts on how you would reign in your letter.

Standard Kingdom requirements apply. Please see Northshield Law III-900 for further detail.

You must affirm that you and your prospective consort have read the Corpora of the Society for Creative Anachronism and the laws of the Kingdom of Northshield, read and understand the Rules of the Lists, and the conventions of combat of the Kingdom of Northshield.

Entrants must be suitable to the Crown.

Tournament Format:

Bring your best. All tourney weapons are allowed. May change weapons prior to any bout you wish.

Pool tourney.

- <= 8 people in the tournament: 1 pool, top 4 advance.
- 9 - 16 people in the tournament: 2 pools, top 2 from each pool advance.
- > 16 people: 4 pools, top 1 advances from each pool.

Ties are broken by the match that occurred between the fighters in the pool. Any multi-way mutually destructive ties will be re-fought.

Top 4 enter standard double elimination.

- First round: 1 bout.
- Second round: Lower bracket must win 2 out of 3, upper bracket need only win 1 out of 3.
- Finals: best 2 out of 3.

A final note from Princess Mary: Crown, to me, is the tournament to show everyone your chivalry, how skilled you are, and how you can work with the eyes of the Kingdom on you. It isn't just a tournament for the top 10 fighters in the Kingdom. So, it would please me greatly to see participation far and wide.

Greetings, gentles!

Included in this month's *Northwatch* is the 2023 Kingdom budget. Astute readers will note that the budget approves spending more funds than the Kingdom will take in. This is because Northshield has over

\$100,000 in cash reserves (on top of the Endowment Fund), and the Kingdom Financial Committee decided that it is acceptable to draw down those reserves, if needed, for some improvements to benefit the entire Kingdom.

It's important to note that the budget is a pre-approval for spending, NOT a commitment to spend funds. For example, the 2022 budget showed an estimated expenditure of \$8,552; however, total actual spending was just under \$4,400. Total income was just over \$5,600, so the Kingdom made more money than was spent in 2022.

Also included in this month's *Northwatch* is the 2022 Northshield Financial Statement. This shows the beginning and final balances in the various Kingdom funds. I hope this helps shed some light on Kingdom finances. I am open to any and all questions about the Kingdom's money and I will always strive to be as transparent as possible about all aspects of Kingdom finances.

Finally, I am still looking for two deputies: Regalia Minister and now Exchequer Education Deputy. Mistress Gweniver served well and leaves a legacy of training information that new exchequers can use. That being said, there is still a need in our large Kingdom to help get new exchequers up to speed and feel comfortable in this critical role. If you are interested in either of these jobs, please contact me directly.

I'm Farolfus, a resident of the Barony of Nordskogen, and I'd like to introduce myself as your new Kingdom Minister of Arts and Sciences (big thanks to Vlad for stepping in for the past 6 months). I am looking forward to serving the Kingdom; we have so many curious and talented people, and I cannot wait to see what you all create, learn, and share over the next two years.

I also have some broad goals for my term, and I invite dialogue on them because they will require input and effort from other

Northshields in order to work. Some will be easier to address than others, and not all of them are 100% achievable in a two-year period, but everything has to start somewhere.

To help the A&S community continue to grow, we must promote ways for beginners to get comfortable with A&S (and not just in competition format). There are many ways to “do” A&S—how can we encourage folks to try it for the first time and then support their journeys?

The Kingdom A&S Faire is coming up in April, and I have been working with deputies to revamp the KA&S judging sheets. The new Novice division sheets are designed to be very beginner-friendly, and changes to the Open division sheets aim to provide a clear yardstick for judges and entrants alike. These and other updates will debut soon. Will you join us this year as an entrant, displayer, and/or judge?

I am committed to working toward diversity, equity, inclusion, and belonging (DEIB) in the Kingdom’s A&S community. For starters, I want to ensure that Northshield’s A&S is inclusive of all cultures within the SCA time frame; examine and address any Eurocentric bias that may be baked into the judging rubric/structure; and expand accessibility for a wider range of abilities and learning styles and make sure that accommodations are useful, available, and easy to request. What does DEIB in A&S look like to you?

And a final goal: investigating opportunities for continued virtual participation, recognizing that not everyone can travel for one-day events or has access to a robust local A&S group. Financial, family, job, health, or geographic constraints should not bar anyone from participating in the A&S community. How might we continue to use virtual tools to reduce barriers?

I look forward to speaking with many of you about these topics. My email inbox is always open at moas@northshield.org.

SCA MEMORIAL TOURNAMENT RAISES \$22,000 FOR CHARITY

In the midst of all the pageantry, education, entertainment and combat, the efforts of members of our community helping those experiencing vulnerability can sometimes be overlooked. The Society remains committed to being the best we can, anchored in our core values and nothing demonstrates this like the actions of individuals in our groups giving back to others. For more than 17 years, members of the Kingdom of Meridies (Alabama, almost all of Georgia, a bit of the Florida panhandle, most of Tennessee, and parts of southern Kentucky) have been doing just that.

Meridian Grand Tourney is that kingdom’s preeminent event for field pageantry and heavy fighting, comprised of several qualifying tournaments that culminate into a final Grand tourney. One of these is the Francois Duvant Memorial Tournament, sponsored privately by the Order of the Chalice, which is beloved for its focus on service and spreading good works. Voluntary contributions and patron sponsorships are compiled from combatants and onlookers at the event, which combine with proceeds from a field lunch, to enable winners to direct a charitable donation. Past recipients include shelters devoted to the safety and wellbeing of women and children.

This year, Jarl Ailgheanan of Atenveldt proved victorious and together with his consort, Duchess Amber Bikkisdottir, asked that the proceeds be donated to The Trevor Project.* They wish to thank all who participated for their generosity, and the Order of the Chalice for institutionalizing a tourney promoting chivalric deeds that bring relief to those in

need. They hope others continue to find ways to take the light generated from participation within the SCA and reflect it back onto their world.

The \$5,000 raised at the event grew thanks to a generous employer match (some 2:1), plus another match arranged by the receiving charity, resulting in a total impact of \$22,000. This brings the total donations raised by the Order and generous individuals to nearly \$70,000 since the Tournament first began.

(*The Trevor Project is a non-profit organization focused on suicide prevention efforts among lesbian, gay, bisexual, transgender, queer and questioning youth. LGBTQ+ youth are more than four times as likely to attempt suicide than their peers, not because of their orientation, but because of the mistreatment and stigmatization in society.)

Ailgheanan and Amber chose this charity to honor the memory of a young teen who they loved, a fixture in their home and close friend of their children, who was lost last year. Their hope is that other children can be saved.

COMMITMENT TO SCA DIVERSITY, EQUITY & INCLUSION

The Board of Directors recognizes and thanks the members and participants who have taken the time to share their thoughts about the importance of diversity, equity, and inclusion (DEI) in the SCA. It is a sign of the passion that people have for our organization, its communities, and making it better and more accessible for all.

The Board remains committed to the Society's equity journey, diversity in our membership, and the broader contributions that these aspects make to becoming a more inclusive organization. The limitless ways diverse needs can intersect and change is why we always need to be looking to provide better help and support beyond what is already being done and admitting when things can be done better.

The Society has grown and changed throughout its 56-year history. Going as far back as 1978, when the Board upheld the right of women to fight in Crown List, to confirming the right for same-sex couples to hold territorial baronial seats, the subsequent acceptance of same-sex couples in Crown Lists, and the ongoing work of the College of Arms for cultural and gender affirming heraldry and titles, the Board has been making steady changes towards inclusion for years following

the procedures prescribed in Corpora. We have seen work led by the DEI Office help us update our Mission Statement to expand our focus to pre-17th world history, improve our policy positions and increase the education resources available. Most recently the Board developed and subsequently endorsed the Oral History proposal and committed to an initial calendar of Days of Recognition. It is with grateful thanks that we acknowledge the work undertaken by many individuals that has led to this growth.

DEI is, however, an ongoing process and one where we must always ask ourselves how we all can do better. The Board acknowledges that there is still significant work to be done and education to be undertaken both at the corporate level and across the organization. It is through sustained commitment to action that these changes will be realized. As part of this continuing work, all Directors are currently undertaking a DEI in the Workplace Certificate Course, complementing any previous SCA education they have participated in.

As part of the Board's enduring commitment to deliver on the SCA's vision, mission, and values, the Directors continually evaluate the outcomes of its strategic initiatives. While excellent foundations have been established, it became evident that the Board's initial direction would not deliver its intended outcomes. As a result, the Directors have begun the process of strategic course-correction to bring us all closer to the better and more inclusive Society that we all want and deserve.

Work has continued on a refocused DEI strategic initiative which will be discussed in more detail at the upcoming January Quarterly Meeting. Strategic initiatives must always be reviewed to ensure ongoing relevance, and this is particularly important for DEI. STATUS OF REDUCED ARMOR RAPIER EXPERIMENT

Unto the Rapier Community,

Recently the Reduced Armor Experiment was ended without much warning. There are a few reasons for the ending of the experiment, but the primary reason was because of the lack of reporting we were receiving concerning the experiment. Without consistent information advising us otherwise, I had to assume that we were exposing the Society and its participants to increased risk and that was unacceptable.

At this time, I am conditionally reopening the experiment with the expectation that reporting will be handled correctly. The expectation from this office is that any experiment regardless of the marshal activity will be reported on every quarter to this office or the experiment will cease.

Along with reporting I will be scheduling a series of meetings with Kingdom Earl Marshals and/or their Rapier Deputies to discuss the wording in the experiment as there seems to be two separate experiments happening and not just the one that was approved.

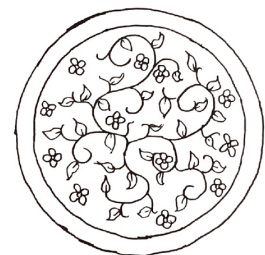

DEAR ABBESS:

I am a merchant and several months ago I entered into negotiations to purchase some copper from Ea-Nasir, a seller in Ur. At first, he promised me that he would “give fine quality copper ingots,” but when I sent my employee Gimil-Sin to pick up the ingots, they were absolute crap. Gimil-Sin protested, but Ea-Nasir was incredibly rude and just told him “If you want to take them, take them; if you do not want to take them, go away!” So my guy told him where he could shove his crummy ingots and left. The problem is, now Ea-Nasir won’t give me a refund either, even though I have sent several messengers to demand it since then. So now I have no money AND no ingots. I have never been treated so badly and I’ve been purchasing copper from merchants for a long time. I am totally at a loss—what should I do?

DEAR NANNI,

This Ea-Nasir fellow sounds like a terrible businessman and you are well within your rights to demand a refund if you have not accepted the product. I suggest you send him a formal

notification of your demand for a refund and remind him that his business practices are lousy. I suggest you also lay out

concrete terms for any future dealings with him—for example, do not accept any further copper sight-unseen, and make him deliver to you. Insist on selecting only high-quality ingots individually in your own yard, and remind him that if he is going to treat you this way, you will exercise your own right of rejection. I encourage you to send the letter on a highly stable material, since you or others may need to rely on it in the future. Given that you are located in Ur, I suggest that you use a clay tablet. This should serve as a durable reminder to Ea-Nasir of what happens when you try to fob off poor-quality copper ingots. Let it be a lesson to others in the future.
