Submission of Event Flyers:

The deadline for submitting event flyers is the 1st of the month preceding the month of publication. Thus, for a flyer to appear in the February Ambassador, it should be submitted by January 1st.

Group Seneschals should fill out the Event Submission form and attach the event's proposed flyer. [Event Submission Form – Gleann Abhann](#)

Copy for Kingdom Events will be run for four months only: the three months prior to and the month of the event. For events occurring within the first ten days of the month, copy may run for the four months prior to the month of the event. Copy for other events will be run for three months only: the two months prior to and the month of the event. For events occurring within the first ten day of the month, copy may run for the three months prior to the month of the event.

Event Copy Submissions: Send all electronic submissions to chronicler@gleannabhann.net. Send checks to the Exchequer and email release form codes to the Chronicler. When personal information is listed the submitter must include a “Personally Identifiable Information Release Code.” Release forms are located in the Chronicler's section of the Kingdom website. Please see: release.deputy@gleannabhann.net

Your flyer **MUST** contain:

1. 1/2” margin
2. Date of the Event (Month, Day & Year).
3. Time of the Event and when site opens and closes.
4. Name of the sponsoring group.
5. Location (name, street address, and town) of the site.
6. The name and email address of the autocrat.

If there is a reservation fee being charged for the event, the statement “Make checks payable to “SCA, Inc. Group Name” must be included. (Example: Make checks payable to SCA, Inc., Barony of Grey Niche).

The Member discount must also be specified in the fee schedule. Correct nomenclature for the costs to attend fees should be as follows: “Adult Event Registration” and “Adult Member Discount Event Registration.”

Members who have their personal information published are required to sign a waiver releasing that information and are assigned a release code. Release codes are **REQUIRED** for submission of the Event Flyer. Please contact releasedeputy@gleannabhann.net for additional information.

Kingdom Level Events are **REQUIRED** to accept PayPal for reservations. PayPal is optional for local events and is not required for events which do not charge for admission.

File format: When using digital media please send your copy in “.jpg”, “.doc”, or “.pdf” format with a resolution of 200 ppi/dpi or better. Any un-readable

format will be returned for re-formatting. The Kingdom Chronicler reserves the right to edit or adjust all submissions in order to most efficiently utilize the space available in the publication. Any submission not received in an uneditable format may be rejected for this reason. It is recommended that a text version of all flyers be submitted along with the fully designed flyer.

Kingdom Level Events receive a full page and are given priority. Local events receive a half page. Local events may upgrade to a full page for no cost, depending on available space. The Ambassador no longer charges for advertising.

Page sizes: (reduction may occur when printed) full page - 8.5” x 11” with a 1/2” margin. 1/2 page horizontal/landscape - 8.5”w x 5.5 ”h, with a 1/2” margin.



I have held the office of Gleann Abhann Kingdom Law Clerk for many years, supporting Crown and Kingdom thru good times and bad. It is now time to hand over the responsibilities of this office to a fresh face. As such, I am taking applications for a Replacement Deputy.

Contrary to the name, you don't need any experience in mundane law. You are simply the keeper of the Master Kingdom Law and Heraldic Law documents. When the Crowns, Kingdom Seneschal, or Heralds wish to make updates to these documents, it is your responsibility to draft up the change documentation, ensure it is signed and published/announced properly, update the Master documents, and send them to the Kingdom Librarian for publication on the Kingdom website.

Applicants must be a Paid Member in good standing in the Society. You must have a working knowledge of Corpora and the current Kingdom and Heraldic Law documents. You don't need to know them by heart, however you do need to know where to go within these documents to find the answers you need. You need to have access to a computer with Internet access and a word processing application that can edit Microsoft Word documents and save them in PDF format for publication. From this day forward, as long as my Crown allows, I am bound to be faithful, holding honor and courtesy above all.

CROWN: Let all here bear witness, that We, _____, King of Gleann Abhann, and _____, Queen of Gleann Abhann, hear and accept your oath of fealty, given in good faith. In turn, We vow to defend you and yours, with word, deed, and force. Those that keep and hold this oath true will be rewarded with Our favor. Those that forget this oath and break faith shall be repaid with Our judgment and dreadful wrath. Now, arise and go, keeping honor and courtesy above all.
