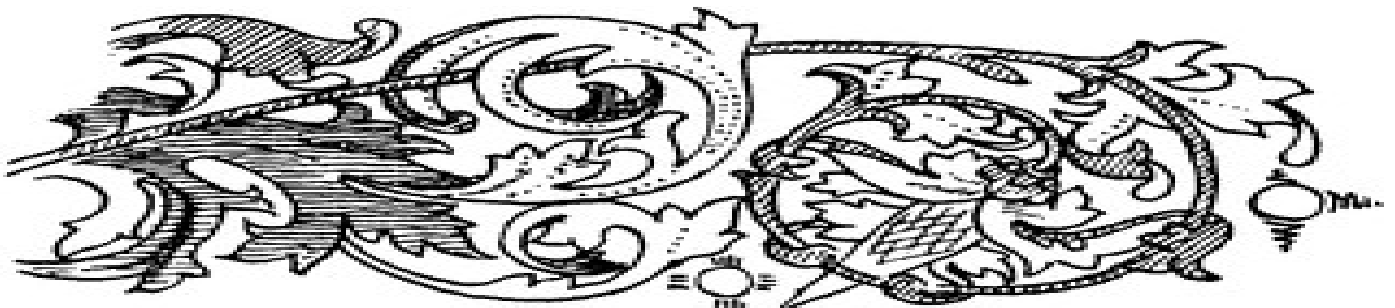
If you have the opportunity, please be sure to congratulate and welcome your new Prince and Princess to the Heirs thrones.

A Call to Service – Triskele Herald of Trimaris

Good Gentles of Trimaris,

The Kingdom seeks a worthy successor to take up the mantle of Triskele Herald, to guide and oversee the heraldic voice of our fair lands. The Triskele Herald stands as the steward of all heraldic activity within the Kingdom, tending not only to the words and ceremonies that grace our courts, but also to the care and strength of the College of Heraldry as a whole. This is both an administrative and creative role, balancing organization, leadership, and a love of heraldry in all its forms.

Duties of the office include overseeing heraldic education, coordinating device submissions, maintaining the Order of Precedence, and guiding commentary and consultation across the Kingdom. The Triskele Herald is responsible for training, warranting, and supporting Lesser Officers and local heralds, ensuring that knowledge is passed hand to hand like a well-kept torch.

This office works closely with the Crown and Kingdom officers, providing quarterly reports and serving as a member of the Kingdom Financial Committee, helping shape and enact the annual budget. The Triskele Herald also appoints and warrants deputies and local officers as needed to ensure the smooth operation of heraldic activities throughout Trimaris.

Attendance at key Kingdom events is required, including at least one Coronation, one Crown Tournament, one Arts & Sciences Faire, and one additional Kingdom-level event each year, where meetings may be held to support and strengthen the heraldic community. Candidates must be a paid member in good standing, warranted, and must remain in fealty to the Crown throughout their tenure.

This role is well suited to one who delights in both pageantry and precision, who finds joy in teaching others, and who is called to serve the Kingdom by preserving its voice, its names, and its history. EVENT FINANCIAL POLICIES

- All returned checks will be subject to a \$20 fee.
- Anyone who does not pay for their site registration by the time registration closes at an event will be considered to have spent the entire weekend with feast and shall be charged accordingly.
- Anyone who does not pay their event fees, or uses NSF checks to do so, will not be permitted to attend events until all fees are paid in full.
- Requests for refunds must be in writing and received (3) days in advance for a full refund. Requests made at the event will be refunded the site registration amount only. Refund requests will be accepted no later than (20) days after the close of the event.
- SCA & Kingdom policies apply to Children and Family site fees (no family more than 3 adult site fees; children 17 and under are exempt from site fee).

EVENT ANNOUNCEMENTS SUBMISSION CHECKLIST

Event announcements need to be submitted as a standard text listing containing the required information. Announcements should be submitted as early as possible to allow for corrections and more advertising for your event. Announcements must be created following the checklist below. This checklist is intended as an aid in the proper submission of event announcements. All event announcements at which any official business will occur **must** contain the following information:

- Name event and the sponsoring group.
- Date of the event.
- Event site location including name and address.
- Time the event site opens and closes to the public.
- Registration open and closing times.
- Name (mundane and SCA) mailing address, e-mail address, and telephone number of the Reservation Steward.
- Name (mundane and SCA), e-mail address, and phone number for the Event Steward
- Names (mundane and SCA), e-mail address, and phone number for the Marshal in Charge and Ranger in Charge
- SCA Corporate Anti-Bullying policy
- Site registration pricing and payment information.
- OPTIONAL: Description of the event activities.

In order to comply with Kingdom Laws and Policies, unless otherwise stated, the following standard event policies will automatically apply to all events submitted and held within the Kingdom of Trimaris.

- No family shall pay more than the equivalent of three (3) adult site fees. Family is defined as adults and their minor children. This applies to site fees only and does not include feast or cabin space.
- Unless otherwise noted, The site fees for children 12 and under are free.
- The SCA member discount for site registration shall not exceed \$10 per person.
