## *From the Topaz Herald*

The Diamond Herald and a few of the Deputies to this office are looking for replacement deputies!!!!

Master Jam Recarediz, Topaz Herald, sends greetings.

The time has come for my deputy to be chosen, with the intent that this person succeed to the role when my term is over. To that end, applications should be submitted to [topaz@gleannabhann.net](mailto:topaz@gleannabhann.net) with a CC to [diamond@gleannabhann.net](mailto:diamond@gleannabhann.net) no later than June 15, 2026.

The Topaz Herald's responsibilities include performing an inventory on scrolls in the scroll case or ensuring that inventory is performed periodically, maintaining and distributing the supply of pre-printed scrolls so they may be painted, and contacting scribes to ensure that champions' scrolls are available for each reign. It is not a requirement for the Topaz Herald to be a scribe; however, familiarity with the Gleann Abhann scribal community and with the award structure of the Kingdom is a great asset to this position. Another requirement of this job is to have access to a laser printer to print scrolls.

Applications should include a statement of interest, contact information including mundane and Society names, and a brief résumé showing relevant mundane and/or Society experience. This ad has been posted on our Facebook group, but we neglected to post it in the Kingdom newsletter. We've had some interest already in the position, but please apply if you are interested.

## *From The Diamond Herald*

The Diamond Herald, Mistress Daphne of Colchester Diamond Herald announces that both the Diamond and the Ruby Herald's offices are looking for replacement deputies.

Kingdom Law describes the Diamond job as the following, "The Diamond Herald will supervise and encourage all heraldic activities within Gleann Abhann, including scribal arts, field and court heraldry, device, and name submission, and all other activities within the College of Arms in Gleann Abhann. 2. The Diamond Herald will review Heraldic Law every (2) years and provide a list of any suggestions regarding the state of Heraldic Law to the Crown. 3. The Diamond Herald, or their appointed representative, will read into court any amendments or repeals to Heraldic Law, and publish. 4. The Diamond Herald, with the consent of the Crown, may create such deputies as they deem necessary to complete the tasks of the office."

Also, in Kingdom Law the Ruby's office is briefly described as "Ruby Herald. The Ruby Herald processes device and name submissions for the Kingdom, through the Society College of Heraldry" This Office needs attention to detail, ability to be trained in the process, working in a timely manner, good customer service skills and admin skills.
