Lastly. I want to thank the Crowns and Sir Gwynn for having the confidence in me to allow me serve our great River Valley Kingdom.

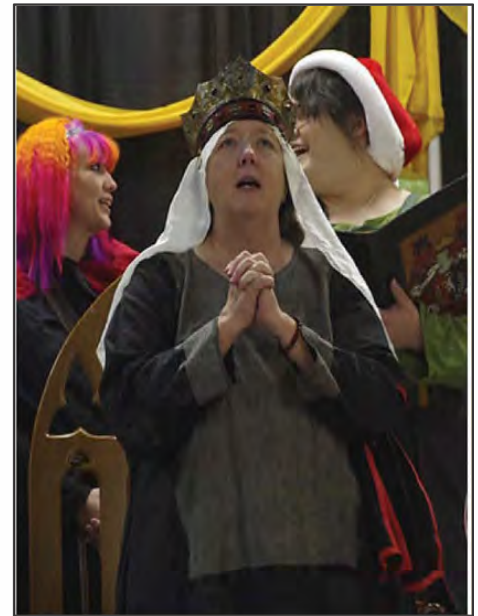
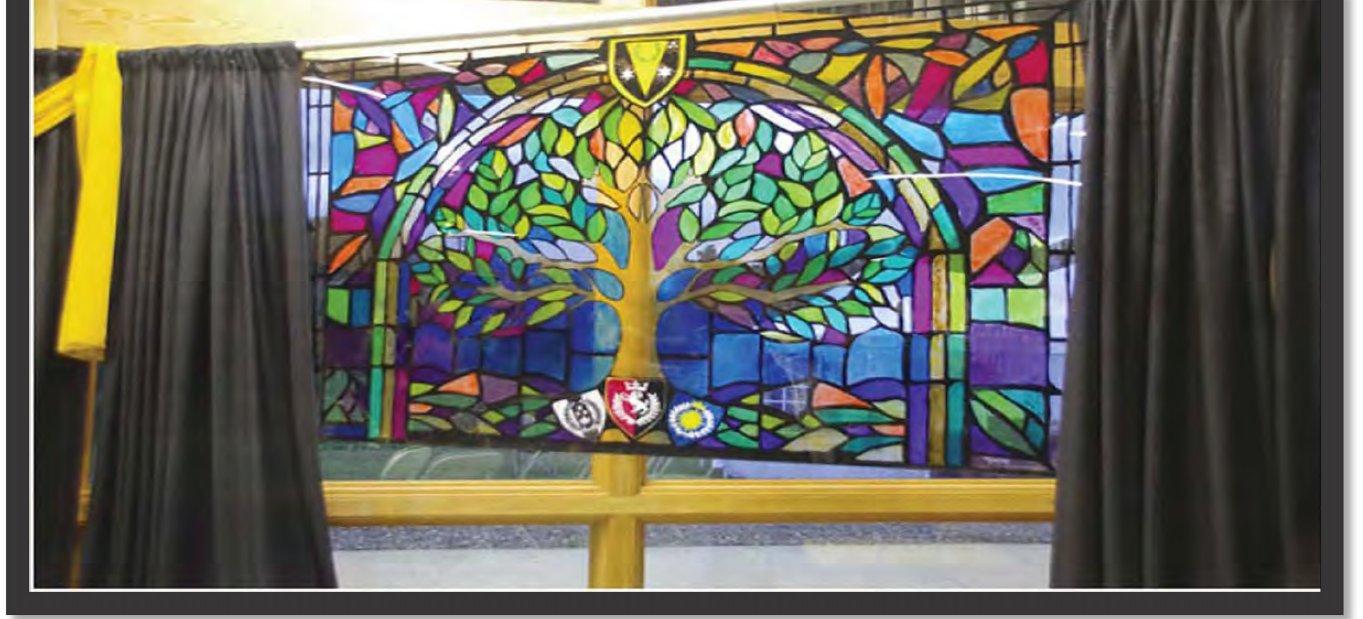
