


THE SCA PROHIBITS HARASSMENT AND BULYING OF ALL INDIVIDUALS AND GROUPS.

The SCA prohibits bullying and harassment of all individuals and groups. Bullying is systematic and unwelcome behavior which involves the use of influence, threat, intimidation, or coercion to cause hurt or harm to another person or group of people. When the bullying behavior is based on a protected class (1), that behavior is defined as harassment.

(1) race, sex, religion, national origin, gender, sexual orientation, age, or disability.

Bullying and Harassment may be **overt**, as in the following non-inclusive list of examples:

- Verbal abuse, including using racial, homophobic, transphobic, ableist epithets, etc.
- Non-consensual physical contact, violence, or threatening gestures.
- Displaying material that is offensive, degrading, or threatening to a protected class.
- Consistent demeaning remarks or malicious teasing - Stalking or predatory behavior

Covert:

- Spreading rumors or innuendo with malicious intent
- Deliberate exclusion, isolation, or alienation of an individual without just cause
- Using rank, title, or office to intimidate others

Provided that the behavior does not rise to the criteria listed above, bullying and harassment is not:

- Single episodes of social rejection, dislike, tactlessness, or forgetfulness.
- Mutual arguments, disagreements, or fights.
- The termination, mutual or not, of a romantic relationship or friendship.
- Reasonable constructive feedback or critique.

The test for bullying is the reasonableness of the behavior and the impact of that behavior on the recipient. Participants engaging in bullying/harassment are subject to appropriate sanctions. If an individual believes they have been subjected to or have witnessed harassment, bullying, or retaliation, that person should contact a seneschal, the President of the SCA, or that kingdom's Board Ombudsman.





Prince Oliver and Princess Grainne.



May peace yet hold. But if war comes, let Æthelmearc be found united, resolute, and steadfast in honor.



From the Kingdom Seneschal

Greetings Æthelmearc!

As I am sure we are all aware things have been getting more expensive for running events in recent years. Following the Covid shutdown, we discovered that many event sites had ceased offering their services during that time, and others had greatly increased their prices. More recently other costs of running events and operating the organization from top to bottom have jumped up as well. We are all feeling the financial squeeze.



Within recent months I heard the same comment repeated in terms of the gate fee for events: "But we're a nonprofit!"

And yes, indeed we are. But something I don't think some people realize is that being a nonprofit doesn't mean we don't have a budget. Nobody gets paid for their service to the Kingdom of Æthelmearc or any of its constituent groups. So, what do we do with all that money collected at the gate?

The money that the groups and kingdom collect throughout the year goes directly into the operations of the organization. We not only have to cover costs for our events, we also must cover other operating costs such as the IT infrastructure the kingdom website runs on, the pavilions used at Pennsic, and maintenance on regalia or other equipment.

Our budget is used for things that benefit all of us as subjects of the kingdom. Ideally, local groups should take in more than they spend on running events. This allows them to take the occasional loss on an event, and to pay for things that we need to keep what we do going. Kitchen equipment, loaner gear, pavilions and popups, regalia, and other things help keep the kingdom alive. Some expenses are compensated for allowing people of various economic means to hold kingdom offices.

All our finances, from the smallest shire to the SCA, are carefully kept track of via the exchequers. We have financial committees to validate their work and come to group decisions about how to spend our money. All of this is periodically audited by an external entity.

Officer Reports

So yes, we ARE a nonprofit organization. Any money you spend on the organization comes back to you in one way or another. Though it is unfortunate that things are getting more expensive, we consider the costs carefully when judging how much to charge to attend events. After all, the people who decide that are no different from you. We're all just members of a club that likes to study history, engage in applied anthropology through our historical recreations, and educate the world about the realities of the world prior to the 17th century.

In other news, I would like to announce that we are soliciting resumes and letters of intent for the position of Kingdom Seneschal. My term will be over in October of this year, so we need to get my successor selected soon. If you are interested in the position please send your resume and letter of intent to resume.seneschal@aethelmearc.org by the end of March.

The core requirements for the position are being a fully paid member of the Society for Creative Anachronism, a legal adult, and being able to pass a criminal background check if selected. The decision will be made by Their Highnesses, Oliver and Grainne, after they have ascended to the throne.

While the term technically rolls over in January, this term will shift the start date to after Pennsic.




Her Majesty remarked how one gentle spent the day with great enthusiasm and participation and named Weston her inspiration for the day.
