Event Specifics



The events herein have been registered in the Kingdom of Atlantia and have an event registration form on file with the Kingdom Chronicler.

For an event to be official, the following information must be published in the issue of The Acorn of the month the event takes place, **otherwise the event is declared unofficial** (i.e., registrations may not be collected, awards cannot be given, etc.):

- **Group Refund Policy**• Spell out your group's refund policy
- **Date of event**• Day, month, and Gregorian year that the event will take place.
- **Group name**• Name of the group hosting the event. Must be an official group.
- **Location and directions**• Name and directions to the legal address of the site.
- **Event Steward**• Event Steward's Society name, a contact phone number with area code, and email address. **Mundane name and address are no longer required.**
- **Registration**• Member & non-Member for event, with deadlines (for pre-registration) as necessary. If there is a Registration for the event, the following statement must be included beneath the \$ amounts: "Make checks payable to SCA, Inc./(group name)." If the event is free, say so!
- **Activities**• Brief synopsis of event—fighting, arts & sciences, merchants, et cetera.
- **Site Restrictions**—wet or dry, no animals, no smoking, et cetera,
- **Accessibility**—handicap parking & entrance/exit ramps, uneven terrain, et cetera
- **Duration**• Start and stop time of the event.

Violates SENA A3E3's prohibition on armory that uses only abstract symbols.

2. Thomas Perrin – New Device

Azure, a chevron Or, charged with a fleur-de-lys, between two fleurs-de-lys in chief and in base two hawks argent is administratively returned due to the device from not being properly filled out. In the future, the device must be included on the submission not as a separate page. Ibis attempted to contact the submitter to correct the problem via email; the submitter did not respond to emails.

3. Thomas Perrin – New Badge

(Fieldless) A fleurs-de-lys argent is administratively returned due to the badge form not being properly filled out. The image of the badge must be included on the submission form and not as separate page. This badge is in conflict with the badge registered to Cate-lin Parry the Patient, Fieldless, a fleur-de-lys argent, which is identical to the design submitted here. While fieldless badges receive a single DC from other fieldless badges, two DCs are required to clear a conflict. As no additional differences exist, this submission must be returned.

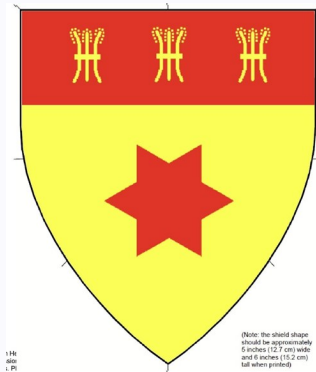
