(i.e., registrations may not be collected, awards cannot be given, etc.):

- **Group Refund Policy**• Spell out your group's refund policy.
- **Date of event**• Day, month, and Gregorian year that the event will take place.
- **Group name**• Name of the group hosting the event. Must be an official group.
- **Location and directions**• Name and directions to the legal address of the site.
- **Event Steward**• Event Steward's Society name, a contact phone number with area code, and email address. **Mundane name and address are no longer required.**
- **Registration**• Member & non-Member for event, with deadlines (for pre-registration) as necessary. If there is a Registration for the event, the following statement must be included beneath the \$ amounts: "Make checks payable to SCA, Inc./(group name)." If the event is free, say so!
- **Activities**• Brief synopsis of event—fighting, arts & sciences, merchants, et cetera.
- **Site Restrictions**—wet or dry, no animals, no smoking, et cetera.
- **Accessibility**—handicap parking & entrance/exit ramps, uneven terrain, et cetera.
- **Duration**• Start and stop time of the event.

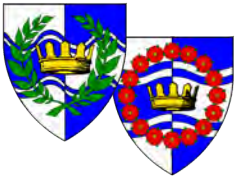

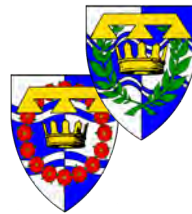

Duties and Responsibilities of Officers of State

The Officers of State shall:

Advise their Great Officer of State on matters pertaining to their office

Submit such reports as are required by their Great Officer of State and the laws of the Kingdom

Attend Curia Regis

Attend Unevent and host any meetings as required by their Great Officer of State

Supervise and coordinate the actions of their office, and, when applicable, their branch officers.

Perform additional duties and responsibilities as defined by their Great Officer of State to whom each report

Specific Duties for Deputies

* The **Emergency Deputy** shall be available should there be some reason the Kingdom Chatelain become unable to do their job. This role stands in for the Kingdom Chatelain until such a time as they are able to resume their job or a new Kingdom Chatelain is selected.

* The **Social Media Liaison & Outreach Deputy** manages social media campaigns for the Chatelains office. This includes, but is not limited to, Facebook, Instagram, TikTok and Discord. This role also works with public media outreach, conducting interviews and guided tours should they be requested.

* The **Special Projects & Demos Deputy** assists with any special projects assigned by the Kingdom Chatelain. This role also handles reporting for Demos throughout the Kingdom and notifies local groups of opportunities near them should they reach out.

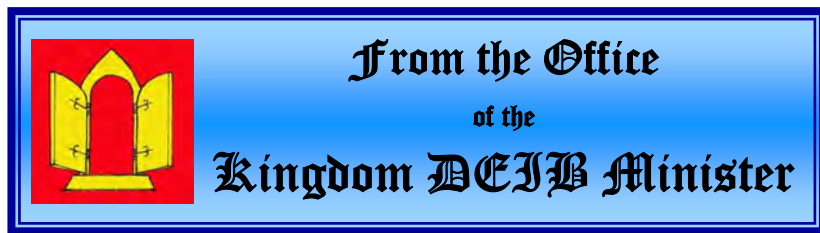
* The **Training & Education Deputy** assists with running Chatelain 101/102 classes, updating training materials, and making sure there are newcomer courses at University sessions.

The Kingdom Chronicler's Office is seeking an Emergency Deputy.

Per Kingdom Law (Atlantia Book of Law—5.11 Emergency Deputies for Great Officers of State):

Should a Great Officer of State resign or become unable to perform their duties, their Emergency Deputy shall take over their duties until a successor can be chosen or until the original officer is able to resume the duties of the office. The Emergency Deputy shall maintain all requirements of their office. The Emergency Deputy is not the " successor." The Crown retains the authority to choose the Great Officers of State.

Responsibilities of the Kingdom Chronicler Emergency Deputy include (Atlantian Policy 6.7.3 Additional Deputies):

Emergency Deputy Kingdom Chronicler

The EDKC is responsible for creating and distributing the Kingdom Newsletter in the event the Kingdom Chronicler cannot perform that duty. The must be a warranted chronicler and train with the Kingdom Chronicler for a span of two months to understand the process and access to all the necessary information has been shared.

All Kingdom-level Emergency Deputies are Officers of State. While serving as an Emergency Deputy you may not be a Branch Officer or hold another Officer of State Position. If you hold on at the time of acceptance you will need to step-down from that position. You may, however, serve as a branch deputy or at-large officer.

Greetings from Rhiannon Triton Principal Herald of Atlantia,

This is a call for Letters of Interest from anyone wishing to be considered for Nereid Herald, Emergency Deputy to Triton Herald.

As all should be aware, our current Neriad, Prince Ragnarr Blackhammer, is ascending to the Crown of Atlantia, and while the College hates to see him leave, even temporarily, it is both an unfortunate and fortunate necessity.

Nereid Herald is colloquially known as the Drop-Dead Deputy and is defined in kingdom law thus:

5.11 Emergency Deputies for Great Officers of State Should a Great Officer of State resign or become unable to perform their duties, their Emergency Deputy shall take over their duties until a successor can be chosen or until the original officer is able to resume the duties of the office. The Emergency Deputy shall maintain all requirements of their office. The Emergency Deputy is not the "designated successor." The Crown retains the authority to choose the Great Officers of State

Neriad Herald, as an Emergency Deputy, is an Officer of State, and Kingdom law requires all Officers of State to be paid members of the SCA

Nereid Herald does not need to be proficient at all aspects of SCA heraldic activity but they should be reasonably well versed in them.

They should be prepared to assist with the ongoing work of the College and its administration and always with an eye toward supporting the kingdom's heralds, scribes and populace in search of heraldic help.

The College is currently focused on recruiting new and encouraging existing heralds and scribes and showcasing their work; expanding access to and understanding of the submissions process; and expanding electronic payment options.

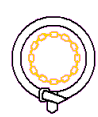
