

Greetings unto the populace of Northshield,



Here are the changes to the Northshield Rapier Rules for Spears.

2.2. Weapons and Parrying Devices

Previous:

A. Weapons

Heavy rapier blades are the only sword blades allowed for use in Northshield. A list of rapier and dagger blades approved for use in Northshield are listed in Appendix 1 of this handbook.

Revised:

A. Weapons

Heavy rapier blades are the only sword blades allowed for use in Northshield. Spears are allowed per rules and regulations found in the SCA Fencing Marshals Handbook. A list of rapier and dagger blades approved for use in Northshield are listed in Appendix 1 of this handbook.

Previous:

B. Prohibited Blades and Weapons:

Foils and epees are expressly prohibited for use in rapier combat in Northshield. Rigid steel "parrying-only" daggers, such as those made from cut down blades, will not be allowed. Flexidaggers are prohibited in Northshield. Rapier Spears are not legal for use in Northshield.

Revised:

B. Prohibited Blades and Weapons:

Foils and epees are expressly prohibited for use in rapier combat in Northshield. Rigid steel "parrying-only" daggers, such as those made from cut down blades, will not be allowed. Flexidaggers are prohibited in Northshield. Rapier Spears are not legal for use in Northshield.

A4.3 Weapons and Parrying Devices

A. Weapons

SCA Corporate Announcements

Feedback Request – Policy on Conduct

The Board of Directors is asking for feedback on the addition of a "Policy on Conduct" to the Corporate Policies

of SCA, Inc. which is suggested by the Society President.

Background:

The Society President listened to feedback from members about having more transparency. SCA, Inc. has concerns about legal risk to the corporation and harm to its members. There is a balance on how much information can be shared. Most people who wrote to the President mentioned sanctions (punishments for breaking rules). Many wanted clear rules to better understand what kinds of actions lead to sanctions.

Purpose:

The SCA has always valued keeping some things private, in order to protect the corporation and its membership, and has not talked much about sanctions in the past. The organization doesn't want to focus on the personal stories of those who break the rules or are investigated as this could lead to the very real danger of retaliation. However, members have asked for more transparency about why sanctions are given.

The Policy on Conduct helps balance the need for privacy with the desire for transparency. Sanctions can be upsetting, but the rules are important for the safety and fairness of everyone who participates in the SCA.

Design:

The Policy on Conduct brings together all the main reasons someone might break the rules of the SCA. These rules aren't new, but they are now organized in one place to make them easier for everyone to find. The rules are kept simple but clear enough to give guidance without putting the organization at risk. More detailed explanations of the rules are found in other handbooks and policies.

Benefits:

This policy helps the Board of Directors explain their decisions more clearly. It also gives a guide for investigations and helps members understand the reasons for sanctions. It should assist to build trust between the Board and the members by showing clear expectations for how everyone should behave in the SCA.

Summary:

It is suggested that a "Policy on Conduct" be added to the SCA Corporate Policies. Taking existing rules and gathering them into one policy helps the membership

better understand what leads to sanctions. Stating the rules with more flexibility allows the Board to explain their decisions in a way that is less risky to the Corporation. This "Policy on Conduct" allows more transparency for sanctions and helps the members know what rules not to break.

XX. Policy on Conduct

To promote a safe, respectful, and enjoyable environment for all participants, this Policy on Conduct outlines the expectations for behavior during all SCA events, activities, and interactions, both in-person and online. This policy does not supersede modern law. Violations of modern law should be reported to the law enforcement authorities.

A. Adherence to SCA Rules and Laws

- 1. All participants must adhere to the SCA's governing documents (Corpora, Corporate Policies, and By-laws), as well as Board-approved SCA Officer Policies, Kingdom Law, and any event-specific rules. Understanding and following these rules is the responsibility of all participants
- 2. Participants are expected to respect the decisions and directions of SCA officers, marshals, and event staff. These individuals are responsible for upholding the rules and safety standards of the SCA. Disagreements may be addressed through the chain of appeals as necessary.
- 3. Participants shall not behave in a manner which could put the SCA or its participants at risk or fear of imminent harm.
- 4. Violations of this policy may result in disciplinary actions, including but not limited to warnings, or Sanctions up to and including temporary removal of participation or revocation and denial of membership in the SCA. The degree of the action will depend on the nature, frequency, and severity of the violation(s).

B. Responsible with Resources

- 1. Corporate and Kingdom financial policies must be followed. This policy may be further defined in the "Society Financial Policy," individual Kingdom policies, and SCA Corporate Treasurer documents.
- 2. Officers and members responsible for managing SCA funds must ensure that

financial resources are used prudently, with transparency and accountability. See also "Exchequer's Handbook."

C. Respect towards Participants

- 1. The SCA promotes an environment free of bullying and harassment of all individuals and groups. This policy may be further defined in the Seneschal Handbook Policy on "Harassment and Bullying" and the SCA Conduct and Behavior Documents.
- 2. The SCA is committed to creating a welcoming environment for all participants. Discrimination based on race, ethnicity, gender, sexual orientation, religion, disability, age, or background is not allowed.
- 3. The SCA prohibits non-consensual sexual behavior including but not limited to sexual assault, sexual harassment, stalking, and sexual violence. This policy may be further defined in the Seneschal Handbook "Sexual Misconduct Policy" and the SCA Conduct and Behavior Documents.

D. Responsible with Minors

- 1. The responsibility for the care, supervision, and behavior of minor children rests solely with their parents or legal guardians at all SCA events, activities, and gatherings at all times. This policy may be further defined in the Seneschal Handbook "Dealing with Minor/Youth-Related Policies."
- 2. Parents and legal guardians are not relieved of their primary responsibility for the welfare and behavior of minors under their supervision when participating in SCA Youth Activities. This policy may be further defined in the Seneschal Handbook "Dealing with Minor/Youth-Related Policies."

E. Safety and Well-being

- 1. All participants must prioritize the safety of themselves and others during all activities.
- 2. Compliance with SCA established safety regulations and procedures is mandatory.
- 3. The possession of modern firearms at SCA events is prohibited. This policy may be further defined in the Seneschal Handbook "Firearms Policy."

F. Animals

1. The responsibility for the care, supervision, and behavior of pets and/or service animals rests solely with their owners at all SCA events, activities,

and gatherings at all times. This policy may be further defined in the Seneschal Handbook "Service Animals Policy" and "Pets at Official SCA Activities Policy."

- 2. Where animal restrictions apply, the only service animals allowed are those permitted under modern law. This policy may be further defined in the Seneschal Handbook "Service Animals Policy" and "Pets at Official SCA Activities Policy."
- 3. The hunting or slaughtering of live animals is prohibited at SCA functions. This policy may be further defined in the Seneschal Handbook "Policy on Hunting, Slaughtering, and Butchering."

G. Reporting and Enforcement

- 1. Members are encouraged to report any violations of this policy to the Office of the Seneschal. Reports must be made in good faith.
- 2. Reports of misconduct must be a nonanonymous first-person account. The SCA will document and keep reports confidential. Should an investigation become necessary, it will be conducted fairly and confidentially, respecting the rights of all parties involved.

Maestra Margalit's Paired Poetry Challenge

Welcome to the Challenge!

Poetry challenges were common across the pre-Modern (Period) world. For example, formal *utaawase* (waka) poetry contests existed in the Japanese Heian period (794-1185 CE), and Chinese challenges are documented during the Tang dynasty. European, Middle Eastern, and African poetic challenge traditions are less well documented, but have included response, debate or answer poems, in which one poet responds to a theme, dichotomy or specific poem presented by another.

All are welcome to join in the Challenge. It is NOT a judged contest.

Basic rules:

- 1. Two-person "teams" enter the Challenge. A team can enter together, or you can enter solo and be randomly matched with a partner.
- 2. Each team will choose a) one of the themes, b) a Challenge Level, and c) which of the pair writes first.
- 3. Team member #1 composes their poem, then passes it to Team member #2, who composes their response, both using the same theme. Team member #2's poem must clearly reference/respond to Team member #1's poem.
 - a. All poems must be in a documented Period style/format

(i.e., sonnet, waka, quintain, etc.), **length limited to 1 page**.

- b. Each author should briefly state the style/format, the approximate time period and place of that style, and a description of the style (see below).
- c. Other limitations as per the Challenge Level.

Challenge Starts: Feb. 14, 2025 Challenge Ends: May 14, 2025

Themes: Love, the Moon, Spring, Honor, Northshield, Margalit's die role (random off an eight-sided die).

Challenge Level I: Initial Poem and Response Poem can be from different styles, places, and times within Period (example: sonnet/Masnavi).

Challenge Level II: Initial Poem and Response Poem can be from different styles, but must match either the same approximate time period or the same approximate place within Period (example: Both Persian styles, but used in different time periods, or two styles circa 1500-1600's but one Western European and one Slavic).

Challenge Level III: Initial and Response Poems both using the same style (and thus same time period and place).

Challenge Bonus Points: One or both authors use a language other than

English. An English translation must accompany their poem.

Submission format:

Initial Poem first, Response Poem follows (or side by side).

Typed in legible font.

Include: theme, SCA name, modern name, poem style, time period and place, brief description of structure of the style.

Theme: Moon

Lord William Not Shakepeare (Bill Smith)

"Ode to the Harvest Moon"

(Poem here)

Petrarchan or Italian sonnet

Initially Italy 1200's, through Western Europe, England throughout Period. Structure:

- Fourteen lines
- Iambic pentameter
- An octave (8 lines) followed by a sestet (6 lines)
- Octave rhyme scheme of ABBAABBA
- Sestet rhyme scheme of CDCCDC or CDECDE




