(i.e., registrations may not be collected, awards cannot be given, etc.):

Group Refund Policy

• Date of event• Day, month, and Gregorian year that the event will take place.

• Group name • Name of the group hosting the event. Must be an official group.

•<u>Location and directions</u>• Name and directions to the legal address of the site. •<u>Event Steward</u>• Event Steward's Society name, a contact phone number with area

•<u>Registration</u>* Member & non-Member for event, with deadlines (for pre-registration) as necessary. If there is a Registration for the event, the following statement must be included beneath the \$ amounts: "Make checks payable to SCA, Inc./(group name)." If the event is free, say so!

•<u>Activities</u>• Brief synopsis of event—fighting, arts & sciences, merchants, et cetera.

•<u>Site Restrictions</u>—wet or dry, no animals, no smoking, et cetera,

•<u>Accessibility</u>—handicap parking & entrance/exit ramps, uneven terrain, et cetera •<u>Duration</u>• Start and stop time of the event.


