From Kingdom Earl Marshal

Greetings to all within the great River Valley Realm.

We are currently in the peak of summer. As some may know, the Society Earl Marshall is looking into a new policy for marshals to prevent heat-related injuries. This will involve extensive exploration and regional research to properly integrate the policy, and it won't be an immediate endeavor. Meanwhile, we ask that you honor the choices made by the event and local marshals. If they decide to take a conservative approach and cancel activities due to safety concerns, please uphold their decisions without trying to bypass them.

Additionally, the latest edition of the Society Armored Combat Handbook has been released and is now available on the official Society and Gleann Abhann websites. Marshals should add this to their collections, and fighters should acquaint themselves with the updates to the rules.

Working jointly with THLord Sebastian, we've created a comprehensive authorization form to accompany the revised Society handbook within Gleann Abhann. The form includes categories for armored combat, youth combat, siege activities, and live weapons, while also recording details for heavy, youth, and sparring marshals. Its purpose is to simplify and uniform the documentation process for authorities. This form is intended for use alongside the Society Armored Combat Handbook, as outlined in Sections 1.2-6 (located on pages 5 and 6):

2. Each Kingdom shall establish a procedure to authorize combatants for participation in SCA combat-related activities. These procedures shall verify that the candidate is familiar with the following:
 - a. Rules of the Lists of the SCA.
 - b. The Armor and Weapons standards of the SCA.
 - c. The Conventions of Combat for the SCA.
 - d. Kingdom-of-residence-specific Conventions of Combat.
 - e. Kingdom-of-residence-specific Armor and Weapons Standards
3. In addition to the above requirements, candidates must demonstrate the ability to function on the field in a manner that is safe both to themselves and to their opponents.
4. Only a warranted or rostered authorized marshal may perform an authorization. This authorizing marshal must witness the authorization and execute the appropriate paperwork to ensure that the authorization is registered with the appropriate kingdom official.
5. Authorization shall be registered with, and kept on file by, the Minister of the Lists or another designated official of each kingdom. This office shall be responsible for keeping properly completed waivers and maintaining the registration of authorizations. This office shall provide the Earl Marshal with a list of all current combat authorization cards upon request.
6. No authorization card may be issued until a properly completed Waiver is filed with the Kingdom.

Please note on the authorization form, we are officially implementing the change started under Sir Carson's tenure. From this point on, we will no longer be collecting the \$25 non-member charge. To be an authorized fighter in Gleann Abhann, we will require membership. It should not fall on the authorization marshal to collect and forward checks to the office of the Exchequer.

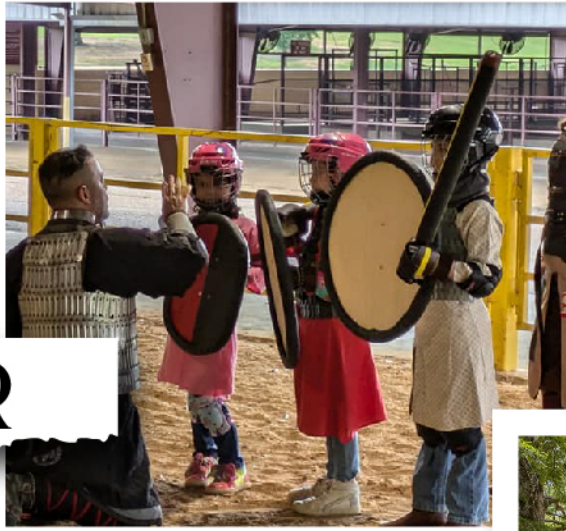

The position may present challenges, but for individuals passionate about our collective progress as a group and within the Society, it will be rewarding.

I trust that as the months progress, everyone is staying well-hydrated and preparing for the next season of events. Crown List is on the horizon!

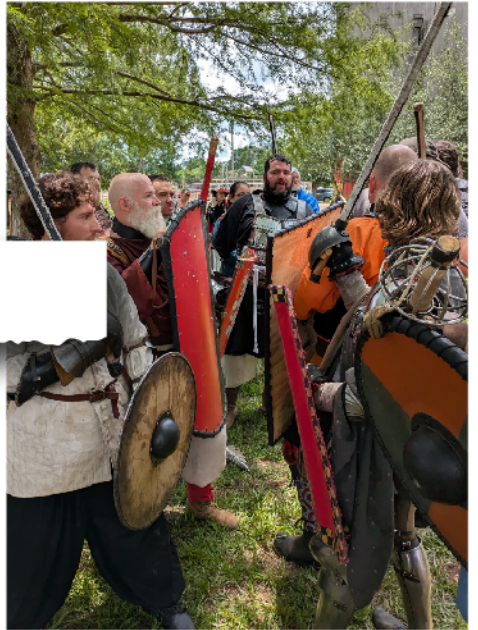

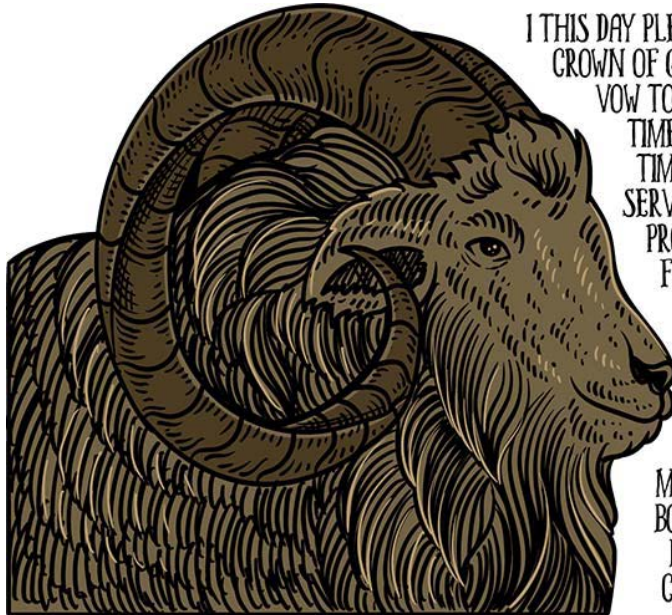
