#### DRAFT PROPOSAL FOR COMMENTARY

CORPORATE POLICY XIX. DELEGATION OF INVESTMENT AUTHORITY POLICY

The Board of Directors is currently considering the following addition to the SCA's Corporate Policy:

XIX. Delegation of Investment Authority Policy

The Board shall ensure that fiduciary responsibilities concerning the proper management of SCA, Inc.'s institutional funds are fulfilled through appropriate investment structure, internal and external management, and portfolio performance consistent with all policies and procedures. Based on the advice and recommendations of the Treasurer and its external fund manager(s), the Board shall approve investment policies and objectives that reflect the long-term investment-risk orientation appropriate to the organization. The Board may, at its sole discretion, create or eliminate committee(s) to advise the Board in furthering its duties and may select, appoint, and remove members thereto.

The Board hereby delegates supervisory responsibility for the management of its invested funds to the Corporate Treasurer, subject to the financial limitations specified in Corpora, as noted below:

- determine that institutional funds are prudently and effectively managed with the assistance of management and any necessary investment consultants and/or other outside professionals, if any.
- recommend the retention and/or dismissal of investment consultants and/or other outside professionals.
- receive and review reports from management, investment consultants and/or other outside professionals, if any.
- periodically meet with management, investment consultants and/or other outside professionals management, investment consultants and/or other outside professionals.
- report to the Board (as needed) whether this policy, investment activities, risk management controls and processes continue to be consistent with meeting the goals and objectives set for the management of institutional funds.
- execute such investment transactions as are necessary to ensure that SCA, Inc.'s investment portfolio reflects the asset allocation, investment-risk orientation, or other direction regarding the investment portfolio as has been established by the Board.

#### **July 2023 Open Seneschal Positions**

#### **Deputy Seneschal - Administration**

The Deputy Seneschal for Administration supports the Kingdom Seneschal by managing many of the ongoing administrative and communication tasks of the Kingdom. They organize and ensure availability of important documents (such as Kingdom Law and procedural manuals), and provide assistance in finding relevant information within those documents. They maintain warrants and officer lists for Deputy and Local Seneschals, as well as other ongoing data collection. The Deputy Seneschal for Administration also provides technical and administrative support to officer meetings such as scheduling Zooms and taking minutes; and other duties as required.

#### **Deputy Seneschal - Calendar & Events**

The Deputy Seneschal for Calendar and Events maintains the official calendar for the Kingdom of Trimaris and ensures that the calendar is accurate and consistent on all Trimaris information channels (Talewinds, Facebook, Discord, and Website) Primary responsibilities of this deputy include receiving event requests, coordinating calendar information with Kingdom Officers and local seneschals and event autocrats, and verifying that required information has been published by event deadlines for Talewinds and the kingdom website; then updating the kingdom calendar on Trimaris.org and with the Chronicler's Office. Additionally, the Calendar & Events Deputy educates event autocrats & local group seneschals on event-related deadlines and provides links to helpful information (ie. event handbooks, etc).

#### Deputy Seneschal - Incipient Groups & Group Recovery

The Incipient Group / Group Recovery Deputy assists the Kingdom Seneschal in the training and evaluation of potential new local groups in order to give them a foundation in policy and procedure, as well as coaching for best practices for successful groups. Additionally, they advise and evaluate groups looking to change status (Canton to Shire, Shire to Barony, etc.) They also serve as an outside advisor to help struggling groups find a path to success or make the choice to change status (demotion or dormancy); and other duties as required. #### Position Available – Marshal of the Society (Society Marshal)

The Marshal of the Society's area of authority is all martial and related activities practiced in the Society, both those described by the handbooks approved for the office and proposed as additions to those handbooks (experimental activities). The Marshal will work to encourage the participation of all in the Society's martial activities, and strive to expand and improve those activities for the benefit of the Society and its members.

The duties of the office include:

- Directing the Earl Marshals of the Kingdoms in matters concerning the supervision of martial and related activities at Society events
- Overseeing the manner and conduct of duties of all marshals throughout the Society
- Working to promote and improve the safety of the Society's martial activities
- Working with the Minister of Arts and Sciences to encourage research in armor, weapons, and the practice of historical martial arts

Day-to-day work of the position entails administering the marshallate activities of the Society and coordinating the activities of the Kingdom Earl Marshals, and of all Deputy Society Marshals for the individual disciplines. Reports are required to be filed quarterly to the Board summarizing the martial activities of the Society. The Society Marshal is also responsible for maintaining communications with the Kingdom Earl Marshals. These activities specifically include:

- Warranting (with the Crown) Earl Marshals for twenty kingdoms
- Warranting (with the Board) Deputy Society Marshals for Armored, Rapier, and Youth Combat, Combat
  Archery, Siege Weapons, Equestrian, Rebated Steel, and Target Archery and Thrown Weapons, and
  other deputies as needed
- Supporting the Earl Marshals when they have questions, and advising them as necessary
- Resolving disputes among marshals, and between marshals and the Crown
- Serving as the point of appeal for sanctions applied by the Earl Marshals
- Encouraging the expansion of martial activities in the Society by the wise revision of the marshallate's documents and by conducting experiments with new materials and activities

The successful candidate must be well versed in administrative techniques, problem solving, and interpersonal communications. The successful candidate will possess:

- Knowledge of marshallate policy, rules, and procedures
- Knowledge of the traditions of the Society
- Extensive negotiation skills and experience in resolving differences
- The ability to set aside all preferences and biases for the betterment of all
- Patience in the face of emotion, advocacy and provocation
- Expertise in the use of modern communications media, messaging, e-mail and telephone
- The ability and availability to travel as necessary



#### **EVENT FINANCIAL POLICIES**

- All returned checks will be subject to a \$20 fee.
- Anyone who does not pay for their site registration by the time registration closes at an event will be considered to have spent the entire weekend with feast and shall be charged accordingly.
- Anyone who does not pay their event fees, or uses NSF checks to do so, will not be permitted to attend events until all fees are paid in full.
- Requests for refunds must be in writing and received (3) days in advance for a full refund. Requests made at the event will be refunded the site registration amount only. Refund requests will be accepted no later than (20) days after the close of the event.
- SCA & Kingdom policies apply to Children and Family site fees (no family more than 3 adult site fees; children 12 and under are exempt from site fee).

### EVENT ANNOUNCEMENTS SUBMISSION CHECKLIST

Event announcements need to be submitted as a standard text listing containing the required information. Announcements should be submitted as early as possible to allow for corrections and more advertising for your event. Announcements must be created following the checklist below. This checklist is intended as an aid in the proper submission of event announcements. All event announcements at which any official business will occur **must** contain the following information:

- Name event and the sponsoring group.
- Date of the event.
- Event site location including name and address.
- Time the event site opens and closes to the public.
- Registration open and closing times.
- Name (mundane and SCA) mailing address, e-mail address, and telephone number of the Reservation Steward.
- Name (mundane and SCA), e-mail address, and phone number for the Event Steward
- Site registration pricing and payment information.
- OPTIONAL: Description of the event activities.

In order to comply with Kingdom Laws and Policies, unless otherwise stated, the following standard event policies will automatically apply to all events submitted and held within the Kingdom of Trimaris.

- No family shall pay more than the equivalent of three (3) adult site fees. Family is defined as adults and their minor children. This applies to site fees only and does not include feast or cabin space.
- Unless otherwise noted, The site fees for children 12 and under are free.
- The SCA member discount for site registration shall not exceed \$5 per person.
