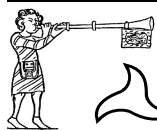

Greetings Trimaris,

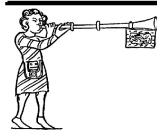

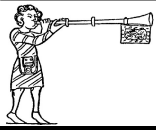

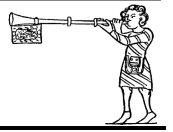

## DRAFT PROPOSAL FOR COMMENTARY

### *CORPORATE POLICY XIX. DELEGATION OF INVESTMENT AUTHORITY POLICY*

The Board of Directors is currently considering the following addition to the SCA's Corporate Policy:

#### XIX. Delegation of Investment Authority Policy

The Board shall ensure that fiduciary responsibilities concerning the proper management of SCA, Inc.'s institutional funds are fulfilled through appropriate investment structure, internal and external management, and portfolio performance consistent with all policies and procedures. Based on the advice and recommendations of the Treasurer and its external fund manager(s), the Board shall approve investment policies and objectives that reflect the long-term investment-risk orientation appropriate to the organization. The Board may, at its sole discretion, create or eliminate committee(s) to advise the Board in furthering its duties and may select, appoint, and remove members thereto.

The Board hereby delegates supervisory responsibility for the management of its invested funds to the Corporate Treasurer, subject to the financial limitations specified in Corpora, as noted below:

- determine that institutional funds are prudently and effectively managed with the assistance of management and any necessary investment consultants and/or other outside professionals, if any.
- recommend the retention and/or dismissal of investment consultants and/or other outside professionals.
- receive and review reports from management, investment consultants and/or other outside professionals, if any.
- periodically meet with management, investment consultants and/or other outside professionals management, investment consultants and/or other outside professionals.
- report to the Board (as needed) whether this policy, investment activities, risk management controls and processes continue to be consistent with meeting the goals and objectives set for the management of institutional funds.
- execute such investment transactions as are necessary to ensure that SCA, Inc.'s investment portfolio reflects the asset allocation, investment-risk orientation, or other direction regarding the investment portfolio as has been established by the Board.

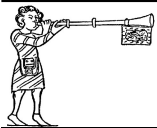

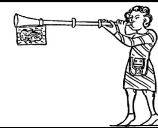

The Kingdom of Trimairs is seeking candidates for the Successor Deputy to the Kingdom Minister of Arts & Sciences. This is a voluntary position to train with the KMOAS until January of 2025 - after which, provided the Crown and Society Minister of Arts and Sciences approve, you would ideally become Kingdom Minister of Arts and Sciences.

The successful candidate will be primarily responsible for fostering the study of pre-17th century culture and technology, and of methods for producing historically accurate artifacts and performances. Duties include coordinating the efforts of Trimaris Group Arts and Sciences Officers, promoting the dissemination of information about the fields under study; and assisting the the mentorship and development of the Kingdom Art Sci Deputy positions: Chancellor of the Laureate, Trimaris Royal University Chancellor, and Art Sci Exposition Deputy Officer(s).

The duties of the Kingdom Minister of Arts & Sciences include, but are not limited to, the following:

Coordinating the reports and monitoring the efforts of local Ministers of Arts and Sciences and working closely with other Kingdom level officers to promote, encourage and advance the Arts and Sciences within the Kingdom;

Acting as a resource guide and referral service for persons looking for experts or information in a field of study pertaining to the Arts and Sciences within the context of the SCA;

Promoting, reviewing, and approving (with the other Kingdom Officers) the Trimaris Royal University and Kingdom Art Sci Fair Events in accordance with the guidelines outlined in Kingdom Policy;

Working with the Kingdom Officers to make sure all A&S needs are met;

Producing reports on a quarterly basis, or as otherwise requested, for the Society Art Sci Minister;

Performing other duties as directed by the Crown or Society Minister of Arts And Sciences (to whom you would directly report after becoming KMOAS);

Successful candidates for this position should be able to travel to 4 of the 6 annual Kingdom events, ideally including Winter Kingdom Art Sci and Trimaris Royal University, and have easy access to phone, mail, and reliable e-mail. Access to social media such as Facebook and Discord is ideal given a majority of Arts and Sciences groups communicate social challenge and community events and portfolios on these platforms;

An applicant must be a paid member of the Society and must be able to meet quarterly reporting deadlines in a timely manner. They must plan to attend Kingdom Meetings and Kingdom Financial Committee Meetings. All Kingdom Officers must swear fealty to the Crown of Trimaris;

This position presents the opportunity to help preserve the rich traditions of the Society and assure its future by assisting in the maintenance and promotion of the teaching and learning culture of the Society.

Per Kingdom Law:

5. The Kingdom Minister of Arts and Sciences

a) The Kingdom Minister of Arts and Sciences is responsible for the fostering of the Arts and Sciences in the Kingdom of Trimaris.

b) The Kingdom Minister of Arts and Sciences will regularly sponsor classes, symposia, and other educational seminars in conjunction with Trimarian Royal University.

c) The Kingdom Minister of Arts and Sciences will coordinate activities at the Kingdom Art-Science Fairs.

d) The Kingdom Minister of Arts and Sciences oversees the Lesser Office of Trimarian Royal University Chancellor.

e) The Kingdom Minister of Arts and Sciences reports to the Society Minister of Arts and Sciences and to the Kingdom Seneschal.

3. There will be two Arts and Sciences Events each year, one during each reign. These will be organized and administered by the office of the Kingdom Minister of Arts and Sciences.

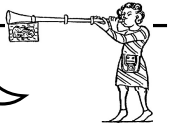

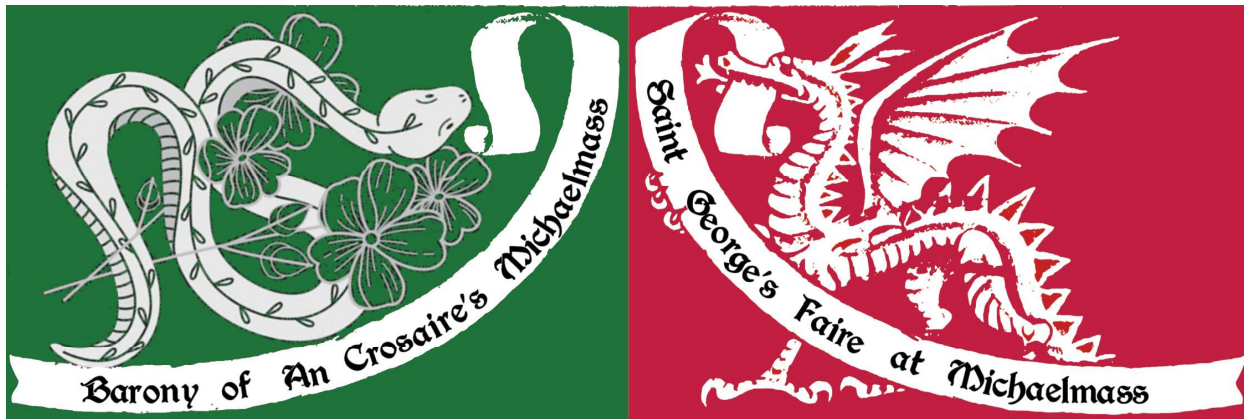

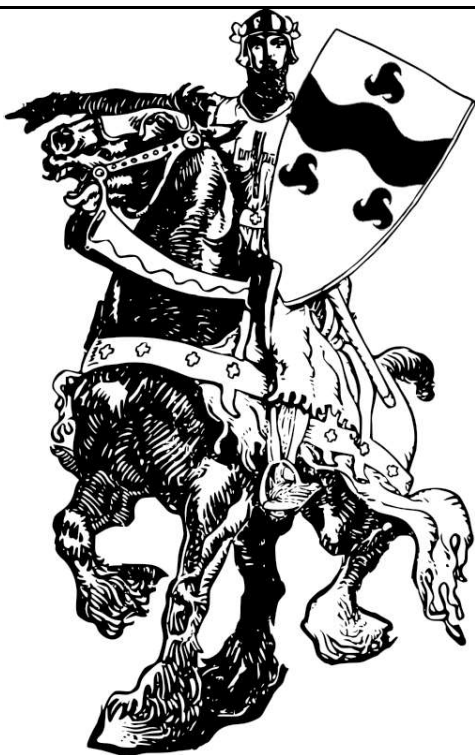

### EVENT FINANCIAL POLICIES

- All returned checks will be subject to a \$20 fee.
- Anyone who does not pay for their site registration by the time registration closes at an event will be considered to have spent the entire weekend with feast and shall be charged accordingly.
- Anyone who does not pay their event fees, or uses NSF checks to do so, will not be permitted to attend events until all fees are paid in full.
- Requests for refunds must be in writing and received (3) days in advance for a full refund. Requests made at the event will be refunded the site registration amount only. Refund requests will be accepted no later than (20) days after the close of the event.
- SCA & Kingdom policies apply to Children and Family site fees (no family more than 3 adult site fees; children 12 and under are exempt from site fee).

### EVENT ANNOUNCEMENTS SUBMISSION CHECKLIST

Event announcements need to be submitted as a standard text listing containing the required information. Announcements should be submitted as early as possible to allow for corrections and more advertising for your event. Announcements must be created following the checklist below. This checklist is intended as an aid in the proper submission of event announcements. All event announcements at which any official business will occur **must** contain the following information:

- Name event and the sponsoring group.
- Date of the event.
- Event site location including name and address.
- Time the event site opens and closes to the public.
- Registration open and closing times.
- Name (mundane and SCA) mailing address, e-mail address, and telephone number of the Reservation Steward.
- Name (mundane and SCA), e-mail address, and phone number for the Event Steward
- Site registration pricing and payment information.
- OPTIONAL: Description of the event activities.

In order to comply with Kingdom Laws and Policies, unless otherwise stated, the following standard event policies will automatically apply to all events submitted and held within the Kingdom of Trimaris.

- No family shall pay more than the equivalent of three (3) adult site fees. Family is defined as adults and their minor children. This applies to site fees only and does not include feast or cabin space.
- Unless otherwise noted, The site fees for children 12 and under are free.
- The SCA member discount for site registration shall not exceed \$5 per person.
