### Searching for a Successor A/S Warranting Officer

The Successor A/S Warranting Officer serves under the direction of the Kingdom Minister of Arts and Sciences and is responsible for the obtaining and completion of Warrants for new A/S officers, ensuring protocols are followed, and maintaining the spreadsheet that lists all such officers.

The Successor A/S Warranting Officer reports A/S Warranting 5 times a year (4 quarters and End of Year Domesday) to the Kingdom Minister of Arts and Sciences.

The Successor A/S Warranting Officer is expected to join the Facebook Officer Group (or similar resource if and when this evolves) – or select a proxy to attend in their stead – and is expected to attend all online/Zoom meetings quarterly.

The Successor A/S Warranting Officer is expected to respond to all emailed correspondence to the Group's Official Arts and Sciences email box within three business days. Queries do not need to be resolved in that time but must be acknowledged. An auto-responder defining alternate contact is acceptable on extended travel/leave.

The Successor A/S Warranting Officer is responsible for reporting receipt and passing of the Chain of Office.

# CHANGES TO KINGDOM LAW

These changes should have already been posted for review

Strike Herald Extraordinaire 12.K.4 from the list of kingdom honorifics

Add to "The Crown"

3.A.1.a)

Such an appeal will be handled as follows. A member of the Populace may appeal a sanction or unfavorable decision imposed by a warranted officer of the Kingdom. As specified in Kingdom Law Section 3.A.1 above, the Crown is the final arbiter of this appeal. Such an appeal will involve a fair hearing in the format of the Crown's choosing, where the warranted officer who made the decision presents their case, the member of the Populace presents their case, and the Crown passes a ruling on it. The Crown may request, as needed, the presence of Kingdom Seneschal and/or the Greater Officer under whose supervision operates the warranted officer who made the unfavorable decision.

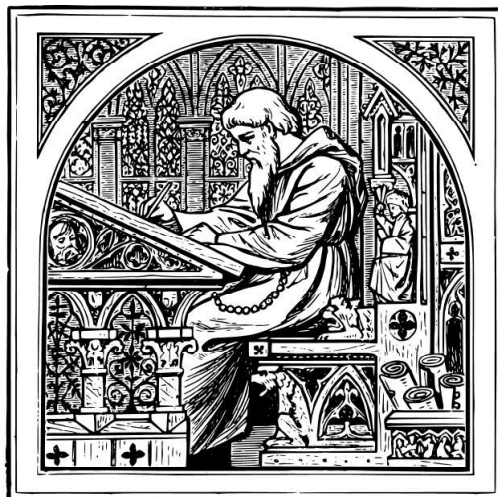
12.D 1. The Peerages of Trimaris consists of the Orders of the Chivalry, the Order of the Laurel, the Order of the Pelican, and Order of Defense, and the Order of the Mark .

14.A.5. Bestowed Peers (Chivalry, Laurels, Masters of Defense, Master Marksman, and Pelicans) may wear a circlet of precious metal with no protrusions above or below the band, with the emblem(s) of the appropriate order(s), the overall height not to exceed one (1) inch. Laurels may wear a Laurel Wreath.

14.B 4 Regalia reserved for the Order of the Mark are a set of nesting scale weights within and conjoined to a masle fleury at the upper point. The regalia of the Order will be two white vambraces or bracers.

The 60th Anniversary of the Society for Creative Anachronism is almost upon us! The SCA 60 Year Anniversary Celebration will take place in the Middle Kingdom in the State of Indiana, at the Hendricks County 4-H Fairgrounds & Conference Complex from June 29th to July 7th, 2026.

I have the pleasure of working as the coordinator of the History Hall at this celebration, and it is in that role that I am reaching out to you.

Each Kingdom will be provided a space to display their history. We are asking that each Kingdom designate a Chair or Chairs who will head your particular Kingdom's display. After my experience organizing the History Hall for the SCA 50th Anniversary Celebration, I highly recommend that each Kingdom identifies at least two volunteers to lead the project: a Chair and a Co-Chair or Deputy Chair. The Chairs will work with me and my team in coordinating their displays, including the acquisition and collection of items if needed. If a representative cannot be on site for the event, any and all items can be sent to me and volunteers will set up the display. While these are static displays, having members of the Kingdoms on-hand to answer questions and tell stories is highly encouraged.

Each Kingdom will be allotted a 20-24' (length) x 8' (Depth) space located in the Hendricks Power Exposition Hall. The Hall has air conditioning, electrical outlets, wifi, and locks to secure the hall overnight. We are asking that all displays include the following:

A banner or sign displaying the name of the Kingdom

A large Kingdom device displaying the arms of the Kingdom

Royal Lineage on a large easily readable display

Pictures or items that are a part of the Kingdom's history (example: coronets, gowns, casting molds from important items, mantles, old armor, new armor etc.)

Recommended but not required:

Any written Kingdom histories

Peerage Lineage

Displays of Kingdom traditions

Kingdom songs recorded or written for viewing and listening

Lists and depictions of Kingdom level awards

Maps of territories, baronies, shires etc.

All the things that make your Kingdom unique!!

Though the event is a year and a half away we want to ensure each Kingdom is represented in the best way possible. Display Chairs should be chosen by February 28, 2025 in order to facilitate communication and provide time to plan and gather the materials needed for this project.

I look forward to working with the Kingdom Display Chairs for all Kingdoms, and will assist in any way I can to make sure that all displays are successful. This checklist is intended as an aid in the proper submission of event announcements. All event announcements at which any official business will occur **must** contain the following information:

- Name event and the sponsoring group.
- Date of the event.
- Event site location including name and address.
- Time the event site opens and closes to the public.
- Registration open and closing times.
- Name (mundane and SCA) mailing address, e-mail address, and telephone number of the Reservation Steward.
- Name (mundane and SCA), e-mail address, and phone number for the Event Steward
- Names (mundane and SCA), e-mail address, and phone number for the Marshal in Charge and Ranger in Charge
- SCA Corporate Anti-Bullying policy
- Site registration pricing and payment information.
- OPTIONAL: Description of the event activities.

In order to comply with Kingdom Laws and Policies, unless otherwise stated, the following standard event policies will automatically apply to all events submitted and held within the Kingdom of Trimaris.

- No family shall pay more than the equivalent of three (3) adult site fees. Family is defined as adults and their minor children. This applies to site fees only and does not include feast or cabin space.
- Unless otherwise noted, The site fees for children 12 and under are free.
- The SCA member discount for site registration shall not exceed \$10 per person.
