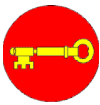

## Chancellor of the Exchequer

Greetings, Exchequers!

Things continue to be quiet at the Kingdom and Society level for exchequers, with no policy updates to report.

This month's *Northwatch* includes Kingdom financial reports for 2023. The format of these reports is very different than group reports – these are generated in Quickbooks, the software all Kingdoms use for tracking financial transactions.

The Statement of Financial Position shows fund balances as of the end of 2023. The Reserves Investments and Investments Endowment funds show artificially high balances because SCA accounting practices do not currently have a place to track changes in market value. As of the end of 2023, neither of these funds were back to their original \$100,000 balances.

The Statement of Activity shows revenues and expenditures by general categories, to give an idea of relative amounts of money moving through Kingdom accounts.

Overall, these reports show that Northshield's financial position is excellent.

The quality and quantity of submissions must be such that it is taking the Society Chronicler longer to evaluate them all. In the



meanwhile, I look forward to submitting Northshield's nominations for the AS LVIII in the coming months. At Warriors & Warlords, I plan to hold a meet & greet for the kingdom chronicler staff and local chroniclers. Anyone interested in learning more about the chronicler's and social media officer's offices, either at the local or kingdom level, is more than welcome to attend.

This month also marks the start of summer as event season kicks into high gear. During the recent pandemic, we seem to have fallen out of habit at effectively promoting our events. I want to share some suggestions for groups hosting events, and individuals seeking information on events.

#### Hosting Groups:

1. If your group has a website, use it to host information on your events. While Facebook has become the most common mass communication method we use, not everyone uses Facebook, but everyone with internet access can visit the website.
2. Share information on your events on the Northshield Hall email list and Discord, in particular to reach those who do not use Facebook.
3. Make sure updates are made to the Event Ad on the Kingdom website, the event websites, and event ads on the Northshield Facebook Page. Publicize those updates on the email lists and social media platforms.
4. If your group has a newsletter, post an event ad in it. If nothing else, it will help anyone writing a history of your group.

#### Individuals Seeking Event Information

1. The kingdom event calendar on <https://northshield.org/> is the best place to start looking for information.
2. Visit the hosting groups website.
3. The "SCA Kingdom of Northshield" Facebook page is the easiest way to find Facebook event ads, under "Events," in the "More" drop down. <https://www.facebook.com/SCANorthshield/events>.
4. When trying to find a post or comment in a Facebook page or group, the Search function (the magnifying glass icon) can greatly narrow the search through the threads.

With the start of the new SCAdian new year, are you looking for a new year's resolution? How about resolving to help Northshield by volunteering for a kingdom office.

My term as Kingdom Chronicler technically ends June 1, 2024. I will ask for an extension

for a few months to find a successor. I would like to receive letters of intent by June 1, 2024, to provide time for Stallari to review the applicants, and provide training to my successor. The office is a required office for a kingdom. It is a largely administrative position, overseeing the specialized deputies who do much of the day-to-day work of their areas. The Kingdom Chronicler is also a voting member of the Stallari Council and Kingdom Finance Committee. ## SCA CORPORATE ANNOUNCEMENTS

### COMMENTARY REQUEST – GOVERNING DOCUMENTS – MARSHALLATE CONTENT

The Board of Directors is requesting commentary on proposed changes to Governing Documents proposed by the Society Marshal. These proposed changes aim to update the Governing Documents related to the Marshallate. The authorities, roles, responsibilities, and functions of the Marshallate occur in several sections of the Governing documents, and have been added to or updated over the years. However, they do not fully reflect the breadth of current SCA martial activities and the evolution of our administrative and safety practices. These changes will (a) include all SCA martial disciplines, (b) incorporate the current and modern practices that have evolved over the years in our rules and the application thereof, and (c) ensure consistency throughout the several sections, while preserving the kingdom flexibility that enables the uniqueness of our kingdom cultures.

Updates include

- clarification of roles and responsibilities of the Society Marshal, Kingdom Earl Marshals and Deputies;
- establishes the Society handbooks to define the minimum requirements and standards for marshals, authorizations, weapons, armor, and equipment;
- clarifies authorizations and warranting of marshals

## **DIVERSITY, EQUITY, INCLUSION AND BELONGING APRIL 2024 BOARD MEETING HIGHLIGHTS**

Following a thorough review of member feedback received, we are pleased to announce overwhelming support for the creation of two new greater offices within our Society: the Society Chatelaine and the Society Diversity, Equity, Inclusion and Belonging (DEIB) Officer.

### **What Does This Mean?**

The elevation of the Society Chatelaine to a greater officer role aims to streamline recruiting and retention efforts across all levels of our organization. By centralizing responsibilities under one umbrella, we can implement consistent strategies for growth and engagement.

Similarly, the creation of the Society Office of Diversity, Equity, Inclusion, and Belonging addresses the need for a cohesive approach to DEIB initiatives. Organizing under this office will ensure that DEIB strategies are uniformly implemented across the society, fostering a more inclusive environment.

These structural changes represent one of the most significant restructurings in our history, emphasizing our commitment to building a stronger, more united community.

### **Renaming the Corporate DEIB Office**

Currently this office has many many projects on its plate. These are long-term projects like implementing an Learning Management System, creating and developing mandatory training for the society officers at various level, broad scale accessibility implementations, and more. This office should remain in ownership of these long-term big initiatives that are more administrative than game facing. Once these projects are delivered, the office can move to supporting other officers with programmatic implementations to improve inclusion.

This will take the burden of working on these types of things off of the plates of the society officers who have game facing responsibilities. To clarify, the Corporate DEIB Office will be renamed to the Office of Inclusive Programs.

## **FROM THE BOARD OF DIRECTORS, SCA INC – OMNIBUS PEERAGE DISCUSSIONS**

Currently, approximately 8000 people around the Known World actively participate in target archery, combat archery, siege weapons, thrown weapons, and equestrian martial activities. At present, there is no path to a prowess related peerage for these activities. Over the last decade, discussions have been ongoing with many people working hard to provide a range of proposals for the various members of the Board of Directors to consider. We acknowledge that the duration of this discussion is frustrating for many in the communities involved.

On January 29, 2024, the Board requested commentary on proposed language to Corpora that could be used if a new peerage were created. We received 362 emails, with the majority commenting not specifically on the language but on the wider matter of a new peerage itself.

Overall, the commentary reflected ongoing positive sentiment towards a path to peerage for the included activities and the why of it. There were significant variations in opinion on what and how of a new peerage with no overarching consensus apart from the clear consensus that something was needed. This included whether certain activities should be included as written in the draft language.

This commentary reflects the current opinions of the Board – there is a need for a path forward, but Board members have not reached a consensus on exactly what it looks like. We remain committed to finding that next step, noting that compromises will be necessary, and no solution will satisfy universally.

At the meeting, language was proposed for a ‘pre-17th century ranged martial pursuits’ peerage (currently archery – combat, target and mounted, thrown weapons and siege), removing the ‘limited to’ language, noting that work would still need to occur to establish a name for the new order and heraldry so this

was an ‘in principle’ approval type first step. There was robust discussion on whether this was the right next step to take. There were several opinions amongst us as to the right path forward. Voting was split down the centre – 3 directors in support, 3 opposed and one abstention.

More work is required by the Board, and we commit to doing it as openly and as promptly as possible.

Thank you for your feedback and advice. We know this is hard. Discussions will continue at the next conference call meeting, and we will provide an update as to the progress of those discussions.

The Directors welcomes any additional context that people feel may be of use to the discussion.

## **FOREVER IN OUR HEARTS – JOHN G. TRIMBLE**

It is with heavy hearts that SCA Inc and the Board of Directors acknowledge the passing of John G. Trimble, known to the Society as John ap Griffin.

On the nineteenth day of April, LVIII anno societatis, Baron John ap Griffin entered immortality. He passed away surrounded by family: Mistress Flavia Beatrice de Carmagniani, Lady Gaynor du Griffin and Countess Lorissa ap Griffin.

John was one of the Founders. He was instrumental in the creation of the Corporation, and served two terms on the Board. He and Flavia were the second and third members of the SCA. His experience in bulk mailings, acquired during his years in science fiction conventions, served the fledgling Society very well in those early years. John was elevated to the Order of the Pelican on September 9, AS XI. (1976), and his service continued through the very end of his life.

John served the Barony of the Angels as herald, seneschal, and baron. He was an integral part of the College of Arms from its very inception, and in fact, his arms (Vert, a griffin segreant contourny Or and for augmentation, maintaining in its forefeet a roundel azure charged with a cross of Caid and a bordure argent) were the first registered by the College. He frequently told the story of his trip to an event in AS X with his wife, and his return with two mistresses... Bjo was created a Laurel and a Pelican on the same day.

John was also a leading light in the early days of science fiction and fantasy fandom. He and Bjo created and ran the World Science Fiction Art Show for WorldCon, he MC'd countless costume contests and panels and ceremonies.

Husband, father, peer, baron, MC extraordinaire, herald, mentor, friend. John was sui generis; one of a kind. He will live on in the hearts of all those who knew and loved him.

### COMMENTARY REQUEST – CORPORA ADDITION – ROYALTY SELECTION (REFUSALS)

The Board of Directors is seeking feedback on the proposed addition to Corpora: Section IV.A, Royalty-Selection. A previous version was put out for comment in 2023. The majority of commentary received was favorable to the concept but not necessarily to the specific language. This rewritten proposal attempts to address those concerns. Additionally, principalities have been added to be in line with other rights, privileges, and restrictions of Principality royalty.

It is clearly stated in the Rules of the List in Corpora that all combatants must be acceptable to the Crown. This is an authority

that has great importance in Royal Lists. It is also important to note that the Crown should not, whether intentionally or otherwise, attempt to influence the outcome a Royal List by using that authority. On multiple occasions a Crown has barred or attempted to bar a swath of people from competing in the Royal Lists based on factors such as geographical location, household affiliation, membership in a particular order, or simply rejecting well over half the letters of intent, giving the distinct impression that this action would control the outcome of the tourney. In 2022, the Society Seneschal issued a Corpora interpretation barring this practice which was upheld by the Board. This proposed language would add and define this restriction to Corpora directly, and also to require the Crown to state a reason to an individual to whom they have refused entry if the individual requests it.

#### Proposed language:

#### IV. ROYALTY

4. *The Crown may refuse entry into the Royal Lists as either combatant or consort, on an individual basis only, for cause stated only to the person denied entry. Entry into the Royal Lists may not be denied to identifiable groups of people, or to a large enough number of entrants that it materially affects the size of the list.*

5. *The Coronet of a Principality may deny entry as stated above, only with the approval of the Crown.*

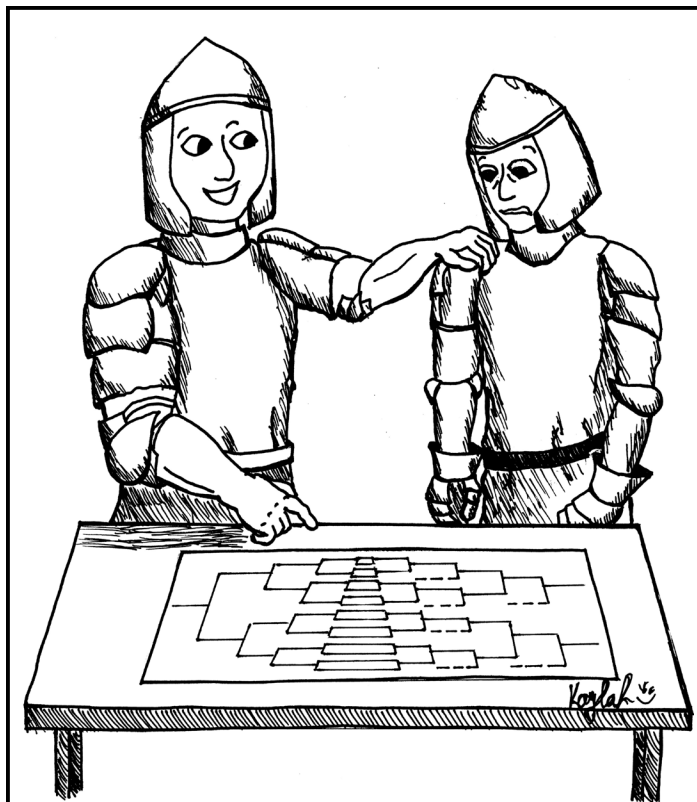
