Motion by Krista Capps to open the Emergency Meeting of the Board of Directors for the Society for Creative Anachronism and to move directly to Executive Session. Second by Joan Steurer. Opposed: None. Motion carried.

Motion by Joan Steurer to open Executive Session for the Emergency Meeting. Second by Krista Capps. Opposed: None. Motion carried.

Executive Session was opened at 7:05 p.m. CDT.

II. EXECUTIVE SESSION

A. Crown of Aethelmearc / Directive by the Board of Directors

Chair Mark Faulcon noted that he is a possible witness and recused himself from discussion of or voting on this issue . The gavel was passed to Vice-Chair K.T. Sheppard, after which Chair Faulcon left the room.

Director Megan O'Shea additionally recused herself from discussion of or voting on this issue .

Motion by Krista Capps to immediately end and declare incomplete the reign of Timothy and Gabrielle, Crown of the Kingdom of Aethelmearc. Second by Jonathan Foster. In favor: Krista Capps, Jonathan Foster, Joan Steurer. Opposed: None. Recused: Megan O'Shea. Recused and Absent: Mark Faulcon. Abstained: Kate Poore. Acting Chair K.T. Sheppard exercised his option to vote and did so in favor of the motion. Motion carried.

Motion by Krista Capps to prohibit Timothy Taylor (Timothy of Arindale) from participation in any Royal List, in any manner whatsoever, for a period of two (2) years, effective immediately and concluding on April 22, 2027. Second by Kate Poore. In favor: Krista Capps, Jonathan Foster, Kate Poore, Joan Steurer. Opposed: None. Recused: Megan O'Shea. Recused and Absent: Mark Faulcon. Acting Chair K.T. Sheppard exercised his option to vote and did so in favor of the motion. Motion carried.

Motion by Kate Poore to prohibit Gabrielle Taylor (Gabrielle van Nijenrode) from participation in any Royal List, in any manner whatsoever, for a period of two (2) years, effective immediately and concluding on April 22, 2027. Second by Krista Capps. In favor: Krista Capps, Jonathan Foster, Kate Poore, Joan Steurer. Opposed: None. Recused: Megan O'Shea. Recused and Absent: Mark Faulcon. Acting Chair K.T. Sheppard exercised his option to vote and did so in favor of the motion. Motion carried.

Chair Marc Faulcon returned to the room and the gavel was returned to Chair Faulcon by Vice-Chair Sheppard.

Motion by Joan Steurer to concurrently adjourn Executive Session and the Emergency Meeting. Second by Kate Poore. Opposed: None. Motion carried.
