- **Location and directions**• Name and directions to the legal address of the site.
- **Event Steward**• Event Steward's Society name, a contact phone number with area code, and email address. **Mundane name and address are no longer required.**
- **Registration**• Member & non-Member for event, with deadlines (for pre-registration) as necessary. If there is a Registration for the event, the following statement must be included beneath the \$ amounts: "Make checks payable to SCA, Inc./(group name)." If the event is free, say so!
- **Activities**• Brief synopsis of event—fighting, arts & sciences, merchants, et cetera.
- **Site Restrictions**—wet or dry, no animals, no smoking, et cetera,
- **Accessibility**—handicap parking & entrance/exit ramps, uneven terrain, et cetera
- **Duration**• Start and stop time of the event.

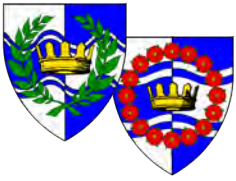

**Directions:** On Saturday, June 14 for the in-person event: From I-95, take US-58 E to Suffolk, then take the US-13 N ramp to I-264 E/I-64/ Portsmouth/Norfolk/VA Beach. Take exit 15B for I-64 toward Chesapeake/VA Beach. Continue onto I-64 W for 13 miles, then take exit 286A for Indian River Rd West. Merge onto Indian River Rd and continue until you reach US-13 S/N Military Hwy. Use the 2nd from the right lane to turn right onto US-13 S/N Military Hwy, then make a left at Drift Tide Drive and an immediate left onto the frontage road that leads to CVUU.

From Richmond/Williamsburg, follow I-64 E to US-13 S/N Military Hwy in Norfolk. Use the 2nd from the right lane to take exit 284A for I-264 W toward Norfolk. Keep right to continue on Exit 13A, follow signs for US-13 S/Military Hwy and merge onto US-13 S/N Military Hwy.

Continue on US-13 S/N Military Hwy for 1.7 miles, then turn right at Drift Tide Drive and make an immediate left onto the frontage road that leads to CVUU.

Phoebe Needles is 0.8 miles on the right. St. Peter's Church can be seen up the hill on the left.

From Rocky Mount, Virginia: From North or South Route 220 at Rocky Mount, exit at Route 220 Business, Main Street, and follow into town 1.8 miles. Turn right at the traffic light onto Route 40 West, Franklin Street, and follow through town 2.4 miles. Turn right at 40 West Food Fare onto Route 640, Six Mile Post Road. #### **MOL Assistant Experiment Proposal Draft**

### **Introduction**

This proposal outlines the MOL Assistant Experiment, an initiative from the Office of the Ministers of the List. The experiment aims to build capacity within the MOL volunteer community by involving non-warranted volunteers in various activities under supervision.

#### **Focus**

The primary focus of the MOL Assistant Experiment is to build capacity within the MOL volunteer community by allowing non-warranted volunteers to assist in various tasks at the MOL table, thereby gaining experience and contributing to the community.

### **Implementation**

The implementation of the MOL Assistant Experiment will begin at the Stierbach Baronial Birthday event. Non-warranted volunteers will be allowed to volunteer at the MOL table to help with the following tasks:

- Signing in fighters
- Checking fighter cards
- Filling out authorization paperwork (but not signing it)
- Assisting in running tournaments

## *MOL Assistant Experiment Proposal Draft*

### **Supervision**

All MOL activities performed by non-warranted volunteers will be under the supervision of a warranted MOL in charge of the respective discipline's MOL table. This supervision ensures that all tasks are performed correctly and maintains the integrity of the MOL processes.

### **Rationale Statement for MOL Assistant Experiment Proposal**

The Office of the Ministers of the List (MOL) is facing increasing challenges in recruiting volunteers. Despite having many MOLs on the list, very few are willing to volunteer for MOL jobs. This reluctance is largely due to the lack of other volunteers to support them, creating a cycle where the shortage of volunteers discourages further participation.

Additionally, there seems to be an attitude of gatekeeping from some MOLs, which turns away potential volunteers. The current requirements to become involved with MOL, including taking two classes, passing a test, and completing two training events, create a barrier to entry. The existing system can make it difficult for new volunteers to 'get in' the door and try helping at MOL.

The MOL Assistant Experiment aims to address these issues by lowering the barrier to entry and making it easier for non-warranted volunteers to assist at MOL tables. By allowing volunteers to help sign in fighters, check fighter cards, fill out authorization paperwork (but not sign it), and assist in running tournaments under the supervision of a warranted MOL, we hope to build capacity within the MOL volunteer community. Implementation of this experiment will begin at Stierbach Baronial Birthday, where non-warranted volunteers will be allowed to volunteer at the MOL table. This initiative will provide a more accessible entry point for new volunteers, fostering a supportive environment, and encouraging greater participation in MOL activities. We are considering other events where this experiment can be explored. After each event we will assess the level of engagement, and determine where changes in the process need to be made.

### **Conclusion**

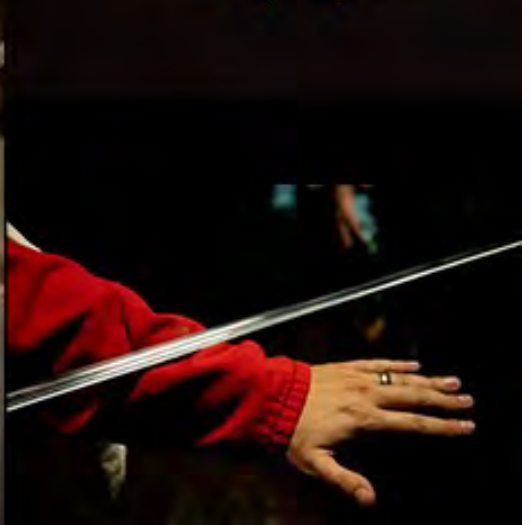

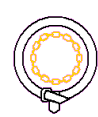
