



Updates to Kingdom Law A.S. LX

The following are changes made to An Tir Law Effective June 2025

- Update dates/footer for AS 60 June 2025
- Change date of laws being signed on signature page

Article I.A The Word of the Crown

Will be changed from

The word of the Crown is law TO the written word of the Crown is law

I.B Changes to Kingdom Law

Will be changed from

All changes to these laws must be proclaimed at a legal <u>official</u> Society event with complete copy published in The Crier

TO All changes to these laws must be proclaimed at <u>an official</u> Society event with complete copy published in The Crier

I.C Principality Law

Will be changed from

Within any Principality of the Kingdom of An Tir, the word of the Coronet is Law subject to the same restrictions as Kingdom Law

TO the <u>written</u> word of the Coronet is Law subject to the same restrictions as Kingdom Law

And from

Any changes to the Laws of a Principality must first be submitted and signed by the Crown of An Tir and the Kingdom Seneschal. They must then be proclaimed at a legal Society event and published in The Crier to Any changes

TO They must then be proclaimed at <u>an official</u> Society event and published in The Crier

Article III.C Kingdom Greater Officers of State

Item 3) A

Will be changed from

Report to the Crown and heirs one month prior to Curia, at each Curia and upon request. A copy of reports should be sent to the Kingdom Seneschal.

TO Report to the Crown and heirs, at each Curia and upon request. A copy of reports should be sent to the Kingdom Seneschal.

Will be changed from

A maximum of two one-year term extensions may be granted at the discretion of the Crown.

Members of the Orders of the Chivalry, Laurel, Pelican, and Masters of Defense.

ARTICLE IV.C Awards and Orders of An Tir

Item 2. a)

Will be changed from

The Principality Coronets, with the written permission of the Crown, may bestow Awards of Arms on behalf of the Crown, to subjects of Their Principality.

TO The Principality Coronets may bestow the following awards, on behalf of the Crown, to subjects of Their Principality. Award of Arms, Sanguine Thorn, Griffe et du Lion, L'Esperon et du Lion and Sable Pheon.

REMOVAL of Item b: The Principality Coronets shall request permission from the Crown at the commencement of the Crown's reign.

Item c)

Will be changed from

The names of the Crown shall be incorporated into the text of the scroll or charter given by the Principality Coronets.

TO The names of the <u>Coronets</u> shall be incorporated into the text of the scroll or charter given.

Article IV.C Awards and Orders of An Tir

Item 4

ADDITION: I) Membership in the Order of the Mark may be offered to individuals who meet the general criteria for peerage and who have displayed skill at target Archery, Combat Archery, Missile Combat, Thrown Weapons, or Siege Weapons at least equal to the level commonly found among existing members of the order.

Item 7

ADDITION:

45): Golden Owl: Given by the Crown for longevity and dedication in teaching (over 15 years) and passing historical knowledge on to the younger generation

46): Golden Lotus: Given by the Crown to those being an inviting, safe and openminded community member, who has gone above and beyond to assist unrepresented populations and newcomers in the Society.

Article V.B Crown and Kingdom Events

Item 4

REMOVAL: c) Fall and Spring Crown Councils, at the Crown's discretion 5) b)

Will be changed from Kingdom Arts & Sciences and Rapier Championship - the first weekend of March TO the <u>third</u> weekend of <u>April</u>

Item 5 c) Spring Crown Council – as proclaimed by the Crown and h) Fall Crown Council – as proclaimed by the Crown

Item 6)

Will be changed from:

The Kingdom Seneschal, the Crown and the Kingdom Events Deputy shall determine the location of the Crown and Kingdom events through bids from subordinate branches

TO The Kingdom Seneschal, the Crown and the Kingdom <u>Exchequer</u>
Item 6a)

Will be changed from:

Actual dates shall be published by or as soon after Twelfth Night as possible for the upcoming year.

TO <u>Successful bids for Crown and Kingdom events shall be published as soon as possible for the upcoming year once awarded.</u>

Article V.B Crown and Kingdom Events

Item 8 a)

Will be changed from:

All final reports and receipts for Crown or Kingdom events must be sent to the Kingdom Exchequer and Kingdom Event Deputy within sixty (60) days of the close of the event.

TO must be sent to the Kingdom Exchequer, <u>Kingdom Seneschal</u> and Kingdom Event Deputy Item 8 b)

Will be changed from:

If all final reports, receipts and sixty percent of any profit made on a Crown or Kingdom event have been sent to the Kingdom Exchequer within thirty (30) days of the event, the remaining forty percent may be kept by the host group.

TO have been sent to the <u>Kingdom Exchequer</u>, <u>Kingdom Seneschal and Kingdom Event Deputy</u> within thirty (30) days of the event, the remaining forty percent may be kept by the host group.

Article VI.E Kingdom Committees, Guild or Companies and Other Entities

Item 1 b) (1)

Will be changed from:

The Noble Estate may meet at Crown events and at Crown Council. The Crown may elect to hold Noble Estate meetings online instead of in-person.

TO The Noble Estate may meet at Crown events. The Crown may elect to hold Noble Estate meetings online instead of in-person.

Item 2) c) (4)

Will be changed from:

Meet a minimum of 4 times per year. These meetings may take place at each of the 4 (four) Crown events or by holding an online or telephone conference within 2 weeks before or following each Crown event

TO by holding an online or telephone conference <u>scheduled within a reasonable</u> <u>time before or after such an event.</u>

REMOVAL: Item 2) c) (5): Additional meetings can be called for at the Spring or Fall Crown Council if needed

Item 3 b) 1

Will be changed from Ladies of the Rose and Valorous Estate TO Companions of the Rose and Valorous Estate on these matters.

Article VIII.A Conduct of Persons in An Tir:

Item 1.d)

Will be changed from:

Violation of these laws will result in the appropriate consequences, and may be grounds for expulsion from an event, banishment, dismissal from office or other sanctions.

TO expulsion from an event, dismissal from office or other possible sanctions.

Item 2)

Will be changed from:

The violation of modern law will be grounds for expulsion from an event, banishment, or arrest by civil authorities.

TO expulsion from an event, possible sanction, or arrest by civil authorities.

Item 3)

Will be changed from

The allowance for admission and control of pets shall be determined by the event steward. If no other determination is made, all animals shall be leashed or otherwise physically secured at all times. All pet owners are responsible for the cleanup and removal of their pet's waste.

TO ADD <u>The Service Animal Policy can be found in the Kingdom Seneschal</u> Handbook and should be reviewed by event stewards.

Item 7) D

REMOVAL: For example, if there are 10 youth A7S classes each in their own separate classroom, each classroom needs to follow the "two deep rule", but only one overall youth "coordinator" responsible for all activity in all classrooms is needed.


