D. Omnibus Peerage Proposal

Motion by Jennifer Krochmal to approve the proposed revisions to Corpora for the creation of a new peerage focused on pre-17th Century ranged weapons, and to direct Officers to work with Laurel Sovereign of Arms to create and submit appropriate name and arms for such a peerage, with an implementation date to be determined after a vote contingent upon a future vote of the Board to amend Corpora. E. Corpora Changes - Removing Language Referring to Courts of Chivalry

The proposed language for commentary is pending publication due to the large number of changes approved for commentary at the January meeting. By consensus the Board took note of the Society Seneschal's update.

F. Corpora Changes - Updated Newsletter Access Language

By consensus, Chairman Mark Faulcon noted that commentary is still being accepted until May 30, 2024 and remanded the matter until the May 2024 conference call.

G. Proposed Addition to Corpora, Section IV.A, Royalty-Selection

b. Variance: I have extended a variance of the policy above (B.1) for the East Kingdom for 6 months (Until 11/30/24) while we investigate their system. They have an automated system which reportedly meets the intent of this policy while not exactly matching the wording above. I am meeting with them to get a feel of their system to evaluate it and the policy interpretation in B.1.

E. Laurel Principal Queen of Arms – Unni Leino (Birgitta Lulli)

The report of Unni Leino, Laurel Principal Queen of Arms, was summarized and accepted as submitted. The report contained the following action items:

- 1. Requested Board Actions: Please approve the following updates to the Administrative Handbook:
 - a. Approve update to the Administrative Handbook to limit the number of submissions to 50 per month per kingdom. Submissions heralds in different kingdoms have been operating under different views of how long a LoI may be; and while most agree that there is a maximum number of items, this isn't written down anywhere accessible. The update corrects this situation.

Motion by Pug Bainter to approve update to the Administrative Handbook to limit the number of submissions to 50 per month per kingdom as requested by the Laurel Principal Queen of Arms. Second by K.T. Sheppard. Opposed: None. Motion carried.

b. Approve update to the Administrative Handbook to allow branches to retain their old names as Ancient Branch Names, as discussed in the January 2024 report, and at the same time clarify that neither Ancient Arms nor Ancient Branch Names can be returned to the status of active Branch Name or Branch Arms.

Motion by Pug Bainter to approve update to the Administrative Handbook to allow branches to retain their old names as Ancient Branch Names as requested by the Laurel Principal Queen of Arms. Second by Megan O'Shea. Opposed: None. Motion carried.

- 2. Requested Board Actions: Amend a policy ruling made by the Board of Directors on September 25, 1983 stating that the names and arms of defunct Society branches may not be reused, and approve update to the Administrative Handbook:
 - a. to clarify that with respect to items registered by the College of Arms, a change of status from full Society branch to Hamlet is treated like other changes in branch status even though one step of the administrative process is formal disbandment;
 - b. to allow a kingdom to transfer the name and arms of a defunct branch to a new branch established in the same location as Ancient Branch Name and Ancient Arms, to give the branch itself power to decide whether to keep or to forget this part of their history.

Motion by Pug Bainter to clarify that with respect to items registered by the College of Arms, a change of status from full Society branch to Hamlet is treated like other changes in branch status even though one step of the administrative process is formal disbandment and to allow a kingdom to transfer the name and arms of a defunct branch to a new branch established in the same location as Ancient Branch Name and Ancient Arms, as requested by the Laurel Principal Queen of Arms. Second by Krista Capps. Opposed: None. Motion carried.

- 3. Please approve the following changes to SENA (Standards for Evaluation of Names and Armory):
 - a. Deleted A2B4a to remove the step from core practice for plants and animals in some situations and revised A2B2 to generally allow plants and animals that existed in the same time and place as period humans to be registered without a step from core practice.
 - b. Revised A6C to allow quartered augmentations to be in the second and third quarters as well as the first and fourth quarters as A3A3c allows.
 - c. Revised PN1B2c "*Lingua Societatis* Allowance" to make it clear that occupational bynames may use this allowance, which matches existing precedent.
 - d. Revised the Japanese names portion of Appendix A "Patterns That Do Not Need Further Documentation by Language Group" to reflect current academic understanding of period Japanese onomastics.
 - e. Updated Appendix E5 "Heraldic Tinctures and Ordinary Color Words Registerable in Non-Personal Names" to allow the use of "grey" (in various languages).
 - f. Updated Appendix L1 "A Partial List of Postures and Orientations" to include additional postures for sea creatures and other creatures whose default posture is erect.
 - g. Updated Appendix M "Some Resources for Conflict Checking" with information on leaves and pelicans.

Motion by Pug Bainter to approve Laurel Queen of Arms' revisions to the following SENA Sections: A2B4a and A2B2 with regard to plants and animals, A6C with regard to quartered augmentations, PN1B2c "Lingua Societatis Allowance", Appendix A with regard to Japanese names, Appendix E5 "Heraldic Tinctures and Ordinary Color Words Registerable in Non-Personal Names", Appendix L1 "A Partial List of Postures and Orientations", and Appendix M "Some Resources for Conflict Checking".

Second by Krista Capps. Opposed: None. Motion carried.

- 4. Approve the following changes to the Glossary of Terms.
 - a. Table 2 "Reserved Charges" has been updated to clarify when a pelican is reserved for members of the Order of the Pelican.
 - b. Updated Table 4 "Conventional 'Proper' Colorings" and Table 5 "Conventional S.C.A. Default Postures" to include yet more definitions for various charges such as paws, sliding door bolts, and Thor's hammers, and to retire the problematic term *Caucasian* from being used to describe human skin color.

Motion by Pug Bainter to approve changes to the Glossary of Terms Table 2 "Reserved Charges and Table 4 "Conventional 'Proper' Colorings" as requested by Laurel Queen of Arms. Second by: K.T. Sheppard. Opposed: None. Motion carried.
