### BOARD ANNOUNCEMENTS ~ OMNIBUS PROPOSAL

Currently approximately 8000 people around the Knowne World actively participate in target archery, combat archery, siege weapons, thrown weapons and equestrian martial activities. While no ultimate decision has yet been made the Board believes that a proposal of a path to peerage for these individuals is worthy of deep consideration.

Having received advice from the Peerage Committee, Directors have discussed the matter and following some minor amendments to language which align the proposed draft of Corpora wording to the existing patent orders, the Board feels that the proposal has matured to the point where commentary on the proposed Corpora wording from members is requested. This commentary will assist the Board in forming further decisions relevant to its consideration of this matter.

The draft Corpora language approved for commentary is:

#### VIII.A.4:

- e. The Order of <Name>
- (i) Members of the Order of <Name> may choose to swear fealty but are not required to do so. The candidate must have attained the standard of excellence in skill and/or knowledge equal to that of their prospective peers in a pre-17th century martial pursuit as practiced in the SCA, including, and limited to, target archery, combat archery, thrown weapons, equestrian activities, and siege engineers. The candidate must have applied this skill and/or knowledge for the instruction of members and service to the kingdom to an extent above and beyond that normally expected of members of the Society.
- (ii) The duties of the members of the order are as follows:
- (a) To set an example of courtesy and chivalrous conduct on and off the field of honor.
- (b) To respect the Crown of the kingdom; to support and uphold the laws of the kingdom and Corpora.
- (c) If in fealty, to support and uphold the Crown of their kingdom.
- (d) To enrich the kingdom by sharing their knowledge and skills.

- (e) To enhance the renown and defend the honor of the peer's Lady or Lord.
- (f) To advise the Crown on the advancement of candidates for the Order of <Name>.

(other sections re-numbered as needed)
Knowing exactly what the people who work, study, and play in the Society want a potential new peerage to achieve and do will be key to moving forward in this discussion. The Board welcomes any additional context that people feel may be of use to the discussion.

Does this language fill the gap I personally feel exists in the paths to peerage, why or why not?

## ANNOUNCEMENT OF MEMBERSHIP PRICE INCREASE

The Society for Creative Anachronism, Inc. (SCA, Inc.) is announcing an increase in membership fees and non-member registration fees for events.

This decision comes after careful consideration and extensive discussion among the Board of Directors, office staff, and Corporate officers. The effects of inflation across all sectors of operation, as well as other factors impacting the organization's operational costs, including insurance premiums, legal expenses, and general business expenses, necessitated a comprehensive review of membership rates. Annual membership fees have not been adjusted in over a dozen years, and non-member registration fees have not increased in over 15

In response to the evolving financial environment, the organization streamlined operations during the 2020 COVID-19 pandemic and significantly reduced corporate expenditures. The relocation of the office to San Jose, CA resulted in an annual savings of over \$35,000, and upgrades to software and CRM systems have netted a further savings of over \$100,000 annually. While membership numbers have rebounded post-pandemic, operational costs continue to rise.

SCA, Inc. Corporate is solely funded by membership fees, including the Non-Member Registration fee, and does not currently seek operational funds from its Kingdoms or subsidiary organizations, including those overseeing Pennsic and Gulf Wars.

At the January 2024 meeting of the Board of Directors, the Board approved the following changes, effective February 15, 2024: Raise the Sustaining membership price from \$45 a year to \$55 a year (This represents an \$0.83 cents per-month increase over the previous monthly rate.)

Raise the Associate membership price from \$30 to \$40 a year. (This represents an \$0.83 cents per-month increase over the previous monthly rate.)

Raise the Family membership price from \$10 a year to \$15 a year, per person. (This represents an \$0.42 cents per-month increase over the previous monthly rate.)

No changes to Canadian or International memberships have been announced at this

Note: this change will take effect for all renewal transactions processed on or after February 15, 2024. Renewal transactions prior to that date will be processed at the previous rate,

regardless of membership expiration date. The Board also approved the following changes to Non-Member Registration fees, effective April 1, 2024:

Raise the Non-Member Registration Fee from \$5 to \$10 per event. As always, this only applies whenever there is an actual event fee charged.

Both Sustaining and International Membership allow subscriptions to printed publications, as well as the ability to add Family memberships. It should be noted that these increases remain less than the cumulative U.S. inflation increase of 36.5% which has occurred since 2011. (Data calculated using the US Inflation Calculator).

SCA, Inc. emphasizes its commitment to transparency and sustaining a vibrant community. These fee adjustments aim to ensure the organization's fiscal health, support ambitious initiatives in 2024 and beyond, and keep the Knowne World thriving and dreaming for years to come.

### APPLICATIONS OPEN – PRESIDENT, SCA INC.

As the Society enters 2024, a new chapter will shortly commence. The Board is seeking a visionary leader – with a heart for community service – to join SCA Inc. and serve as President. SCA Inc. is focused on creating a sustainable, stronger, connected Society and Directors believe that the right President will be pivotal in helping achieve this vision through driving the delivery of the Board's strategic goals. The Board of Directors of the Society for Creative Anachronism, Inc. is currently accepting applications for the position of President of the SCA, Inc. This is a salaried position requiring 30-40 hours per week. The office hours are flexible, as availability for evening calls may be required.

Position Requirements and Responsibilities: The President is the principal spokesperson for the SCA, Inc. This officer is the principal liaison between the SCA, Inc. and outside authorities. Specifically, they are responsible for communications between outside professionals such as attorneys, accountants, insurance representatives, for law enforcement, government agencies, other organizations, and claimants against the SCA, Inc. Approves official interactions with outside media sources when required.

Provides inspirational leadership and direction to all executives and ensures the continued development and management of a professional and efficient organization; establish effective decision-making processes that will enable the SCA, Inc. to achieve its long- and short-term goals and objectives.

Serves as the point of contact for all legal and law enforcement inquiries and communications. Responsible for coordinating with SCA legal, IT, and other SCA offices to provide documentation required for legal actions. May be required to provide depositions and affidavits. Works with the Vice President of Corporate Operations to coordinate much of the day-today modern operation of the Corporation. Services as the immediate point of contact for all Society and Corporate officers. The President currently supervises the Corporate DEIB, Communications, Marketing officers, and the President's Special Project Deputy Officer. Works with the Executive Assistant to maintain rosters of Officer Warrants and timely post job openings when needed. Responsible for ensuring all interviews for Society and Corporate positions are scheduled properly after consultation with the Board and pertinent officers.

Works closely with the Society Seneschal and usually participates in the Society Seneschal meetings with the Kingdom Seneschals. Is the primary point of contact for Kingdom Seneschals on all modern legal issues. Assists in handling special matters when the Society Seneschal cannot due to a conflict.

Executes contracts necessary to properly conduct the SCA's business and may delegate similar responsibilities. Monitors, stores, and negotiates Affiliate Agreements with Board oversight.

In conjunction with the Corporate Treasurer ensures that the flow of funds allows the SCA Inc. to make continuous progress towards the achievement of its mission and that those funds are allocated properly to reflect present needs and future potential.

Cultivates a strong and transparent working relationship with the Board and ensures open

communication about the measurement of financial, programmatic, and impact performance against stated milestones and goals. Advises the Board of Directors on areas of corporate governance and policy issues. Currently the President reviews and approves site contracts in accordance with SCA corporate policy. Additionally monitors and audits procedures and departments at large events as needed (Gulf Wars, Pennsic, etc.). Responsible along with the Vice President of Corporate Operations for interviewing and hiring office staff as needed with approval from the Board.

Responsible for drafting and submitting four Quarterly Reports to the Board, four Post-Board Meeting Reports to the membership, and ensuring the creation and publication of a public year-end report.

The President may be assigned other duties by the Board.

General Requirements:

The President must be available for the four quarterly Board meetings, typically held over a Friday and Saturday or a Saturday and Sunday. These meetings may be held via videoconference or in person. In-person meetings require travel, typically on a Thursday and Sunday. In addition, the President must be available for conference call meetings of the Board four to twelve times a year, typically on weekday evenings, and meetings or calls with officers or directors on an as-needed basis.

The President must have the ability to travel when required by the Board or for legal matters.

Management experience working with both volunteers and employees required. Prior nonprofit experience ideal; management of a global or multisite organization preferred Excellent written and oral communication skills, the ability to work independently to prioritize tasks and meet deadlines. Experience in a modern business setting, organizational ability and problem-solving skills are a must. Experience in a modern non-profit organization and prior experience at the Corporate or Society level of the SCA are desirable, but not required.

As a great deal of the Board's business occurs via the Internet, familiarity and basic skills with a computer, MS Office software (specifically Microsoft Word and Excel), and e-mail are required. SCA Inc. is seeking applications for the position of Deputy Society Seneschal for Investigations. This is a part-time stipend position expected to require approximately 15 hours a week on average. This position reports to the Society Seneschal/VP for Operations and is a warranted deputy working under that officer. Responsibilities:

Assist in recruiting volunteer investigators Train and oversee investigators, including producing training materials in conjunction with the Society Seneschal

Maintain a record of volunteer investigators and their assignments

Assign investigations in consultation with the Society Seneschal

Maintain regular contact with volunteer investigators and get regular updates on investigations in progress

Communicate with relevant kingdom officers, complainants, subjects of investigations, and major identified witnesses to inform them of the assignment of an investigation and introduce the volunteer investigator

Maintain investigation files and send information to assigned volunteer investigators as required

Provide advice, guidance, and instructions to volunteer investigators as needed

Assemble finished investigation reports and files into documents for Society Seneschal and Board review

Summarize investigation files and recommend Board actions as appropriate

Make recommendations and assist Society Seneschal with revisions to investigation procedures, the SCA Sanctions Policies and Procedures Manual, and other relevant documents as needed

Serve as a consultation resource for kingdom seneschals regarding kingdom investigations and sanctions

Qualifications:

Excellent written and oral communication skills

Familiarity with SCA governing documents, policies regarding investigations and sanctions, and relevant handbooks and procedures manuals

Prior experience in leadership positions within the SCA or in leading volunteer organizations Ability to maintain confidentiality of investigations and the related materials

Previous experience in investigative processes within the SCA or in similar modern professions such as Human Resources, Law Enforcement, Legal, etc.

Ability to organize and evaluate large amounts of information

Ability to maintain a neutral perspective while evaluating statements and evidence Ability to pass Background Check

This position will require the ability to communicate with volunteer investigators via email, phone, or videoconference, prepare detailed reports for the Board of Directors, and communicate with participants in the SCA community without regard to rank or position. Attendance via videoconference at portions of SCA Inc. Board meetings may be required. These meetings may be held on evenings or weekends, several times per year. A computer, phone, and access to internet is required. Proficiency with Microsoft Office and Adobe Pro is a plus. #### From did you become a scribe?

A dear friend was retiring from the SCA and I found myself gifted with her scribal supplies,

much to my surprise and delight.

# What do you enjoy most about being a scribe?

First and foremost, I love being able to provide joy to others by acknowledging them with awards. Second to that, I enjoy the entire process of creating both charters and originals. From the first blank stare wondering what I'm going to do, then watching the paper come to life with creation. It's an amazing process that

thrills me every single time.

# have you ever held an office position as a Scribe?

I have been Coronet Scribe four times... back to back once. It was an amazing experience and I am so honored to have been trusted to pull it off. All Reigns were super to work for and made it very easy to be a positive experience. The heavy work happens almost immediately after Coronet, preparing, cajoling others, getting designs, words, and printing accomplished in time to have charters ready for Investiture. Then it's a matter of good communication with the Reign to ensure they have everything they need (plus extras J) for each upcoming event. Spreadsheets are your friend.... thank you Alessandra:)

I am also Principality Scribe at the moment, which is ensuring the Scribal Arts are happening throughout the Principality of Tir Righ, reports, and assistance along with encouragement to any and all who need it.

I am, as well Kingdom Sable Preceptor, which is the person 'in charge' of scribal education & contests for An Tir. This job has enabled the 48 Hour An Tir Backlog Competition to be successful.

#### What is your scribal pet peeve?

Poor printing and unsigned work. People like to thank the scribe, and like to know who did the work for them. Sign your work Scribes... but not in ink or directly behind the text or art!

Was there anyone that helped you along your scribal journey that you would like to acknowledge? If so, how did they influence you on this journey?

There's many who I bugged the heck out of when I first started out, it's hard to name them all. A thing that stands out however, any time I did a collaboration with Duchess Helene, her 'payment' was to send me something new to try... real gold leaf, new pigments she had ground... the payment was to always try something new. I love and really appreciate that.

Do you have any special tips,

# tricks, or techniques that you use or have learned through your scribal journey?

We learn something new each piece we do. I would tell everyone that there's no such thing as a mistake; as in period, corrections were a plenty. A blotch becomes a bug, a drip becomes a flower, a forgotten letter is inserted in the margin with a long finger pointing to its home.

A tip I would advise is always test your paint on a piece of whatever surface you are using. Your blue may be lovely on that nice parchment but look totally different on the heavy watercolor paper you are planning on using.

have you ever done an original award? If so, what did you learn though the process? Do you have any advice you would pass on to someone new to original work?

Yes I have. I'm still surprised by that. I've done quite a few at this point. Why? One does not say no to Hlutwige. The advice I would give is just DO ITI Don't be afraid of spreading your wings. It's not as scary as it seems, and if you do enough researching you will find there are so so many inspirations out there... and never be shy approaching another scribe about questions you might have.

What is your favorite Kingdom Award that you have painted, calligraphed, or designed?

Why is that your favorite?

I honestly love them all. There isn't one that is more or less important than another. Each one brings undeniable joy to the recipient and I like to make each one as unique as I can.

What is the best or most impactful piece of advice you have ever received through your scribal journey?

If doing a design for a charter, put your inspiration on the back, allowing the scribe to look

up the original, and potentially allowing for help in painting the award.

Is there anything that you would say to your younger scribal self just starting out on this path?

Don't be such a scaredy cat! Try the things, buy the good stuff, do the research! Find your joy!!

Is there anything else that you would like to say or add as an An Tir Spotlight Scribe?

Don't be afraid to collaborate. Scribing can be a solitary thing, adding someone else to the project adds an entirely new dimension to your project. Also, you are the only one who sees any imperfection in your work. The person receiving your gift is overjoyed and only sees the care and love you've put into the work. If you are feeling down on yourself (don't worry, it happens to all of us) reach out to another scribe or friend, let others lift you back up where you belong <3

ome extant cookbooks, especially those in English, and from the later period of our interests, do not need much, if any, modern recipe redactions in order to cook from them. Often the ingredients even have weights and measures associated with them. They are not as clear as modern recipes, but much easier to cook from than those of the medieval past. "The Good Housewife's Jewel" by Thomas Dawson with an introduction by Maggie Black, Southover Press, 1996 is one such book. Thomas Dawson's book was compiled "in 1596 and 1597 when English Society stood on the threshold of a new era." The emergence of a middle and upper-middle class spurred on the publishing of many different manuals, including cookbooks, that allowed this new wealthy class to emulate the upper class and the Royalty. World-wide trade was also on the rise bringing new products into England and allowing access to these products to a larger group of

"Approued pointes of Cookerie, Approued pointes of Husbandrie, Approued Medicines for sundry diseases., etc." This edition has been re-formatted into a more approachable book for the modern reader. The recipes are sorted into boiling and stewing, roasting, frying, fritters and puddings, baking, eggs and cream, etc. This, in my opinion and for our use, was an unnecessary change. However if you would like to look at the original part one of "The Good Housewife's Jewel" can be found in Early English Books online here: https://quod.lib.umich.edu/e/eebo/A19957.0001.001?view=toc

The recipes in Dawson are incredibly varied. We see the use of bread in stuffing for meat, similar to the modern kind, for the first time. There are cordials and distilled products. Candies such as sugared violets and preserved cherries, lemons, oranges and more. Sweet pies and tarts for the "Banqueting course" and

savory ones for the other courses. You will also find many savory meat dishes boiled, roasted and fried and then served with scrumptious

sauces. We also see, possibly, the first written recipe for Haggis! In Dawson's recipe it calls for bread crumbs rather than the traditional Scottish Oats. It doesn't call for nearly as many different offal parts as the modern recipe and

This modern edition is structured completely differently from the original. The original editions, Parts One and Two, had chapters such as





adds cream, rosewater, pepper mace, nutmeg, winter savory parsley, thyme, pennyroyal and sugar. Quite the complicated flavor profile. Along with the culinary recipes there are also medical recipes, which the modern editors have categorized under "Remedies". Some of the recipes are throw backs to a more medieval time including the recipe for "Triffle" and a recipe that is almost exactly the same as the medieval Blancmanger. Dawson also includes the first recipe in an English cookbook for the new world product of sweet potatoes. Besides the recipes this edition includes an Introduction by Maggie Black on the history of the book, an editor's note that speaks briefly about the changes made in this edition, a glossary and an Index.

As mentioned above "The Good Housewife's Jewel" contains the first recipe for "Trifle". Two years later, in 1598, Florio described a trifle in his Italian to English dictionary as "a dish composed of cream boiled with various ingredients, similar to a fool". This recipe, besides the heating, is very similar to a medieval fool. Modernly, trifle is a classic British cold pudding with custard, fruit, jam and day old-cake or sponge biscuits. Dawson's recipe for trifle is not a modern one. It adheres to Florio's description of a "Fool". You can easily make this recipe from the description in Dawson's book. Just sweeten and flavor it with rosewater and some spicy powdered ginger to your taste. BE CAREFUL with the rosewater. Every brand, and it seems every bottle, has a





different strength. This is the same with powdered ginger. Start slow and add a ½ teaspoon at a time. To a pint of 35% heavy cream I used 3 tablespoons of white granulated sugar, 1½ teaspoons of powdered ginger and 1 tablespoon of Rosewater. Put these ingredients into the cream before you start to whip it. Also make sure you don't turn the cream to butter!

#### TO MAKE A TRIFLE

Take a pint of thick cream, and season it with sugar and ginger, and rose water. So stir it as you would then have it and make it luke warm in a dish on a chafing dish and coals. And after put it into a silver piece or a bowl, and so serve it to the board.

This chicken sauce recipe is reminiscent of

Chinese American Orange Chicken. The Title of the recipe is "To Boil A Capon With Oranges And Lemons." The first line of the recipe says to "Take oranges or lemons" "And" or "Or"? I choose to do AND for two reasons, first the title, second the oranges we have now are likely sweeter than ones in period. I have also substituted chicken for the capon. It is much easier to find in the grocery store. You could even make this sauce and serve it over warm Rotisserie Chicken for a very quick and easy potluck contribution.

#### ELIZABETHAN SWEET AND SOUR CHICKEN SAUCE

2 cups of chicken broth

1 ½ cup semi-sweet white wine

1 medium sized lemon, quartered with peel

1 medium sized orange, quartered with peel

7 prunes

4 whole cloves

½ teaspoon peppercorns

4 tablespoons of sugar, or to taste

3 pieces of whole mace

1 tablespoon of rosewater

In a small sauce pan place all ingredients. Bring to a boil, then simmer over low heat until the flavors combine.

Note: Modern diners will likely want a thicker sauce. You can thicken this sauce with your go -to thickener, but in period it was a thinner sauce and the chicken was served over sops with the sauce poured over it.

Not much is known about Thomas Dawson. We don't even know when he was born or died. We do know of two other popular recipe/household books are attributed to him "The good Hus-wifes handmaid for the kitchen" (1594), and "The Booke of Carving and Sewing" (1597).

Margaret "Maggie" Black was born in 1921, in London and died August 5th, 1999. She was a well-known food historian and food writer and also the author of several children's books and plays. She completed a Master's Degree at the University of the Witwatersrand in Johannesburg, South Africa. Besides Dawson she was also the editor of "Mrs Beeton's Favourite Cakes and Breads" (1972). Her historic cook-



books Include "Heritage of British Cooking" (1977), Maggie Black. "Food and Cooking in Medieval Britain" (1985) with Peter Brears, "The Medieval Cookbook" (1996, 2012) reviewed previously in Eat This Book, and "Medieval Cookery: Recipes and History" (2003).
