



Greetings unto the populace of Northshield from the Minister of Regalia,

Continuing our celebration of Northshield's 20th anniversary as a Kingdom I would like to share some more of our regalia. This item is called the "Princess' Sleeve." Here is the text in the actual sleeve case explaining the history of the item:

At the first rapier championship of the Principality of Northshield, HSH Gwyneth Felton presented the victor (Isaac de Hugo) with one of the sleeves from the gown she was wearing at the time. At the next tournament, Isaac passed along this favor to the new champion, Adrien de Troyes, thus beginning the tradition of the Princess' Sleeve as a "hereditary" favor. The idea of a Princess' Sleeve tournament (independent of the rapier champion tournament) was presented during the third reign of the Principality Northshield. "I proposed this new tradition during TSH's Therica & Sigfried's reign because many rapier fighters felt that the selection process of a champion was too selective and that we should



have an honor conferred by prowess alone – Julio."

Counting the initial two champions as joint sleeveholders/champions, the rapier community has provided a Princess' Sleeveholder to each and every Princess Northshield has been graced with (as both a principality and now as a kingdom) {note, Countess Bridei, aka Queen Mum, was never the Princess of Northshield and did not host a Princess' Sleeve tournament}. Greetings, Heralds of Northshield!

As the saying goes, "many hands make light work." It takes over 100 volunteers to fill our various kingdom offices, from Stallari to group officers and all. Our community of heralds is no exception; we need volunteers! Northshield is divided into three regions, and Polaris is supposed to have a Regional Deputy in each. All three of those positions are open.

- Duco Herald (Eastern Regional Deputy)(WI & the UP)
- Ministraro Herald (Central Regional Deputy)(MN & ON)
- Illumino Herald (Western Regional Deputy)(ND, SD, & MB)

Regional heralds collate reports from branch and at-large heralds in their assigned region, and complete quarterly summary reports of regional activities. They are expected to maintain contact with senechals of groups in their assigned area without a branch

herald to make sure any needs are being met, and to serve as first-line resources for branch and at-large heralds in their assigned area. They are expected to assist with tournaments and courts at events held in their assigned area as needed or on request. They are expected to provide commentary in OSCAR, and will be trained in its use if needed (don't worry, it's not hard at all). You must have a paid SCA membership to be an officer. Time commitment:

about 1-2 hours per week. The term of office is generally two years.

For more information, please feel free to contact me. Please send letters of intent to me at herald@northshield.org. These positions will be open until filled.

In addition, my friends, I will be stepping down in December, so I am calling for letters for my replacement as well. Polaris Herald is the administrative head of the Northshield College of Heralds, and is warranted jointly by the Crown of Northshield and the Society Herald as a Great Officer of State. Polaris is responsible for overseeing all heraldic and scribal activities within the Kingdom, and for reporting quarterly to Laurel Sovereign and Their Royal Majesties regarding those activities in the kingdom. They are a member of the Stallari council as a Great Officer, and are expected to attend Stallari meetings and to advise Northshield Royalty. You must have a paid SCA membership to be an officer. Time commitment: 2-3 hours per week. The term of office is generally two years.

Speaking of changes in the future, have I mentioned lately that we have a new website coming? I know, I know, I've said that before. But this time for realsies. And if anybody wants to help develop it (the base will be WordPress, so PHP and MySQL is helpful, but a good UX designer wouldn't go awry, and I expect that the Chronicler letter in this issue will have more details), please let us know.

And finally, we have been asked by the Society Webminister to make some changes to how Northshield manages websites in our Kingdom. Specifically, the requirement we've had in place that someone other than a group's webminister also have admin permissions to the group's website will be expanded, and the office of the Kingdom Webminister will also need to have that level of access. I will be in touch with all of the group webministers to get that information.

But wait, there's a carrot with this stick! In addition, any group which needs a location for a website will be given space on the hosting provider which hosts the Kingdom website. At this time we can only provide .Net / MSSQL hosting, but soon – with the advent of the new website – we will be able to host WordPress installations as well. Since those will be in the same space as the Kingdom website, we will also be able to provide a data feed from the Kingdom database into the group's site. You won't need to manage your own OP, your own populace list, your own officer list... it will open whole new vistas for webministers in Northshield.

# SCA CORPORATE ANNOUNCEMENTS

#### JANUARY BOARD MEETING ANNOUNCEMENT: OMNIBUS PEERAGE

Currently approximately 8000 people around the Knowne World actively participate in target archery, combat archery, siege weapons, thrown weapons and equestrian martial activities. While no ultimate decision has yet been made the Board believes that a proposal of a path to peerage for these individuals is worthy of deep consideration.

Having received advice from the Peerage Committee, Directors have discussed the matter and following some minor amendments to language which align the proposed draft of Corpora wording to the existing patent orders, the Board feels that the proposal has matured to the point where commentary on the proposed Corpora wording from members is requested. This commentary will assist the Board in forming further decisions relevant to its consideration of this matter.

The draft Corpora language approved for commentary is:

VIII.A.4:

- e. The Order of <Name>
- (i) Members of the Order of <Name> may choose to swear fealty but are not required to do so. The candidate must have attained the standard of excellence in skill and/or knowledge equal to that of their prospective peers in a pre-17th century martial pursuit as practiced in the SCA, including, and limited to, target archery, combat archery, thrown weapons, equestrian activities, and siege engineers. The candidate must have applied this skill and/or knowledge for the instruction of members and service to the kingdom to an extent above and beyond that normally expected of members of the Society.
- (ii) The duties of the members of the order are as follows:
- (a) To set an example of courtesy and chivalrous conduct on and off the field of honor.
- (b) To respect the Crown of the kingdom; to support and uphold the laws of the kingdom and Corpora.
- (c) If in fealty, to support and uphold the Crown of their kingdom.
- (d) To enrich the kingdom by sharing their knowledge and skills.
- (e) To enhance the renown and defend the honor of the peer's Lady or Lord.

(f) To advise the Crown on the advancement of candidates for the Order of <Name>.

(other sections re-numbered as needed)

Knowing exactly what the people who work, study, and play in the Society want a potential new peerage to achieve and do will be key to moving forward in this discussion. The Board welcomes any additional context that people feel may be of use to the discussion.

We are looking for your feedback – as you begin to type up your comments please feel free to include your thoughts on the following questions:

- Does this language fill the gap I personally feel exists in the paths to peerage, why or why not?
- What is my ideal vision of a new peerage and its members? What virtue will they embody?

EDIT: If you are a financial member of the SCA, please include the relevant information.

The expertise of our community is invaluable, and these responses will contribute significantly to an outcome that positions our Society to meet its goals and future opportunities.

#### POLICY CLARIFICATION: KINGDOM EARL MARSHALS AND AUTHORIZATIONS (JAN 22, 2024)

The following is a joint statement from the Society Seneschal (Lis Schraer) and the Society Marshal (Melissa Midzor).

This is a clarification of Society Seneschal's Corpora interpretation regarding the "Authority of a Kingdom Earl Marshal (KEM) to issue or confirm martial authorizations" (July 24, 2022). The long version of this clarification (including Corpora and Marshal Handbook references) can be found at: http://www.sca.org/resources/document-library/#marshal

Clarification: If there is a question on the validity of the proof of an authorization, the KEM is responsible for and is the arbiter for confirming that yes, a person did authorize properly (and thus were properly issued their authorization) or no, they did not authorize properly. If a proper authorization was completed and verified, the KEM can also issue the proof of authorization (for all martial forms). This provides a quick remedy for participants in the case of a lost card, or when paperwork filing or online system updates were delayed. "Issue" in this context refers to the proof of authorization provided to the participant upon an authorization being completed, registered and tracked by the kingdom (Corpora IX.A.6).

This does not mean a KEM can singularly authorize an individual unless they are a warranted and designated authorizing marshal of that form and follow established processes. Paperwork should be processed in a timely manner. Undue delays in the registration and tracking of properly submitted paperwork must be reported to the Kingdom Marshal immediately. Further disagreements on the issuance of authorizations are referred to the Society Marshal for resolution.

Additional information on authorizations:

- a) A marshal, including KEMs, cannot authorize a participant unless that marshal is an authorized marshal of that martial form, and designated as able to authorize individuals. Warranting and authorizations must follow Society and Kingdom processes. (Corpora IX.A.2, and IX.A.3)
- b) All authorized and warranted marshals, including KEMs, PEMs, Society, and their Deputies, must meet Society requirements before they can be authorized and warranted in that martial form. They are not, and cannot be, automatically authorized and warranted in any martial form solely because they hold an office or an award. Society requirements include demonstrating the ability to oversee that martial activity, judge an authorization, and inspect weapons and armor, and be knowledgeable about the safety and rules of that martial activity. (see specific Marshal requirements in the Handbooks.)

Event membership rate fees received this period will be classified as "Prior to February 3, 2024" for financial reporting purposes.

Post February 3, 2024:

Fees collected on or after February 3, 2024, for events occurring after March 31, 2024, will be subject to the revised event membership rate of \$10.

We understand that adjustments to fees impact our community, and we appreciate your understanding and continued support as we work together to enhance the SCA experience. There simply is no good time to implement an increase of this nature due to the ongoing nature of our events.






