Any copyrighted material by others must be accompanied by written permission from the original author(s). Please check the licence/usage terms of any clip-art used. The Dragon's Tale is set using Scribus 1.4.6 with Garamond, Arial, Arial Narrow. Lucida Handwriting and UBW Chancery typefaces in various sizes. The Dragon's Tale logo is in Tyrfing Demo typeface.

#### Event Scheduling and Announcements

Announcements should then be written and can be updated directly to the web form or sent separately to the Chronicler.

Event announcements must include:

- Site street address (if no address, you must mention that in the announcement).
- Date of the event.
- Starting/stopping time of the event .
- Cost and Payment information (if there is a fee).

You are encouraged to include:

- Name and contact details of Marshal-in-Charge (if there is combat).
- · Reservation deadlines, if any.
- URL for the full announcement
- · Restrictions, if any (pets, open fires, alcohol) etc.
- Information about what the event is about
- Information about accommodation, meals etc.
- Other contacts (reservations, cook etc.)

# Awards in the SCA and how they are awarded - A look behind the scenes

One of the things I really like about the SCA is that we take the time to recognize a lot of the hard work, time and dedication our friends put into our society. At many events we gather for court and watch and cheer as the spotlight is directed at people for their contributions to the arts & sciences, martial activities, service and overall participation that together make our dream happen. I know there are others who don't agree with me in that the awards system is good and I totally agree that our system is far from perfect but I haven't come up with a better one, nor had one suggested. How often do we in our mundane lives, in other clubs or societies, at work or other social groups take the time to pause and shine a spotlight on people who do great stuff? Nearly never. In the SCA we do!

So what actually happens before the pomp and ceremony of a court? Who decides what people will get called up and how? The first question is easy, the crowns decide but the how takes more time to explain. Here is a summary of what has to happen before someone gets called into court and in a way sometimes maybe an explanation of why someone has not yet received a certain award.

- 1. You have to go to events where royalty are present. If you aren't at events where court is being held the likelihood of being called up is zero.
- 2. You have to register well in advance. This past reign we have tried to get scroll recommendations to signet clerk at least 6 weeks before an event so that she can assign the scroll to scribes and the scribes have time to make the scroll and get it to us/the event in time (scrolls from UK to us in Sweden take 3 weeks in the mail so there goes half of that time!) This means that we have usually asked the event autocrats for a list of registered people 7-8 weeks before the event. If you register 4 weeks before we probably won't know you are going until we see you on site.
- 3. Someone needs to have written a recommendation. Preferably more than one person. It happens that we give out awards without any recommendations because we know the person and "recommended them to myself" but we really try to avoid doing that as it increases the "you have to be friends with the royalty" bias.
- 4. The recommendation has to have come in well in advance. Quite often recommendations get sent 2 weeks or even shorter time before an event (and of course many just after events). That is great and it will be on file for future events but the planning for court and scrolls is already done so it won't be taken into account for this event.
- 5. If you have gotten another award recently then it doesn't matter if we have 30 recommendations for an award, the likelihood of you getting it now is very low because we want to shine the spotlight on many different people, not the same ones again and again. Those recommendations will however remain and be passed on to future crowns.
- 6. The OP needs to up to date so that we can see that you recently got an award and thus can follow #5. That means court reports were sent in and Posthorn has had time to update. And this is volunteers work so we cannot expect this to always be done promptly because life and volunteers. The OP being up to date also helps us avoid awarding the same award more than once to the same individual.
- 7. Many recommendations are for barony/principality/kingdom level awards at the same time. We royalty try to communicate before events so we don't call the same person up for 2 awards during the same event. But again; volunteers. And sometimes it isn't the same event but 2 close to each other so award #1 was planned and scroll commissioned and in the weeks between that and the event itself award #2 was given out by someone else.
- 8. No one likes 3 hour courts. The list of awards that we would like to give out is always longer than the list of awards we actually give out. At pretty much every event. We will prioritize as best we can based on many factors including likelihood of you being at an event with a royal court in the near future but sometimes you just have to be lucky when it is toss of a die what goes on the final list or not.

Yes, it isn't fair that for some people it is easier to get all these things to line up so it can happen and for others it is really hard due to geography, time, money, family, ability to plan in advance, area of interest, what people you hang out with, if you like being seen or like hiding in the background etc etc etc. But that is a part of life. We can all do our part in trying to lessen these challenges to help our society as a whole and the easiest way to do this is to send in recommendations. Look around you at your next event and see those around you doing great things. Recommend your closest friends and family if you feel they are deserving of an award. Take the time to ask around and find out the name of the person who caught your attention but you don't know (and write it down so you don't forget). Better yet, go introduce yourself and tell them that you appreciate their efforts. Simple words of recognition can mean a lot, often more so than being called up in court and a scroll on the wall.

# Curia decision

The following law change is now in effect after having been discussed at curia on October 24th and read into court on November 9th during Kingdom University.

7.01.2 In return for the privilege of being allowed by the Crown to sponsor one of the six Kingdom Level events, the sponsoring group shall donate 50% of the profits of the event to the Kingdom coffers. This shall apply even if the event is held within an affiliated organization.

#### • Feedback Request - Policy on Conduct

The Board of Directors is asking for feedback on the addition of a "Policy on Conduct" to the Corporate Policies of SCA, Inc. which is suggested by the Society President.

#### Background:

The Society President listened to feedback from members about having more transparency. SCA, Inc. has concerns about legal risk to the corporation and harm to its members. There is a balance on how much information can be shared. Most people who wrote to the President mentioned sanctions (punishments for breaking rules). Many wanted clear rules to better understand what kinds of actions lead to sanctions.

#### Purpose:

The SCA has always valued keeping some things private, in order to protect the corporation and its membership, and has not talked much about sanctions in the past. The organization doesn't want to focus on the personal stories of those who break the rules or are investigated as this could lead to the very real danger of retaliation. However, members have asked for more transparency about why sanctions are given.

The Policy on Conduct helps balance the need for privacy with the desire for transparency. Sanctions can be upsetting, but the rules are important for the safety and fairness of everyone who participates in the SCA.

#### Design:

The Policy on Conduct brings together all the main reasons someone might break the rules of the SCA. These rules aren't new, but they are now organized in one place to make them easier for everyone to find. The rules are kept simple but clear enough to give guidance without putting the organization at risk. More detailed explanations of the rules are found in other handbooks and policies.

#### Benefits:

This policy helps the Board of Directors explain their decisions more clearly. It also gives a guide for investigations and helps members understand the reasons for sanctions. It should assist to build trust between the Board and the members by showing clear expectations for how everyone should behave in the SCA.

#### Summary:

It is suggested that a "Policy on Conduct" be added to the SCA Corporate Policies. Taking existing rules and gathering them into one policy helps the membership better understand what leads to sanctions. Stating the rules with more flexibility allows the Board to explain their decisions in a way that is less risky to the Corporation. This "Policy on Conduct" allows more transparency for sanctions and helps the members know what rules not to break.

#### XX. Policy on Conduct

To promote a safe, respectful, and enjoyable environment for all participants, this Policy on Conduct outlines the expectations for behavior during all SCA events, activities, and interactions, both in-person and online. This policy does not supersede modern law. Violations of modern law should be reported to the law enforcement authorities.

#### A. Adherence to SCA Rules and Laws

- 1. All participants must adhere to the SCA's governing documents (Corpora, Corporate Policies, and By-laws), as well as Board-approved SCA Officer Policies, Kingdom Law, and any event-specific rules. Understanding and following these rules is the responsibility of all participants
- 2. Participants are expected to respect the decisions and directions of SCA officers, marshals, and event staff. These individuals are



responsible for upholding the rules and safety standards of the SCA. Disagreements may be addressed through the chain of appeals as necessary.

- 3. Participants shall not behave in a manner which could put the SCA or its participants at risk or fear of imminent harm.
- 4. Violations of this policy may result in disciplinary actions, including but not limited to warnings, or Sanctions up to and including temporary removal of participation or revocation and denial of membership in the SCA. The degree of the action will depend on the nature, frequency, and severity of the violation(s).
- B. Responsible with Resources
- 1. Corporate and Kingdom financial policies must be followed. This policy may be further defined in the "Society Financial Policy," individual Kingdom policies, and SCA Corporate Treasurer documents.
- 2. Officers and members responsible for managing SCA funds must ensure that financial resources are used prudently, with transparency and accountability. See also "Exchequer's Handbook."
- C. Respect towards Participants
- 1. The SCA promotes an environment free of bullying and harassment of all individuals and groups. This policy may be further defined in the Seneschal Handbook Policy on "Harassment and Bullying" and the SCA Conduct and Behavior Documents.
- 2. The SCA is committed to creating a welcoming environment for all participants. Discrimination based on race, ethnicity, gender, sexual orientation, religion, disability, age, or background is not allowed.
- 3. The SCA prohibits non-consensual sexual behavior including but not limited to sexual assault, sexual harassment, stalking, and sexual violence. This policy may be further defined in the Seneschal Handbook "Sexual Misconduct Policy" and the SCA Conduct and Behavior Documents.
- D. Responsible with Minors
- 1. The responsibility for the care, supervision, and behavior of minor children rests solely with their parents or legal guardians at all SCA events, activities, and gatherings at all times. This policy may be further defined in the Seneschal Handbook "Dealing with Minor/Youth-Related Policies."
- 2. Parents and legal guardians are not relieved of their primary responsibility for the welfare and behavior of minors under their supervision when participating in SCA Youth Activities. This policy may be further defined in the Seneschal Handbook "Dealing with Minor/Youth-Related Policies."
- E. Safety and Well-being
- 1. All participants must prioritize the safety of themselves and others during all activities.
- 2. Compliance with SCA established safety regulations and procedures is mandatory.
- 3. The possession of modern firearms at SCA events is prohibited. This policy may be further defined in the Seneschal Handbook "Firearms Policy."
- F. Animals
- 1. The responsibility for the care, supervision, and behavior of pets and/or service animals rests solely with their owners at all SCA events, activities, and gatherings at all times. This policy may be further defined in the Seneschal Handbook "Service Animals Policy" and "Pets at Official SCA Activities Policy."
- 2. Where animal restrictions apply, the only service animals allowed are those permitted under modern law. This policy may be further defined in the Seneschal Handbook "Service Animals Policy" and "Pets at Official SCA Activities Policy."
- 3. The hunting or slaughtering of live animals is prohibited at SCA functions. This policy may be further defined in the Seneschal Handbook "Policy on Hunting, Slaughtering, and Butchering."
- G. Reporting and Enforcement
- 1. Members are encouraged to report any violations of this policy to the Office of the Seneschal. Reports must be made in good faith.
- 2. Reports of misconduct must be a non-anonymous first-person account. The SCA will document and keep reports confidential. Should an investigation become necessary, it will be conducted fairly and confidentially, respecting the rights of all parties involved.
