# Kingdom Law Changes read into court at Candlemas Feb 8th, 2025

### IV.D.5

The Crown and Greater Officers above the office being applied for, will interview all applicants for the replacement deputy position in a timely fashion.

### IV.F.9

The Seneschal of the Kingdom will have the power to withdraw the Society's sanction authorization from an event when the activities of the group or individuals conflict with Gleann Abhann Law, the Governing Documents of the SCA, Inc., the civil or criminal laws of any county or parish, city, state, or nation in which the event is held, or with the Directives of the Board of Directors. The Kingdom Seneschal will withdraw sanction only as a last resort.

### IV.F.11

The Kingdom Seneschal, with the consent of the Crown, may create, suspend or close such deputies and lesser offices as they deem necessary to complete the tasks of the office. Their deputies may include:

### IV.G.3

The Chatelaine, with the consent of the Crown, may create, suspend or close suchdeputy and lesser offices as they deem necessary to complete the tasks of the office. Their deputies may include:

The Kingdom Exchequer, with the consent of the Crown, may create such deputies as they deem necessary to complete the tasks of the office. Theirdeputies may include:

The Diamond Herald, with the consent of the Crown, may create such deputies as they deem necessary to complete the tasks of the office. Their deputies may include:

### IV.J.7

The Kingdom Earl Marshal, with the consent of the Crown, may create such deputies as they deem necessary to complete the tasks of the office. Their deputies may include:

### IV.L.4

The Chronicler, with the consent of the Crown, may create such deputies as they deem necessary to complete the tasks of the office. Their deputies may include:

### IV.M.4

The Webminister, with the consent of the Crown, may create such deputies as they deem necessary to complete the tasks of the office. Their deputies may include:

### VI.D.2

The Kingdom Seneschal will first determine if the complaint warrants investigation.

### VII A 1

Kingdom Level Events (KLEs) are officially sanctioned authorized SCA events that are hosted by local groups, of Shire status and above, for the Kingdom Crown and Kingdom Officers to conduct official business. All the theming, business and scheduling of the event will be decided by the Kingdom representative, rather than the host group. The representative of the kingdom making these decisions varies, based on the specific KLE, as described in section VII.C of Gleann Abhann Law.

### VII.F.2

The trade must be agreeable to both hosting groups and submitted to the Kingdom Senschal for approval VII.F.3

The trade may be denied by the Kingdom Seneschal if the Kingdom they judges the trade to be unfavorable to the Kingdom as a whole.





- Flyers Flyers are no longer required to be submitted, but by all means create one for more advertisement. Contact the Kingdom Chronicler for required info that needs to be on your flyer.

### Officer Changes

· Local Officers - When taking on a local office, you must contact the Kingdom Officer that oversees that office prior to filling out Officer Change Form. Permission must be granted, paperwork must be submitted and process must be started before office change can be completed.
