From the Kingdom Seneschal's Office,
Greetings to all, good citizens of Trimaris.

As we head into the hot season I wanted you to know that the Kingdom is well positioned for growth. I am meeting first-timers at every event, looking at the camps as tents sprout where once was bare grass, and the parking lots are full of cars. It reminds me of the way-back days before the plague years.

I have some announcements for you today.

First, that our Barony of An Crosaire has gained a new Canton, Brymmestreme.

Their promotion from incipient group was announced in Their Majesties' Court April 6, at Spring Coronation, and their Canton's name was approved by the SCA College of Heraldry in the January LOAR. Brymmestreme watches our northern border with Meridies, their territory is Columbia, Hamilton, Madison, and Suwannee Counties and I wish them all success. Chirp, Chirp!

Second, that three new Deputy Kingdom Seneschals have been selected from the application period which was posted in January, February, and March's Talewinds, announced on the kingdom website, and also posted to Trimaris Populace FB group on Dec. 9, 2023.

The application period was open from January 1, 2024 through March 10, 2024.

The new Kingdom Deputy Seneschals are:

Successor Deputy: Sir Hjorr yggr ("Yorick") Hákonarson, mka Jerry Gordon.

He will step up as Kingdom Seneschal at Fall Crown List in November 2024 and serve until November 2026.

2nd Deputy: Baroness Thalassia Hellenis, OP, mka Amanda Fessenden.

She is slotted to step into the successor deputy role in Q2 or Q3 of 2025, and then become Kingdom Seneschal in November 2026, serving until November 2028.

3rd "drop dead" deputy, also Kingdom Constable and Event Merchant Coordinator,

Mistress Sythean ("Shannon") Lina Chandler, mka Meridith Cain.

She will serve as Kingdom Constable through November 2025 (this is subject to change) and then step into the chief deputy role through November 2028.

Third, I need a bid in my hands soon for Fall Crown List 2024, this will be November 8-10, at Camp Challenge. The flyer must appear in October's Talewinds, making the deadline for bids approximately May 31st, so the bid may be reviewed and voted upon in the summer Financial Committee Meeting.

I am also taking bids for Winter Art-Sci in January 2025, and Spring Coronation in April 2025.

Lastly, I am charged with putting together a New Kingdom Event: the Queen's Rapier Championship.

We had so much fun at the one which Sudrholt and Moose Lodge produced, we need to keep it going. This event will be a 1-day and needs 2 things: a site and an event team. I am actively looking for suitable day event sites with Her Grace, Grainne who is the Kingdom's site selection committee chair. If you know of one could be a fairgrounds, horse farm, church or private school gym, or a lodge building, get the management's contact information and forward that to myself and Grainne.

Be excellent to each other and remember that chivalry and courtesy are something to practice every day.

Submissions must be received by the 1st of the month prior to publication. Any submissions received after the submission deadline may be held until the next issue. The preferred method of submission is via e-mail to chronicler@trimaris.org. Electronic submissions may be in the body of an e-mail or as an attachment. Artwork should be submitted as a computer graphic file. If you have any questions please contact the Kingdom Chronicler.

EVENT FINANCIAL POLICIES

- All returned checks will be subject to a \$20 fee.
- Anyone who does not pay for their site registration by the time registration closes at an event will be considered to have spent the entire weekend with feast and shall be charged accordingly.
- Anyone who does not pay their event fees, or uses NSF checks to do so, will not be permitted to attend events until all fees are paid in full.
- Requests for refunds must be in writing and received (3) days in advance for a full refund. Requests made at the event will be refunded the site registration amount only. Refund requests will be accepted no later than (20) days after the close of the event.
- SCA & Kingdom policies apply to Children and Family site fees (no family more than 3 adult site fees; children 17 and under are exempt from site fee).

EVENT ANNOUNCEMENTS SUBMISSION CHECKLIST

Event announcements need to be submitted as a standard text listing containing the required information. Announcements should be submitted as early as possible to allow for corrections and more advertising for your event. Announcements must be created following the checklist below. This checklist is intended as an aid in the proper submission of event announcements. All event announcements at which any official business will occur **must** contain the following information:

- Name event and the sponsoring group.
- Date of the event.
- Event site location including name and address.
- Time the event site opens and closes to the public.
- Registration open and closing times.
- Name (mundane and SCA) mailing address, e-mail address, and telephone number of the Reservation Steward.
- Name (mundane and SCA), e-mail address, and phone number for the Event Steward
- Names (mundane and SCA), e-mail address, and phone number for the Marshal in Charge and Ranger in Charge
- SCA Corporate Anti-Bullying policy
- Site registration pricing and payment information.
- OPTIONAL: Description of the event activities.

In order to comply with Kingdom Laws and Policies, unless otherwise stated, the following standard event policies will automatically apply to all events submitted and held within the Kingdom of Trimaris.

- No family shall pay more than the equivalent of three (3) adult site fees. Family is defined as adults and their minor children. This applies to site fees only and does not include feast or cabin space.
- Unless otherwise noted, The site fees for children 12 and under are free.
- The SCA member discount for site registration shall not exceed \$10 per person.
