Searching for a Successor A/S Warranting Officer

The Successor A/S Warranting Officer serves under the direction of the Kingdom Minister of Arts and Sciences and is responsible for the obtaining and completion of Warrants for new A/S officers, ensuring protocols are followed, and maintaining the spreadsheet that lists all such officers.

The Successor A/S Warranting Officer reports A/S Warranting 5 times a year (4 quarters and End of Year Domesday) to the Kingdom Minister of Arts and Sciences.

The Successor A/S Warranting Officer is expected to join the Facebook Officer Group (or similar resource if and when this evolves) – or select a proxy to attend in their stead – and is expected to attend all online/Zoom meetings quarterly.

The Successor A/S Warranting Officer is expected to respond to all emailed correspondence to the Group's Official Arts and Sciences email box within three business days. Queries do not need to be resolved in that time but must be acknowledged. An auto-responder defining alternate contact is acceptable on extended travel/leave.

The Successor A/S Warranting Officer is responsible for reporting receipt and passing of the Chain of Office.

CHANGES TO KINGDOM LAW



We're planning on moving forward with a number of law changes. This email constitutes our formal submission for purposes of the thirty day waiting period. We plan to have these changes read into court at Queen's Heart (May 10th).

Here is the relevant text regarding procedure in current Kingdom Law:

B. Publication for comment and analysis

1. The Crown shall submit the proposed amendments in writing and in a commonly used word processing format.
2. Amendments shall be submitted to the Kingdom Web Minister for publication on the Kingdom Web Page.
 - a) The Crown may, in its sole discretion, direct the Kingdom Web Minister to publish the proposed amendments in other forums in addition to the Kingdom webpage.
3. Amendments shall be submitted to the Kingdom Chronicler for publication in the Kingdom newsletter.
 - a) In the case of extensive revisions of Kingdom Law (defined as an amendment that requires such space as to make publication in the Kingdom newsletter prohibitive), a notice shall be published in the Kingdom newsletter alerting the populace to proposed changes and directing them to the Kingdom's webpage.
 - b) Any member of the Society of Creative Anachronism residing in the Kingdom of Trimarís may request a written copy of the proposed law changes referred to in the notice at the Kingdom's expense.
 - (i) Any notice published in the Kingdom newsletter pursuant to this section shall include the following language: "Those members of the Society for Creative Anachronism who wish to do so may contact the Kingdom Chronicler for a paper copy of the proposed law changes, to be mailed at the Kingdom's expense."
4. Non-substantive amendments to Kingdom Law to correct typographical errors, renumbering, or that do not substantive change the meaning of the law, need not be published for commentary.

C. Comment period

1. The comment period runs for 30 days from the date Crown submits the amendment for publication to the Kingdom Web Minister and Kingdom Chronicler.
 - a) For the purposes of this section, submission to the Kingdom Web Minister is deemed completed upon emailing the amendment to: webminister@trimaris.org.
 - b) For the purposes of this section, submission to the Kingdom Chronicler is deemed completed upon emailing the amendment to: chronicler@trimaris.org.
 - c) The Crown shall maintain written evidence of the content and date of submission.
2. All comments shall be submitted in writing to the Crown via comments@trimaris.org
 - a) The Crown may, in its sole discretion, accept written comments via alternative submission methods.
3. The Crown, in its sole discretion, may extend the comment period.

Here are the changes we would like to make to kingdom law, in the order in which they appear. The new text is in blue and italic font. They are:

Loosen the residency requirement for Crown Tournament.

Add one Defender event per year.

Clarify that sponsorship by Barony or Shire is not required for a bid.

Add a no-compete rule for events.

Clarify that the Queen and Princess may wear an honorary white scarf while sitting.

Strike "administrative" from Order of the Argent Scales to make it a broad service award.

Add a new kingdom honorific award.

Remove stipulation that Orbis Honoris can only be bestowed at Gulf Wars.

Revise sumptuary laws

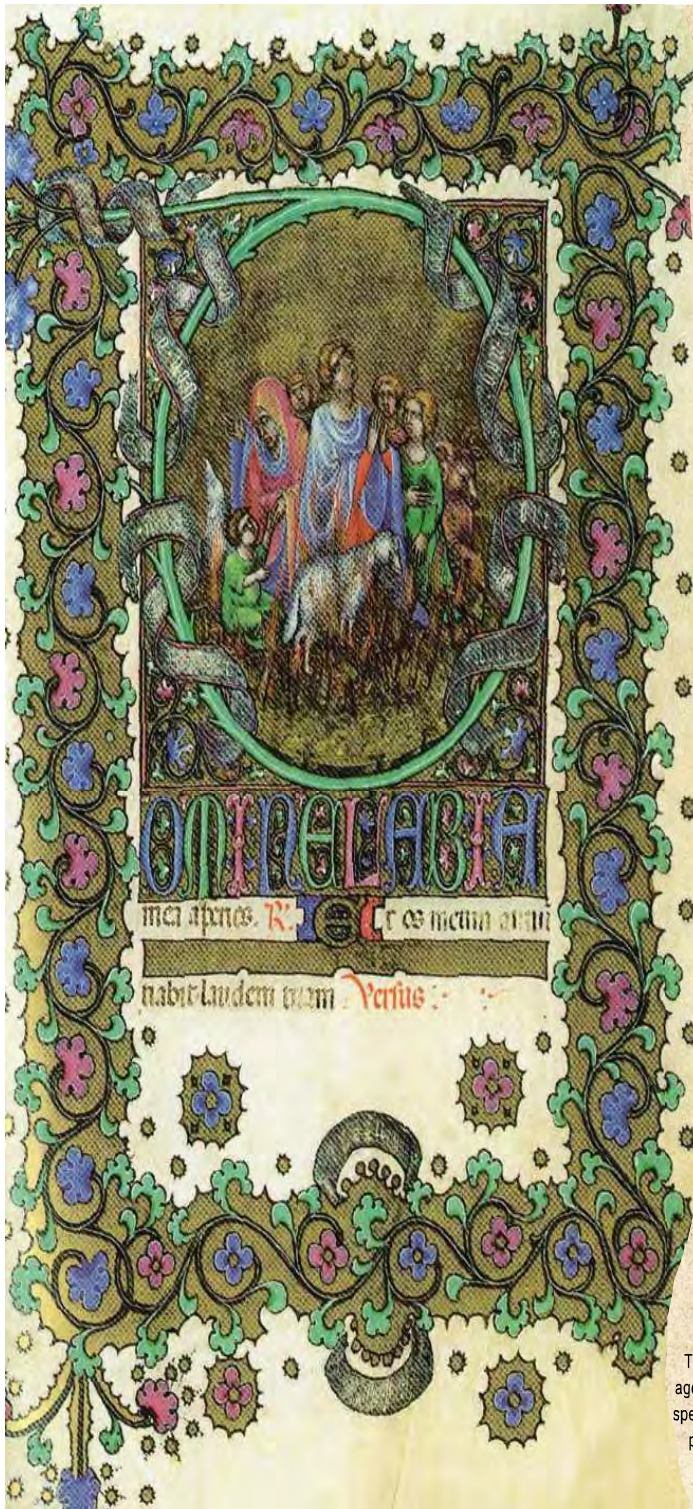

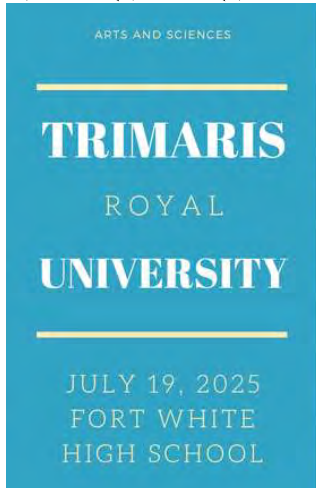

Submissions must be received by the 1st of the month prior to publication. Any submissions received after the submission deadline may be held until the next issue. The preferred method of submission is via e-mail to chronicler@trimaris.org. Electronic submissions may be in the body of an e-mail or as an attachment. Artwork should be submitted as a computer graphic file. If you have any questions please contact the Kingdom Chronicler.

EVENT FINANCIAL POLICIES

- All returned checks will be subject to a \$20 fee.
- Anyone who does not pay for their site registration by the time registration closes at an event will be considered to have spent the entire weekend with feast and shall be charged accordingly.
- Anyone who does not pay their event fees, or uses NSF checks to do so, will not be permitted to attend events until all fees are paid in full.
- Requests for refunds must be in writing and received (3) days in advance for a full refund. Requests made at the event will be refunded the site registration amount only. Refund requests will be accepted no later than (20) days after the close of the event.
- SCA & Kingdom policies apply to Children and Family site fees (no family more than 3 adult site fees; children 17 and under are exempt from site fee).

EVENT ANNOUNCEMENTS SUBMISSION CHECKLIST

Event announcements need to be submitted as a standard text listing containing the required information. Announcements should be submitted as early as possible to allow for corrections and more advertising for your event. Announcements must be created following the checklist below. This checklist is intended as an aid in the proper submission of event announcements. All event announcements at which any official business will occur **must** contain the following information:

- Name event and the sponsoring group.
- Date of the event.
- Event site location including name and address.
- Time the event site opens and closes to the public.
- Registration open and closing times.
- Name (mundane and SCA) mailing address, e-mail address, and telephone number of the Reservation Steward.
- Name (mundane and SCA), e-mail address, and phone number for the Event Steward
- Names (mundane and SCA), e-mail address, and phone number for the Marshal in Charge and Ranger in Charge
- SCA Corporate Anti-Bullying policy
