**DRAFT PROPOSAL FOR COMMENTARY  
CORPORATE POLICY XIX.  
DELEGATION OF INVESTMENT AUTHORITY POLICY**

The Board of Directors is currently considering the following addition to the SCA’s Corporate Policy:

**XIX. Delegation of Investment Authority Policy**

The Board shall ensure that fiduciary responsibilities concerning the proper management of SCA, Inc.’s institutional funds are fulfilled through appropriate investment structure, internal and external management, and portfolio performance consistent with all policies and procedures. Based on the advice and recommendations of the Treasurer and its external fund manager (s), the Board shall approve investment policies and objectives that reflect the long-term investment-risk orientation appropriate to the organization. The Board may, at its sole discretion, create or eliminate committee(s) to advise the Board in furthering its duties and may select, appoint, and remove members thereto.

The Board hereby delegates supervisory responsibility for the management of its invested funds to the Corporate Treasurer, subject to the financial limitations specified in Corpora, as noted below:

- Determine that institutional funds are prudently and effectively managed with the assistance of management and any necessary investment consultants and/or other outside professionals, if any.
- Recommend the retention and/or dismissal of investment consultants and/or other outside professionals.
- Receive and review reports from management, investment consultants and/or other outside professionals, if any.
- Periodically meet with management, investment consultants and/or other outside professionals management, investment consultants and/or other outside professionals.
- Report to the Board (as needed) whether this policy, investment activities, risk management controls and processes continue to be consistent with meeting the goals and objectives set for the management of institutional funds.
- Execute such investment transactions as are necessary to ensure that SCA, Inc.’s investment portfolio reflects the asset allocation, investment-risk orientation, or other direction regarding the investment portfolio as has been established by the Board.

There are a number of other positions that will soon reach their normal cycle time, so if you want to help, never fear, there'll be more opportunities coming soon!

Like, for example, a couple of months ago I opened up a call for a deputy to Blue Hawk, our OP Clerk. However, due to real life constraints, we actually need to fill the main position of Blue Hawk as well.

I would like to take this moment to thank Baron Konstantia Kaloethina for all of their work. They have fulfilled this role for about four years, and done a great job at it. It's a thankless job, except for right now when I'm thanking Their Excellency. They have been a major part of why the Calontir College of Heralds is as strong as it is.

By the way, if you've already sent me an email for the deputy position, no need to send me another. I'll go through all the applicants at once and choose both at the same time.

Moving on, I'd also like to thank Mistress Sarra the Brave. In December, she took over the job of Saker when no one else could despite the fact she didn't have enough training.

Saker is the External Submissions Deputy and is critical to getting names and devices properly registered. It requires a great deal of detail work, preferably by someone who loves book heraldry.

It is *not* an easy job, so I'm immensely grateful to Sarra for throwing herself on that grenade. However, her real life has gotten extremely busy and she too needs to step down so we need a new Saker as well as the OP clerks.

Again, if you're interested, please send me an email. I'll be accepting letters for both positions through Pennsic.

So yeah, about my attitude.

Not really, I mean attitude in heraldry. "Attitude" is a specific term meaning the way a person or animal is arranged on a device. For example, if you're Scottish, you know the lion on your royal banner is "rampant." If you're a fan of medieval Russia, you know the double-headed eagle is "displayed," as is the single-headed eagle of Germany. And, of course, if you root for England in the World Cup, you're rooting for the Three Lions, which are "passant guardant."

Let's talk about a few of my favorites.

I have a dragon passant on my device, which means the animal is walking, or passing by. If you play chess, you see it with the *en passant* rule, which allows a pawn to take another pawn that moved two on it's opening move, attacking it when it passed by.

Passant derives from a Proto-Indo-European root that means "to spread." From it we get "fathom," "expansion," and, of course, El Paso.

Here's something for all those wanting to awe and amaze any Pelicans in your life. When you see their medallion with a pelican in its piety, as in piercing its own breast, you can compliment them on how well that pelican vulns. "Man, that pelican is so good at vulning!" Or, "Wow, that pelican vulned like mad!"

I'm sure Pelicans will love this!

The etymology should be fairly clear, as "vuln" comes from the same sources as vulnerable, which goes at least all the way back to Proto-Indo-European for "wound, pierce." So this attitude, is vulning.

Anyway, let's talk about dormant. I do like my sleep, and it's the attitude of a sleeping creature. Interestingly, at least to me, it also goes all the way back to Proto-Indo-European and its meaning hasn't really changed. In fact, its descendants mean "to sleep" in Old Church Slavonic, Greek, and Sanskrit as well.

I guess you could say its meaning has remained... dormant. Ha! I slay me.

Anyway, let's get to the position I'm in right now. I'm on my couch, well my couch recliner, so of course I'm couchant, or lying down with my head up. Actually the etymology of couchant is boring as it just goes back to Latin and we don't know much about it



before then.

Etymologists must be... lying down on the job.

And with that, it's probably best if I just lay dormant for a while. It's surely my best attitude.

With Lilies and Battlemoor behind us we look forward to the next war! Pennsic is coming! print your cards and check your gear. Reread the rules. There is a new rule book posted and there are several changes! a brief update on what was changed and a quick explanation of why.

1-There has been a change to the authorizations. two weapon fighting has been removed because it is just a weapon style and not a safety concern so does not require an authorization.

2-We are allowing unpadding polearms in the kingdom now provided that an attempt was made to make it look like a weapon from 10 feet. no slick sticks! With this change Two handed sword and Pole arm have been combined into Two Handed Weapons.

3-Siege weapons and shafted combat archery have been added as authorizations. Everyone will continue to get golf tube combat archery with sword and shield authorization, however if you want to shoot shafted combat archery you must authorize it.

Those are the major changes that were put into the book. There are a few other rules that were modified that I'm willing to discuss the reasons behind with anyone that would like to.

The Court is null, and void and the herald must read the entire court report again into a proper court for everything to be okay. Please do not make the Heralds do this. Please do not make Their Majesties, Their Highnesses or your fellow populace do it again. Do not take away someone's joy at receiving recognition. Please submit the flyer correctly the first time.

Also, a reminder that my warrant is nearing its end, and while this has been fun, I have other things I wish to do, other offices I wish to hold and events to enjoy. 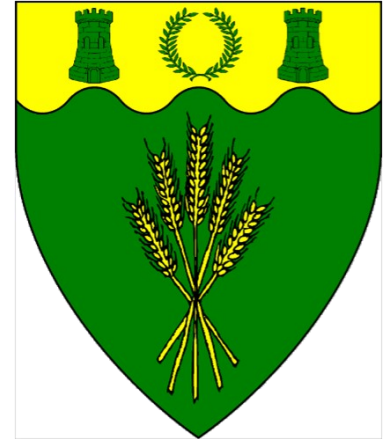

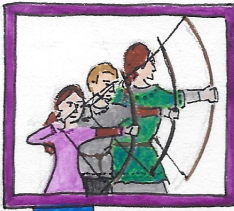

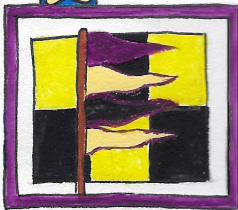

# FLYER GUIDELINES

- ◆ Details of Registration : Do NOT use “FEE” as a describer for registration cost.

For Their Majesties to hold Court, & for official business to happen, a complete flyer must be published in *The Mews*. Failure to do so means that the Crown can not hold Court at that event.

Before sending an event flyer confirm your event with the Reeve. *The Mews* **WILL NOT** publish an announcement if your event has not been approved or confirmed. Check the Kingdom Calendar at: <https://www.calontir.org/events/> For information on how to submit a flyer please visit: <https://www.calontir.org/chronicler/>

For an event to be considered complete and published, official Kingdom business can be carried out, t announcements **MUST contain these SIX ITEMS:**

- ◆ Day month and year of the event
- ◆ Site open & close times for populace
- ◆ Name of the sponsoring group or groups
- ◆ Location of the event. The name of the event site, and full address.
- ◆ Name, both SCA and Modern, of the Event Steward, including contact phone and email.  
( Needed if there an emergency / or issues arise)

Example of wording for Registration:

**Adult Event Registration: \$25 / Adult Member Discount Registration: \$20 / Youth (6-17) \$5 / Children 5 & Under: FREE**

**Event Copies: An Editable version of your flyer MUST be sent. FLYER PDFs WILL NO LONGER BE ACCEPTED AND RETURNED FOR EDIT.**

**Deadline:** The Chronicler must receive event copies no later than the **1<sup>st</sup> of the month TWO MONTHS PRIOR to your event.** ( e.g. if the event is in November, the flyer must be received by September 1st. ) If there is an issue with meeting the deadline, please contact the Chronicler ASAP.  
There is no grace period the deadline is final and non-negotiable. The earlier a flyer is received the better!
