### Request of Commentary—Omnibus Proposal

Currently approximately 8000 people around the Knowne World actively participate in target archery, combat archery, siege weapons, thrown weapons and equestrian martial activities. While no ultimate decision has yet been made the Board believes that a proposal of a path to peerage for these individuals is worthy of deep consideration. Having received advice from the Peerage Committee, Directors have discussed the matter and following some minor amendments to language which align the proposed draft of Corpora wording to the existing patent orders, the Board feels that the proposal has matured to the point where commentary on the proposed Corpora wording from members is requested. This commentary will assist the Board in forming further decisions relevant to its consideration of this matter. The draft Corpora language approved for commentary is:

VIII.A.4:
e. The Order of <Name>

(i) Members of the Order of <Name> may choose to swear fealty but are not required to do so. The candidate must have attained the standard of excellence in skill and/or knowledge equal to that of their prospective peers in a pre-17th century martial pursuit as practiced in the SCA, including, and limited to, target archery, combat archery, thrown weapons, equestrian activities, and siege engineers. The candidate must have applied this skill and/or knowledge for the instruction of members and service to the kingdom to an extent above and beyond that normally expected of members of the Society.

(ii) The duties of the members of the order are as follows:

(a) To set an example of courtesy and chivalrous conduct on and off the field of honor.

(b) To respect the Crown of the kingdom; to support and uphold the laws of the kingdom and Corpora.

(c) If in fealty, to support and uphold the Crown of their kingdom.

(d) To enrich the kingdom by sharing their knowledge and skills.(e) To enhance the renown and defend the honor of the peer's Lady or Lord.

(f) To advise the Crown on the advancement of candidates for the Order of <Name>.

(other sections re-numbered as needed)

Knowing exactly what the people who work, study, and play in the Society want a potential new peerage to achieve and do will be key to moving forward in this discussion. The Board welcomes any additional context that people feel may be of use to the discussion.

We are looking for your feedback – as you begin to type up your comments please feel free to include your thoughts on the following questions:

Does this language fill the gap I personally feel exists in the paths to peerage, why or why not?

What is my ideal vision of a new peerage and its members? What virtue will they embody?

EDIT: If you are a financial member of the SCA, please include the relevant information.

The expertise of our community is invaluable, and these responses will contribute significantly to an outcome that positions our Society to meet its goals and future opportunities.

# Applications Open - President, SCA Inc.



As the Society enters 2024, a new chapter will shortly commence. The Board is seeking a visionary leader – with a heart for community service – to join SCA Inc. and serve as President. SCA Inc. is focused on creating a sustainable, stronger, connected Society and Directors believe that the right President will be pivotal in helping achieve this vision through driving the delivery of the Board's strategic goals.

If you're ready to lead with innovation, inspire a dedicated team and drive strategic initiatives towards a future of growth and positive impact for the Society, we invite you to apply.

#### President, SCA Inc.

The Board of Directors of the Society for Creative Anachronism, Inc. is currently accepting applications for the position of President of the SCA, Inc. This is a salaried position requiring 30-40 hours per week. The office hours are flexible, as availability for evening calls may be required.

#### Position Requirements and Responsibilities:

- The President is the principal spokesperson for the SCA, Inc. This officer is the principal liaison between the SCA, Inc. and outside authorities. Specifically, they are responsible for communications between outside professionals such as attorneys, accountants, insurance representatives, for law enforcement, government agencies, other organizations, and claimants against the SCA, Inc. Approves official interactions with outside media sources when required.
- Provides inspirational leadership and direction to all executives and ensures the continued development and management of a professional and efficient organization; establish effective decision-making processes that will enable the SCA, Inc. to achieve its long- and short-term goals and objectives.
- Serves as the point of contact for all legal and law enforcement inquiries and communications. Responsible for coordinating with SCA legal, IT, and other SCA offices to provide documentation required for legal actions. May be required to provide depositions and affidavits.
- Works with the Vice President of Corporate Operations to coordinate much of the day-to-day modern operation of the Corporation. Services as the immediate point of contact for all Society and Corporate officers. The President currently supervises the Corporate DEIB, Communications, Marketing officers, and the President's Special Project Deputy Officer.
- Works with the Executive Assistant to maintain rosters of Officer
  Warrants and timely post job openings when needed. Responsible for
  ensuring all interviews for Society and Corporate positions are scheduled
  properly after consultation with the Board and pertinent officers.
- Works closely with the Society Seneschal and usually participates in the Society Seneschal meetings with the Kingdom Seneschals. Is the primary point of contact for Kingdom Seneschals on all modern legal issues. Assists in handling special matters when the Society Seneschal cannot due to a conflict.
- Executes contracts necessary to properly conduct the SCA's business and may delegate similar responsibilities. Monitors, stores, and negotiates Affiliate Agreements with Board oversight.
- In conjunction with the Corporate Treasurer ensures that the flow of funds allows the SCA Inc. to make continuous progress towards the achievement of its mission and that those funds are allocated properly

- to reflect present needs and future potential.
- Cultivates a strong and transparent working relationship with the Board and ensures open communication about the measurement of financial, programmatic, and impact performance against stated milestones and goals.
- Advises the Board of Directors on areas of corporate governance and policy issues.
- Currently the President reviews and approves site contracts in accordance with SCA corporate policy. Additionally monitors and audits procedures and departments at large events as needed (Gulf Wars, Pennsic, etc.).
- Responsible along with the Vice President of Corporate Operations for interviewing and hiring office staff as needed with approval from the Board
- Responsible for drafting and submitting four Quarterly Reports to the Board, four Post-Board Meeting Reports to the membership, and ensuring the creation and publication of a public year-end report.

The President may be assigned other duties by the Board. *General Requirements:* 

- The President must be available for the four quarterly Board meetings, typically held over a Friday and Saturday or a Saturday and Sunday. These meetings may be held via videoconference or in person. Inperson meetings require travel, typically on a Thursday and Sunday. In addition, the President must be available for conference call meetings of the Board four to twelve times a year, typically on weekday evenings, and meetings or calls with officers or directors on an as-needed basis.
- The President must have the ability to travel when required by the Board or for legal matters.
- Management experience working with both volunteers and employees required.
- Prior nonprofit experience ideal; management of a global or multisite organization preferred
- Excellent written and oral communication skills, the ability to work independently to prioritize tasks and meet deadlines. Experience in a modern business setting, organizational ability and problem-solving skills are a must. Experience in a modern non-profit organization and prior experience at the Corporate or Society level of the SCA are desirable, but not required.
- As a great deal of the Board's business occurs via the Internet, familiarity and basic skills with a computer, MS Office software (specifically Microsoft Word and Excel), and e-mail are required. The successful applicant must have reliable access to the Internet.

# Announcement—Membership Price Increase

The Society for Creative Anachronism, Inc. (SCA, Inc.) is announcing an increase in membership fees and non-member registration fees for events. This decision comes after careful consideration and extensive discussion among the Board of Directors, office staff, and Corporate officers. The effects of inflation across all sectors of operation, as well as other factors impacting the organization's operational costs, including insurance premiums, legal expenses, and general business expenses, necessitated a comprehensive review of membership rates.

Annual membership fees have not been adjusted in over a dozen years, and non-member registration fees have not increased in over 15 years.

In response to the evolving financial environment, the organization streamlined operations during the 2020 COVID-19 pandemic and significantly reduced corporate expenditures. The relocation of the office to San Jose, CA resulted in an annual savings of over \$35,000, and upgrades to software and CRM systems have netted a further savings of over \$100,000 annually. While membership numbers have rebounded post-pandemic, operational costs continue to rise.

SCA, Inc. Corporate is solely funded by membership fees, including the Non -Member Registration fee, and does not currently seek operational funds from its Kingdoms or subsidiary organizations, including those overseeing Pennsic and Gulf Wars.

At the January 2024 meeting of the Board of Directors, the Board approved the following changes, effective February 15, 2024:

Raise the Sustaining membership price from \$45 a year to \$55 a year (This represents an \$0.83 cents per-month increase over the previous monthly

Raise the Associate membership price from \$30 to \$40 a year. (This

represents an \$0.83 cents per-month increase over the previous monthly

Raise the Family membership price from \$10 a year to \$15 a year, per person. (This represents an \$0.42 cents per-month increase over the previous monthly rate.)

No changes to Canadian or International memberships have been announced at this time.

Note: this change will take effect for all renewal transactions processed on or after February 15, 2024. Renewal transactions prior to that date will be processed at the previous rate, regardless of membership expiration date.

The Board also approved the following changes to Non-Member Registration fees, effective April 1, 2024:

Raise the Non-Member Registration Fee from \$5 to \$10 per event. As always, this only applies whenever there is an actual event fee

Both Sustaining and International Membership allow subscriptions to printed publications, as well as the ability to add Family memberships.

It should be noted that these increases remain less than the cumulative U.S. inflation increase of 36.5% which has occurred since 2011. (Data calculated using the US Inflation Calculator).

SCA, Inc. emphasizes its commitment to transparency and sustaining a vibrant community. These fee adjustments aim to ensure the organization's fiscal health, support ambitious initiatives in 2024 and beyond, and keep the Knowne World thriving and dreaming for years to come.




