THE SCA PROHIBITS HARASSMANT AND BULYING OF ALL INDIVIDUALS AND GROUPS.

The SCA prohibits bullying and harassment of all individuals and groups. Bullying is systematic and unwelcome behavior which involves the use of influence, threat, intimidation, or coercion to cause hurt or harm to another person or group of people. When the bullying behavior is based on a protected class (1), that behavior is defined as harassment.

(1) race, sex, religion, national origin, gender, sexual orientation, age, or disability.

Bullying and Harassment may be **overt**, as in the following non-inclusive list of examples:

- Verbal abuse, including using racial, homophobic, transphobic, ableist epithets, etc.
- Non-consensual physical contact, violence, or threatening gestures.
- Displaying material that is offensive, degrading, or threatening to a protected class.
- Consistent demeaning remarks or malicious teasing Stalking or predatory behavior

Covert:

- Spreading rumors or innuendo with malicious intent
- Deliberate exclusion, isolation, or alienation of an individual without just cause
- Using rank, title, or office to intimidate others

Provided that the behavior does not rise to the criteria listed above, bullying and harassment is not:

- Single episodes of social rejection, dislike, tactlessness, or forgetfulness.
- Mutual arguments, disagreements, or fights.
- The termination, mutual or not, of a romantic relationship or friendship.
- Reasonable constructive feedback or critique.

The test for bullying is the reasonableness of the behavior and the impact of that behavior on the recipient. Participants engaging in bullying/harassment are subject to appropriate sanctions. If an individual believes they have been subjected to or have witnessed harassment, bullying, or retaliation, that person should contact a seneschal, the President of the SCA, or that kingdom's Board Ombudsman.



Greetings from your Kingdom Webminister!

Please ensure that your Quarter 2 reports are in on-time. They are due on April 15. Either the



Webminister or Seneschal can fill out the report (or a Guildmaster, an Officer, or Order Clerk, for their respective sites).

If your group, guild, order, or officer site did not have a report filled out for Q1, it is an absolute must for Quarter 2. Else, your Webminister is in jeopardy and your site will no longer be listed on the Kingdom's website. (This is per Kingdom Webminister Policies.)

Second — Kingdom Officers (including deputies, regionals, and so on), ALL Group Seneschals, and Order Clerks — Please check your aethelmearc.org email. Despite the numerous announcements since December 2020, there are still folks who have not been in their account. These accounts do NOT forward by default, and the Webministry is unable to set forwarding for accounts that are allowed to forward. If you need your credentials or a password reset, please email helpdesk@aethelmearc.org.

Lastly — as the new Society Webminister's Handbook is out, there is a definite change that is coming to our policies. Email addresses no longer need to be obfuscated. However, if it is a personal email address (rather than an aethelmearc.org or other "non-personal" email) you must need an email or signed letter on file stating it is okay to use the personal email address on a website.

Lord William FitzWilliam was called to

attend Their Majesties. His long support of the rattan fighting community, and his skill on the field caused Their Majesties to induct him into the Order of the Golden Alce. Scroll by Mei Lan Hua with words by Jehan Leblanc.

Their Majesties having heard of Maestro Filippo de Sancto Martino's skill in the bardic arts called him forward, They felt moved to induct him into Their Order of the Sycamore for his performances. Scroll Illuminated by Caleb Reynolds with Illumination by Ekaterina Volkova.




