- An attached copy of the SIGNED event form
- Consider including details such as directions to the site, merchant information, event activities, site restrictions, and ADA accessibility options.

Events which have not published all of the above information in the Kingdom newsletter are not eligible to have awards, law changes, or other Official Kingdom business conducted at them.

- All submissions must be received by midnight on the 1st of the PREVIOUS month (see the Calendar).
   The deadline does not change for Sundays or holidays. Late submissions may not make it into that month's issue.
- Articles may be reformatted for publication. Please use a single font; do not use tabs or create columns.
- Event Articles should be provided as an attached MS Word, .txt, or Open Office file.





#### Accessing Your Membership (Existing Members)

Please update your bookmarks; the new SCA Member Portal can be accessed at: https://sca.app.neoncrm.com/login

- 1. Once at this site, you will be prompted to log in to your existing account.
- 2. Your Login Name and Password should be the same as the most recent login information you used to access your membership.
- 3. If you have trouble logging in, you can enter your email to reset your password. If that email address exists in our system, you should receive a recovery email shortly.
- 4. If you do not receive an email, please check your spam folder. If you still do not receive an email, there is no account associated with the submitted email address.
- 5. Once you've done this step, you will be prompted to log in every time you visit the site the system can even remember you!

#### Will I lose my membership number?

No. Your SCA membership number is safe and sound; it has been transferred with the rest of your member information to the new system.

Note: If you have been a member previously and wish to retain that number, we will shortly have this functionality. Stay tuned for our next FAQs which will include details on that process.

#### **How Do I Request My Membership Information?**

Once you've logged into the portal:

- Select the Membership Information option on the left navigation bar.
- Enter your name and email in the form.
- $\bullet \ \ \, \text{This will generate an email with your membership number, SCA name, and Kingdom.}$
- As in the old system, each member has their own unique account regardless of membership type. At present, to obtain Membership Information details for Family members, you or the Family member will need to log in to their account directly. Note: This is a temporary process while we further configure the system to provide complete Proof of Membership details for yourself and any Family members. We anticipate this update will be completed by late March.

Membership card production was paused during the system shutdown, but will begin again soon. If you renewed your membership after mid-December 2022 and have not yet received a membership card, rest assured that it is on its way. Feel free to reach out to membership@sca.org with any questions.



# **Kingdom Announcements**

With the Success of the War of the Phoenix, we continue to grow.

Part of that growth includes preserving and updating the awards and traditions that were part of our Estrella War, and we are carrying forward with the War of the Phoenix. The Queen's Oleander Favor celebrates the ladies who join us on the field of combat at the war. While the Star of the Desert is to award those persons who give of their time and effort to make the war happen for the known world.

As such, we have updated the Ceremony and Charter for both as found below.

# Queen's Oleander Favor (Ceremony Re-wording)

Herald:

Atenveldt's Lands are graced with gentle breezes and a blazing sun -- lands that nurture life bearing an inner strength, and astonishing beauty. It is from this Aten soil, that the Desert Oleander grows -- strong, entrancing in color and delicacy, yet bearing stems braced with deadly thorns and a lethal poison.



Like the Oleander, ladies who take the field of combat combine this same gentle beauty with deadly force. Like the desert flower that bears the name Oleander, these combatants enchant their opponents with their grace and beauty, yet bear thorns to cut the flesh and a deadly force to slay their enemies.

It was thus proclaimed long ago, that the first time a lady takes the field as a combatant at Estrella War, they are forged in the Atenveldt Sun and earn the right to wear a favor bearing a desert Oleander. With the War of the Phoenix rising out of the memories of Estrella War, it is thus proclaimed that the tradition shall continue with the War of the Phoenix and ladies who return to do combat on the fields of the War of the Phoenix may then add one Oleander to the favor for each year they fight.

Her Majesty of Atenveldt calls before Her all ladies from all Kingdoms of the Knowne World who fought on the War of the Phoenix battlefields for the first time in heavy weapons or rapier, so they may receive their Oleander favor.

Herald: Three cheers for these Gentle Ladies!!!

# Star of the Desert (Charter Update)

In Anno Societatis XXXVII (37), during the third reign of Their Royal Majesties Aaron and Alessandra was created an award known as the Order of the Star of the Desert. In Anno Societatis LVII (57), during the seventh reign of Their Royal Majesties Craven and Elzbieta, the charter was amended to reflect the change in the name of Atenveldt's kingdom war.



- 1. There shall exist in the Kingdom of Atenveldt an award known as the Order of the Star of the Desert, which may be given by the Crown to individuals who show tireless service helping with the running of the Kingdom's war (i.e. Estrella War, War of the Phoenix).
- 2. This Award shall be given to adults in three levels depending on the years of service for the war the recipient may receive a Gules 1st level, Azure 2nd level, or Argent 3rd and highest level. The level being awarded by the Crown at the time of presentation. This award may be presented to the same individual more than once, but only at a higher level than is currently held by the recipient.
- 3. In addition, there will be two levels for youths. For those youths under 13 years of age may receive the Vert level and for those youths aged 13 to 17 may receive the Sable level of this award.
- 4. The members of this Order shall be styled as Companion of the Order of the Star of the Desert, and be entitled to place the initials (for adults) SDG, SDB, or SDA; and for Youths SDV or SDS after their names.
- 5. The insignia of the order shall be; "Per fess indented azure and argent, in chief four mullets of four points elongated palewise Or and in base a sun in splendor azure", suspended from a ribbon to denote the level as follows:
  - a. Vert (green) youth under 13
  - b. Sable (black) youth 13 17
  - c. Gules (red) 1st level
  - d. Azure (blue) 2nd level
  - e. Argent (white) 3rd level (highest)
- 6. Companions of the Order shall take precedence after armigerous Principality Awards and before armigerous Baronial Awards.
- 7. The Protectors of the order will be the Crown of Atenveldt.
- 8. Amendments to this charter shall be made by the Crown of Atenveldt.
- 9. Membership in the Order of all previous recipients of this award is hereby confirmed.

Done by our hands this 4th day of February Anno Societatis LVII, being 2023 in the common reckoning.


