



#### Ciao Calontir,

As many of you may already know, event insurance has gone up effective May 1, 2023 (Society notification missed the May Mews deadline so this is a little late). It is a significant increase but there are several things to note:

1) This is not the total charge for event insurance. Society covers the larger portion of the costs.

2) There need not be any increase to your group for events. You only need to pay an additional fee if the site you are using requires that they be a named insured on the policy. (This is a piece of paper that you request from Corporate) Being a named insured doesn't increase their coverage and isn't required by our insurance or by society or by kingdom law. I know some groups have requested this out of habit, but it is not always necessary. It saves both the SCA and your event money if you don't request this and the site is still covered. So, unless the site requires it, don't offer it and don't request it. If you are unsure whether your event needs to request this from Corporate let me know.

3) Two types of insurance that have seen an increase AND are required are: Equestrian and Golf Carts. Most of our events don't use golf carts. Only Lilies, as far as I am aware, and that is a recent addition.

More significant to Calontir at this time is the increase for equestrian activities. The equestrian community is looking at ways to help defray the insurance expenses for events that want to offer equestrian activities. If you have an event that offers or would like to offer equestrian activities let me know.

As always, if you need any help, have questions, or need more information, let me know.

If you have any topics that you would like to see addressed in the Seneschals Mews letter let me know. Help finding useful topics to share with the Kingdom are always appreciated. If you want more information about something I'm sure you are not alone. **In servicio dove posso**

#### Are you ready for fireworks?

It's June and that means Lilies and that means fireworks. If you've sat next to me during one of these you'll hear me yell out Calontir, or Outlands, or Ealdormere, or whatever kingdom matches the heraldic colors painting the sky. Find me at Lilies and we can have a veritable chorus of heraldic shouting to add to the fun! Or annoy those around us. I'm not entirely sure.

Let's get to the business side of things. First, I'm expanding our OP Clerk setup to add a deputy. Basically, Blue Hawk enters in all the awards given by Their Majesties into the database so everyone knows who has what. It's not a difficult task, but it takes time almost every week and has no pause for attacks of life, hence the need for a deputy. Qualifications are few, just the ability and energy to enter in various changes consistently. If you're interested in helping out, send me an email at **goldfalcon@calontir.org**.

Also, I'm opening up the position of Lanner Herald. This is a job for those interested in creating fun and cool ceremonies for court. Peerages, baronial investitures, coronations, those sorts of things. There's a database to draw from, but the most important requirements are the interest to research ceremonies and cool things in a large variety of cultures and the skill to dig out fun, interesting nuggets. Again, send me an email if you're interested.

Please send letters of interest for either position by the end of Lilies and we'll schedule interviews to follow soon after.

Now, let's get back to fireworks, or at least, heraldic charges related to the sky.

We are, of course, starting with the heraldic term mullet. Yes, it's a heraldic term, no it doesn't mean a heraldic beast with a business mane in the front and a party mane in the back. Nor was this heraldic term created by the Beastie Boys, but it is fun to think about them blazoning devices.

The mullet in heraldry refers to a star. Of note, mullets are, by definition, stars with five points, but

they can have more or less. A mullet of four has four points, a mullet of six has six points, and so on. A great example of a mullet of six would be the device of Finnvarr de Taahe, who just happens to be the Midrealm king that finally released Calontir's jesses and signed off our kingdom. He actually likes mullets of six so much his device is a mullet of six with mullets of six at each point. Stars upon stars, as you can see here: middlewiki.midrealm.org/index.php/ Finnvarr de Taahe.

By the way, mullet, in this context comes from the late 14th century into Middle English as molet or molette. This derives from Old French molete "rowel of a spur," equivalent to mole "millstone." So, yes, stars in heraldry are etymologically related to millstones. No wonder shields with mullets on them are so heavy!

But of course, there's another star that's relevant to heraldry, and especially relevant to Lilies, the sun. One way we see the sun in heraldry is the term rayonny. This has nothing to do with the fiber, but they are etymologically related. Rayon, the fiber, comes from the French word "rayon" or beam of light.

"Rayonner" is French meaning to spread out, radiate. Hence, rayonny, in heraldry are wavy rays meant to show the sun's light.

You see this anywhere there's an edge. Per pale (remember that one?) rayonny would be a vertical line with wavy rays going out both sides.

Here's a great example of rayonny used as the edge of a chief: calontir.org/persona/4420. Oh, and hey, look Ayisha's heraldry has mullets too! Mullets of eight, even.

How cool is it that one of our patent pending Laurels has exactly the right heraldry for this month's letter? Almost like I planned it.

Except it's me, and I never plan anything. She's just got great, and cool, heraldry.

## EVENT FLYER GUIDELINES

For Their Majesties to hold Court, or any official business to occur, a complete flyer must be published in *The Mews*. Failure to do so means that the Crown can not hold Court at that event.

Before sending an event flyer confirm your event with the Reeve. *The Mews* **WILL NOT** publish an announcement if your event has not been approved or confirmed. Check the Kingdom Calendar at: <u>https://www.calontir.org/</u> <u>events/</u> For information on how to submit a flyer please visit: <u>https://www.calontir.org/chronicler/</u>

For an event to be considered complete and published, so official Kingdom business can be carried out, an event announcement MUST contain these **SIX ITEMS**:

- Dates of the event- day and month
- Event time: when site opens & closes to the populace
- Name of the sponsoring group or groups
- Location of the event. The name of the event site, and full address.
- Name, both SCA and Modern, of the Event Steward, including contact phone and email. (Needed if there an emergency / or issues arise)

• Details of Registration : Do NOT use "FEE" as a describer for registration cost.

Example of wording for Registration: Adult Event Registration: \$25 / Adult Member Discount Registration: \$20 / Youth (6-17) \$5 / Children 5 & Under: FREE

**Event Copies:** An Editable version of your flyer MUST be sent. If you wish to send a PDF, you are more than welcomed. However, I need a version I am able to edit, because sometimes that PDF just will not convert correctly and I would like to keep your flyers looking nice.

**Deadline:** The Chronicler must receive event copies no later than the **1**<sup>st</sup> of the month TWO MONTHS PRIOR to your event. (e.g. if the event is in November, the flyer must be received by September 1st.) If there is an issue with meeting the deadline, please contact the Chronicler ASAP. There is no grace period the deadline is final and non-negotiable. The earlier a flyer is received the better!
