




Welcome to our new Heirs. We look forward to seeing Our Kingdom welcome them with the hospitality and warmth that typifies the people of Trimaris.

Ringbonn Laws

Unto the Populace of the Kingdom of Trimaris:

Their Majesties have submitted proposed amendments to Trimaris Kingdom Law. Pursuant to Kingdom Law the proposed amendments are to be published to the Trimaris.org website for review and commentary.

Quoting Trimaris Kingdom Law Section 16:

- B. Publication for comment and analysis
- 1. The Crown shall submit the proposed amendments in writing and in a commonly used word processing format.
- 2. Amendments shall be submitted to the Kingdom Web Minister for publication on the Kingdom Web Page.
- a) The Crown may, in its sole discretion, direct the Kingdom Web Minister to publish the proposed amendments in other forums in addition to the Kingdom webpage.
- 3. Amendments shall be submitted to the Kingdom Chronicler for publication in the Kingdom newsletter.
- a) In the case of extensive revisions of Kingdom Law (defined as an amendment that requires such space as to make publication in the Kingdom newsletter prohibitive), a notice shall be published in the Kingdom newsletter alerting the populace to proposed changes and directing them to the Kingdom's webpage.
- b) Any member of the SCA residing in the Kingdom of
- Trimaris may request a written copy of the proposed law changes referred to in the notice at the Kingdom's expense.
- (i) Any notice published in the Kingdom newsletter pursuant to this section shall include the following language: "Those members of the Society for Creative Anachronism who wish to do so may contact the Kingdom Chronicler for a paper copy of the proposed law changes, to be mailed at the Kingdom's expense."
- 4. Non-substantive amendments to Kingdom Law to correct typographical errors, renumbering, or that do not substantive change the meaning of the law, need not be published for commentary.
- C. Comment period
- 1. The comment period runs for 30 day from the date Crown submits the amendment for publication to the Kingdom Web Minister and Kingdom Chronicler.
- a) For the purposes of this section, submission to the Kingdom Web Minister is deemed completed upon emailing the amendment to: webminister@trimaris.org.
- b) For the purposes of this section, submission to the Kingdom Chronicler is deemed completed upon emailing the amendment to: chronicler@trimaris.org.
- c) The Crown shall maintain written evidence of the content and date of submission.
- 2. All comments shall be submitted in writing to the Crown via comments@trimaris.org
- a) The Crown may, in its sole discretion, accept written comments via alternative submission methods.
- 3. The Crown, in its sole discretion, may extend the comment period.



#### Position Available – Marshal of the Society (Society Marshal)

The Marshal of the Society's area of authority is all martial and related activities practiced in the Society, both those described by the handbooks approved for the office and proposed as additions to those handbooks (experimental activities). The Marshal will work to encourage the participation of all in the Society's martial activities, and strive to expand and improve those activities for the benefit of the Society and its members.

The duties of the office include:

- Directing the Earl Marshals of the Kingdoms in matters concerning the supervision of martial and related activities at Society events
- Overseeing the manner and conduct of duties of all marshals throughout the Society
- Working to promote and improve the safety of the Society's martial activities
- Working with the Minister of Arts and Sciences to encourage research in armor, weapons, and the practice of historical martial arts

Day-to-day work of the position entails administering the marshallate activities of the Society and coordinating the activities of the Kingdom Earl Marshals, and of all Deputy Society Marshals for the individual disciplines. Reports are required to be filed quarterly to the Board summarizing the martial activities of the Society. The Society Marshal is also responsible for maintaining communications with the Kingdom Earl Marshals. These activities specifically include:

- Warranting (with the Crown) Earl Marshals for twenty kingdoms
- Warranting (with the Board) Deputy Society Marshals for Armored, Rapier, and Youth Combat, Combat Archery, Siege Weapons, Equestrian, Rebated Steel, and Target Archery and Thrown Weapons, and other deputies as needed
- Supporting the Earl Marshals when they have questions, and advising them as necessary
- Resolving disputes among marshals, and between marshals and the Crown
- Serving as the point of appeal for sanctions applied by the Earl Marshals
- Encouraging the expansion of martial activities in the Society by the wise revision of the marshallate's documents and by conducting experiments with new materials and activities

The successful candidate must be well versed in administrative techniques, problem solving, and interpersonal communications. The successful candidate will possess:

- Knowledge of marshallate policy, rules, and procedures
- Knowledge of the traditions of the Society
- Extensive negotiation skills and experience in resolving differences
- The ability to set aside all preferences and biases for the betterment of all
- Patience in the face of emotion, advocacy and provocation
- Expertise in the use of modern communications media, messaging, e-mail and telephone
- The ability and availability to travel as necessary



Event announcements need to be submitted as a standard text listing containing the required information. Announcements should be submitted as early as possible to allow for corrections and more advertising for your event. Announcements must be created following the checklist below. This checklist is intended as an aid in the proper submission of event announcements. All event announcements at which any official business will occur <u>must</u> contain the following information:

- Name event and the sponsoring group.
- Date of the event.
- Event site location including name and address.
- Time the event site opens and closes to the public.
- Registration open and closing times.
- Name (mundane and SCA) mailing address, e-mail address, and telephone number of the Reservation Steward.
- Name (mundane and SCA), e-mail address, and phone number for the Event Steward
- Site registration pricing and payment information.
- OPTIONAL: Description of the event activities.

In order to comply with Kingdom Laws and Policies, unless otherwise stated, the following standard event policies will automatically apply to all events submitted and held within the Kingdom of Trimaris.

- No family shall pay more than the equivalent of three (3) adult site fees. Family is defined as adults and their minor children. This applies to site fees only and does not include feast or cabin space.
- Unless otherwise noted, The site fees for children 12 and under are free.
- The SCA member discount for site registration shall not exceed \$5 per person.
