an event registration form on file with the Kingdom Chronicler.

For an event to be official, the following information must be published  
in the issue of The Acorn of the month the event takes place,

**otherwise the event is declared unofficial**

(i.e., registrations may not be collected, awards cannot be given, etc.):

- **Group Refund Policy**• Spell out your group's refund policy
- **Date of event**• Day, month, and Gregorian year that the event will take place.
- **Group name**• Name of the group hosting the event. Must be an official group.
- **Location and directions**• Name and directions to the legal address of the site.
- **Event Steward**• Event Steward's Society name, a contact phone number with area code, and email address. **Mundane name and address are no longer required.**
- **Registration**• Member & non-Member for event, with deadlines (for pre-registration) as necessary. If there is a Registration for the event, the following statement must be included beneath the \$ amounts: "Make checks payable to SCA, Inc./ (group name)." If the event is free, say so!
- **Activities**• Brief synopsis of event—fighting, arts & sciences, merchants, et cetera.
- **Site Restrictions**—wet or dry, no animals, no smoking, et cetera,
- **Accessibility**—handicap parking & entrance/exit ramps, uneven terrain, et cetera
- **Duration**• Start and stop time of the event.

## KMOL Training Deputy Opening

Hail and well met good Gentles of Atlantia,

The Kingdom Minister of the List would like to announce an opening for one of the Kingdom Deputy positions. Currently we are in need of a Kingdom MOL Training Deputy. Below you will find a description and requirements of the position:

**Position:** Kingdom of Atlantia Minister of the List Training Deputy

**Requirements:** Paid membership and Fully warranted MOL

**Duties:** This position manages the training and review of our MOL-IT program and assists the KMOL in creating and updating the warrants for our new MOLs. The Training Deputy helps review the online material, grades the online tests that our MOLs and MOL-ITs submit for credit and then reports this information to the KMOL. Periodically, they will help the KMOL develop new classes and tests appropriate to the MOL needs. The position requires the person to work with the University staff to either teach or ensure we have a teacher to teach at least one class from the MOL curriculum for each Kingdom University. As a part of the coordination, they will review the class roster and ensure the people who attended will have credit recorded in the warrant database system. This review process also involves updating the class information in the warrant database when other events offer MOL training as well, in order to assist the KMOL in issuing updated or new warrants for our MOLs.

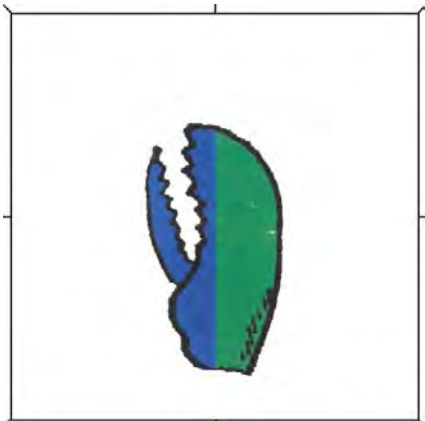

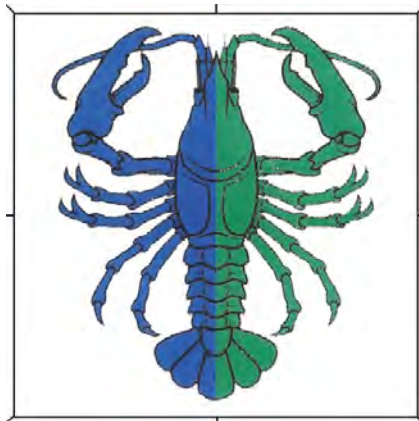

22. **Úlfr Erlendsson** - Resub Badge



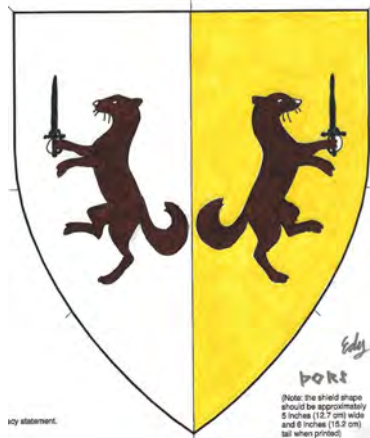
