From the Kingdom Senschal

Hello Sunshines!

I'm delighted by the buzz and interest and conversation around DEIB (Diversity, Equity, Inclusion & Belonging) that has been going on. In the interest of transparency, I just wanted to give

some updates from the behind-the-scenes side of things so you know your concerns are not just disappearing into the Void.

The big thing is that the structure of the Societylevel DEIB Office is changing; not the people, but the

structure of it. SCA Corporate is currently in the process of moving it out from under the Seneschal's office and into being a full Greater Office of its own right. As part of that transition, they are creating training and a handbook and all sorts of other promised goodies. (They are also hoping to do that with the Chatelaines' office, to better support newcomers.)

Because of that, Ealdormere's Crown and Council are holding off on creating official job descriptions

and actively looking for a Kingdom DEIB officer until that structure and those supports are fully in place, as was suggested by the current Society DEIB officer. The hope is that things will be settled into place late this year, or early next year. (Everyone cross fingers for things moving quickly at the Board level).

How does that affect Ealdormere? We already have a unique-to-us position in the Lawspeaker, historically an ombudsman responsible for both interpreting the Kingdom and Society laws to the populace, and also providing an avenue for the populace to bring concerns to, and help with communication between the populace, the Crown and Council. The DEIB Officer will likely need to work closely with the Lawspeaker to determine how best to implement these new structures and policies in a manner that also retains and reflects both Ealdormere's values as a kingdom, and Ontario's own mundane laws (as may be different from the American influences on many other kingdoms).

So, keep talking, keep planning, keep thinking about how to improve our kingdom for everyone as we work our way through the waiting and planning phases of getting the DEIB office off the ground. But mostly, be patient with us! We expect this to be a trial and error process to some extent; we'd like to NOT make it be a trial by fire one!

From the Trillium Principal Herald

Greetings, Ealdormere!

This was originally intended to be my final letter as Trillium, but there are a few loose ends to tie up before you're completely rid of me, so I will save the various thank-yous until next month.

This month's topic: Use of registered Ealdormere heraldry and publicly-available graphics.

There are two issues here. One involves permissions from artists/creators of heraldic graphics (or "emblazons", as we herald-nerds call them), and the other involves use of the heraldry itself.

So: First issue: We have posted on the Kingdom website a number of graphics -- award badges, populace badges, group arms, the wolf template for helm stickers, etc. These graphics have generally been made available by their creators to be used freely by all Ealdormerians. However, there was never an understanding that these graphics (in their unaltered form) could also be used without permission for for-profit or commercial uses (or even for things such as t-shirts) by individuals or groups. Going forward, we will be updating the graphics page to credit each artist, and will be confirming with the artists what types of permissions they grant for usage. Those who wish to use heraldic art for any other purposes will be directed to contact the artist.

This leads to another, related issue. Corpora contains the following policy:

XII. POLICY ON TRADEMARKS The names and armory (devices and badges) of all groups and awards/orders which are registered on the registry of the Society Herald to any SCA Kingdom, Principality or any branch or subgroup thereof, are owned by the SCA. This includes names and armory of guilds and other artisan groups registered with the Society Herald by the SCA or branches thereof, including any other such marks as would be considered "collective marks" designating quality, origin or distinguishing features or goods or services. They may be used or reproduced only upon permission of the Society President or authorized delegate.

For you non policy wonks, what this means is the SCA owns all names and heraldry associated with territorial groups, including badges, and permission must be obtained to use them. Note that in Ealdormere, the "authorized delegate" of the Society President would be the Kingdom Seneschal. This should not impact use by official SCA groups for official SCA websites or by the Crown to give out to members of the populace, for instance. It would not impact display of award badges by those who have received those awards. It would impact, however, individuals who wish to use registered heraldry for commercial/for profit purposes.

Note that this is NOT a ban. It is a requirement to receive permission for use. In some cases this permission should be very straightforward--for instance, merchants who create award medallions provide a valuable service to the SCA, and permission would likely be a rubber stamp.

Why do we have this policy? It helps protect SCA heraldry from use by third party sites, for example, who may not have the organization's best interest at heart, or who might produce inappropriate items that could lead to reputational damage. It gives the legal representative of the kingdom a chance to confirm that the proposed use is in keeping with the SCA's mandate.



So, summary: Want to use heraldic artwork that you did not create? Get permission from the artist. Want to use registered armory for an SCA group (including badges) for other than officially-recognized purposes? Get permission from the Kingdom Seneschal.

I will add one final caveat: Within the SCA (and here, we are talking at events) wearing any territorial group device (the ones with the Laurel wreath) is quite restricted - only the Crown (or Baronage, for a Barony) or a herald acting on their behalf may wear those arms. This is why we have populace badges, which are for use by all.

For Bonne Signe it is to slightly expand its scope, keeping the focus on developing silent heraldry, but adding the possibility of other means of making Court more accessible. If you have any thoughts on either idea, please send them my way.

From the Minister of Arts & Science


Greetings Ealdormere,



SCA Inc Notice

POSITION OPENING: SOCIETY SENESCHAL/VICE PRESIDENT FOR OPERATIONS

The Society for Creative Anachronism (SCA) is seeking candidates for the position of Society Seneschal/Vice President for Operations.



The Society Seneschal is considered both a Society and Corporate officer, and is responsible for coordinating the administration of the Society's historical re-creation. This involves directing the activities of the Kingdom Seneschals and of Society-level deputies. Where questions arise concerning the intent of Corpora, the Board specifically authorizes the Society Seneschal to make interpretations and clarifications. The Society Seneschal is also responsible for reviewing all sanction related activities.

This is a part-time stipend position requiring a minimum of 25 hours per week, often more.

Applicants must possess strong communication skills and be capable of interacting with unique SCA personalities without regard to rank or position in the organization. The ability to process and distill large amounts of information from multiple sources is required. Organizational and problem-solving skills are essential. Having held a Kingdom Seneschal position, while not required, is preferred. Applicants must be capable of maintaining a home office space, have access to internet, PC/tablet, printer, and possess word processing skills. Proficiency with Microsoft Office and Adobe Pro is a plus. Ready access to postal service for the mailing of trackable documents is required.

Required skills or background:

- · Prior experience in positions of leadership within the SCA or in leading volunteer organizations
- · Excellent working knowledge of current SCA corporate documents and handbooks
- · Ability to research issues surrounding kingdom and Society rules and policies
- · Understanding of how the SCA's sanction and investigative procedures work; direct experience with these procedures is preferred
- · Ability to maintain confidentiality of investigations and other confidential material
- · Ability to manage multiple projects and oversee volunteers on both Society and Kingdom levels
- Excellent communication skills, both written and oral
- · The ability and willingness to communicate via email, phone, and videoconferencing on a regular basis
- · Ability to explain policies, delegate projects, and build consensus

The Society Seneschal is responsible for the following duties:

· Oversee directly and indirectly the planning and implementation of all "game side" activities.

• Deal with large amounts of correspondence with many individuals, including but not limited to all kingdom seneschals, royalty, and corporate/Society level officers, especially the President, VP for Corporate Operations, and Executive Assistant to the Board of Directors.

 \cdot Meet via videoconference and/or phone with kingdom seneschals, Directors, and other corporate and Society officers several times a month.

· Provide training and advice to kingdom seneschals on a regular basis.

- · Present sanction packets to the Board and provide oversight of investigations related to possible sanctions.
- Interpret Corpora and other SCA policies as needed; revise policies and create new policies as needed to facilitate SCA activities.

Evaluate and create documentation as needed to facilitate a positive experience for SCA participants.
 Quarterly review of all Kingdom Seneschal reports, respond to reports, and refer Kingdom Seneschal requests or questions to the appropriate Society or Corporate officer for assistance as needed.

· Submit detailed quarterly reports to the President and Board, and supplemental reports as needed.

- · Attend all quarterly meetings of the Board of Directors, mid-quarter conference call meetings, and other meetings as required.
- · Other duties and projects may be assigned by the Board or President.

The Society Seneschal must be available for the four quarterly Board meetings, typically held over a Friday and Saturday or a Saturday and Sunday. These meetings may be held via videoconference or in person. In-person meetings require travel, typically on a Thursday and Sunday. In addition, the Society Seneschal must be available for conference call meetings of the Board four to twelve times a year, typically on weekday evenings, and meetings or calls with officers or directors on an as-needed basis. Additional travel besides the quarterly meetings may be required, typically around SCA events.


