Kingdom of Atlantia Air Quality Guidance for Marshals

June 29, 2023

This Guidance is the work product of the Kingdom of Atlantia. It shall not be altered, modified, or changed without the permission of the Kingdom of Atlantia Earl Marshal.

This Guidance may be published, distributed, or reprinted in an unaltered format.

A. Purpose and Applicability

This Guidance serves as a resource for Marshals conducting martial Events and Activities where poor Air Quality may pose a risk for certain participants. This Guidance does not create new Kingdom Law, nor should it be considered mandatory. It is a tool for the Marshallate to utilize to make informed decisions on whether to continue, modify, suspend, or terminate certain martial activity due to poor air quality due to air pollutants. This Guidance applies to all adult armored rattan, armored rebated steel, rapier (including cut and thrust), thrown weapons, target archery, siege, and equestrian (rider only) and Youth martial participants at Events and Activities. It does not apply to non-combat participants.

Note: An "Event" is a registered official event on the Atlantia Kingdom Calendar. An "Activity" is an arts & sciences (A&S), business meeting, marshalled practices, etc. announced via any local official SCA medium whether Facebook, elist or newsletter. The terms Autocrat, Marshal, Martial in Charge (MIC), Marshallate, Earl Marshal and Deputies, and Minister/Mistress of the List (MOL) have the meanings contained in the Kingdom Governing Documents.

Risks Related to Ground Level Ozone

Ground-level ozone (O3) is a product of nitrogen oxides (NOx) and volatile organic compounds (VOCs) in the presence of heat and sunlight. Motor vehicle exhaust, industrial emissions, gasoline vapors, and chemical solvents are among the major sources of NOx and VOCs responsible for harmful buildup of ground-level ozone. Even at low concentrations, ozone can trigger a variety of health problems such as lung irritation and inflammation, asthma attacks, wheezing, coughing, and increased susceptibility to respiratory illnesses.

Risks Related to Particulate Matter

Particulate matter (PM), or airborne particles, includes dust, dirt, soot, and smoke. Some particles are directly emitted into the air by cars, trucks, buses factories, construction sites and wood burning to name a few examples. Other particles are formed in the air when gases from burning fuels react with sunlight and water vapor. Such gases, from incomplete combustion in motor vehicles, at power plants and in other industrial processes, contribute indirectly to particulate pollution. This pollution can cause chronic bronchitis, asthma attacks, decreased lung function, coughing, painful breathing, cardiac problems, and heart attacks, as well as a variety of serious environmental impacts such as acidification of lakes and streams and nutrient depletion in soils and water bodies. (US National weather Service)

B. Planning and Set-Up

When martial Events or Activities are planned during times of the year likely to experience poor air quality, the Marshallate can use the following guidance to mitigate risk. As always, individual participants should use their own judgment, considering their personal health and fitness when considering whether to participate in a given activity.

1. Weather Review

EPA has established national air quality standards to protect public health. Ground level ozone and airborne particles are the two pollutants that pose the greatest threat to human health in this country. (US National Weather Service)

E. Use of Indoor Spaces

 Activities held indoors in air conditioned or air filtered spaces are not affected by outdoor AOI

2. Site Planning

- Work with Autocrats so that contingencies are planned and are communicated in the formal Event/ Activity announcement.
- If the Event/Activity schedule must be changed prior to the Event/Activity start time, engage the Autocrat to notify participants of changes through all available official communications channels.

D. Recommendations for Martial Activities

Green and Yellow – No change to outside activities.

Orange – Sensitive group should be aware of concerns and the effects of AQI.

Red - Treat like high heat levels, limited duration activates, and longer breaks. Sensitive groups should not participate. Purple and Maroon - NO outdoor martial activities.

Atlantía Kingdom Law Changes by King Afshin and Queen Yasmin

On June 25, 2023, Their Royal Majesties of Atlantia, King Afshin and Queen Yasmin held a Curia Regis to discuss Their proposed changes to law. They appreciate all who were in attendance and who gave their counsel regarding the proposed changes. All counsel and questions were listened to carefully and considered.

The proposed changes are being enacted into law as they were proposed, with one minor change. The new awards were originally proposed as "The Order Of..." and are being changed to "The Award Of...".

Here follows the listed of accepted changes to Kingdom Law. The Clerk of Law has made these changes and the new Great Book of Laws is now available on the Kingdom website. These laws are in effect as of July 1, 2023.

- 5.1.3 The University Chancellor Officer of State application and changeover process shall be as follows:
 - Eight months prior to the end of the current term of the Current University Chancellor, advertisement of the open position (s), University Chancellor and Deputy University Chancellor shall be published by the Kingdom Minister of Arts and Sciences.
 - The application period will be available for at least 30 days and no more than 60 days.
 - Applications shall be sent to the Crowns, the Crown Heirs, the Kingdom minister of Arts and Sciences, and the current University Chancellor.
 - •The Crown Heirs, with consultation from the Crown, the current University Chancellor, and the Kingdom Minister of Arts and Sciences, will select and announce the next University Chancellor and Deputy University Chancellor no less than 6 months from the position changeover
 - •The chosen candidates (Primary and Deputy) will then immediately join University staff as a Deputy to the KMOAS as Chancellor-Select and Deputy Chancellor-Select, training with the University Chancellor until the changeover date.

Writing in the cover letter for the July 2018 LoAR, Wreath noted: "Extant examples of stone Celtic crosses have three things in common: wide arms which are straight or slightly tapered, with couped ends; semi-circular cutouts at each of the four angles at which the arms meet in the center; and an annulet that is thinner than the arms, centered on the central axes of the cross, with all four arms of the cross extending beyond the annulet. Artifacts following this pattern are found in both Latinate and equal-armed varieties. This form of Celtic cross will continue to be registerable. Crosses that do not have these three features are not Celtic crosses, and must be documented and defined separately.: In the current example, the arms are not really wide and the annulet is clearly of the same width as the arms which means that this must either be redrawn to match a canonical "Celtic cross" such as the example from the online Pictorial Dictionary (http://mistholme.com/dictionary/cross-celtic/) which appears as the first image below or must be defined and documented separately.
- 2. The cross used closely resembled the Cross of Coldharbour, which is a disallowed charge. It was previously ruled unregisterable in the SCA in the January 2010 return of Sadb ingen Chonchobair's device, Argent, on a catamount rampant vert a straight-armed Latinate Celtic cross argent on the ground that the Celtic cross as so drawn is undocumentable; we now rule that this rendering of the Celtic cross, both couped and throughout (the latter also being known as a Cross of Coldharbour) is also offensive and unregisterable in any format regardless of documentation." I'm afraid that the cross throughout depicted on this emblazon to me clearly must be judged as offensive under this precedent which covers both crosses couped and throughout. Not only does it have that "gunsight" appearance but also closely matches the "Cross of Coldharbour" mentioned in the ruling as that was depicted in the online Pictorial Dictionary (http://mistholme.com/dictionary/cross-coldharbour/).
- 3. If the charge maintained by the satyr were allowable under current charge group theory, it is functionally invisible on the vert field..
- 4. The satyr is "barely overall".
- 5. The Satyr skin tone must be specified using the defined propers for human skin tones now in use. (See the Glossary of Terms for the correct terminology for each category of skin tone.)




