### Their Royal Highnesses

Greetings unto the populace of Northshield!

Summer is in full swing and that means War Season! We feel it is important for all of us to show our support to Their Royal Majesties in any way possible during this season. We hope all of Our combatants do their best to fight and have fun on the field of battle. For those who choose to support their Crown through arts (like dance!) or through service, please know We see you and greatly appreciate the contributions you bring to our multifaceted and inclusive community. The magic of the SCA does not happen without you all! Stay hydrated, recognize when your body is telling you to take a break, and remember to wear your sunscreen!

Please note that this month Her Highness, Isabella, will be supporting Their Royal Majesties at Pennsic War and She looks forward to joining the Archery Corps with her beloved crossbow, Mirabelle. Mirabelle will also make her appearance at Crispin's Archery Thing and hopes to see other crossbows there as well! His Highness, Yngvar, will be attending Poor Man's Pennsic and looks forward to seeing how the Northshield Army shines!

Speaking of fighting, it has come to Our attention that there may be a need in the future to choose our own heirs. Because We feel it is better for all to have as much time to prepare as possible, below is Our Crown Tournament Format.

Fall Crown list will allow any weapons other than spear or other melee-specific weapons. Each bout will be "bring your best". Each bout will be one fight (rather than best two out of three). The format will be as follows:

There will first be a round robin tourney. If there are more than nine fighters, there will be pools for the round robin tournament. These pools will be randomly seeded by draw and will each contain as close to the same number of combatants as possible. The number of pools will be determined by the number of entrants, so that no pool contains more than nine fighters. If there is one round robin pool, the top four entrants will be selected to proceed, otherwise, the top two entrants out of each pool will be selected to proceed. Please note that ties in the top of the pool(s) will be broken by one additional match between tied combatants, and mutually destructive fights will be refought throughout the pool(s).

The top entrants selected from the round robin tourney will then fight in a double elimination tournament to determine the victor of the day. If the number of entrants in the final double elimination tourney is not a standard number for double eliminations (ex. 4, 8, 16), byes or challenge-ins will be used as deemed appropriate by the Minister of the List.

In addition to the requirements in kingdom law (listed below), We require that each combatant and consort demonstrate some previous service to kingdom or local group. This could be anything from holding office to helping at an event. Also, each must submit their current heraldry (if they have personal heraldry) with their letters of intent.

Per Kingdom Law III-900:

All prospective combatants and their consorts must meet the minimum criteria in the Governing Documents, as well as the following requirements:

1. Each must have been a subject of Northshield for one year immediately before the Crown Tournament.

2. Each must be a member of the Society for Creative Anachronism and have access to the *Northwatch*.

3. All prospective combatants and their consorts must be acceptable to the Presiding Royalty.

4. No one under 18 years old may fight or be fought for in a Crown Tournament.

5. No member of the Royalty may either fight or be fought for in a Crown Tournament.

6. One member of the couple must also affirm that they can and will maintain the ability to legally cross the U.S./Canadian international border for the duration of their reign, should they be victorious, to ensure that they are free to travel to all parts of the Kingdom.

This means that any who fight in Crown must have one member of the pair that can cross the international border legally. This includes but is not limited to them being vaccinated per the mundane laws in place and not having a felony, OWI, DWI, etc.

7. All prospective combatants must hold a valid Northshield Armored Combat authorization card. If the combatant does not hold all authorizations that will be used in the tournament, the Crown has the sole discretion as to how and whether they will allow that combatant to participate.

By choosing to fight in Crown they have agreed to these terms and attested that they do indeed meet all the requirements and that at least one of them can legally cross the border to the best of their knowledge and belief.

#### Greetings, kinsfolk!

My office has been very quiet, which is a good thing.

Those reading closely will note that I did not get the survey out last month regarding exchequer education. I plan to do so soon, hopefully before this is published. I and my deputies want to help train and educate, and we want to get feedback from the people who need it, so that we can be more effective. Thanks in advance for your thoughtful responses.

While I have a year in office yet, I would like to relieve Bayard of his position as Emergency Deputy Exchequer and install someone who is interested in serving as Kingdom Exchequer. Interested gentles would serve as Emergency Deputy Exchequer, a position that does not have any official duties other than to be copied on Kingdom Exchequer emails and generally be prepared to step into the Kingdom Exchequer office in case of emergency. Please contact me if you are at all interested or have any questions.

The requirements of the role are as follows.

The Emergency Deputy Exchequer is a Deputy to the Chancellor of the Exchequer; is responsible for directly assisting the Chancellor of the Exchequer with all aspects of their position; and has the ability and willingness to take over the position in case of an emergency which would prevent the Chancellor of the Exchequer from performing in this capacity.

Chancellor of the Exchequer duties include, but are not limited to, financial oversight of the Kingdom and its assets; ensuring compliance to Financial Policies; reporting compliance for all Kingdom Branches; compilation of reports for all the Branches and the Kingdom accounts; and maintaining and updating Kingdom Financial Policy (in accordance with Society Financial Policy) and Kingdom Budgets. These duties also include delivering and meeting deadlines for the following:

- Ensure that all necessary steps are completed to become a signatory on all Kingdom bank and investment accounts.
- Ensure that they have online access to all banking and investment accounts, Chancellor of the Exchequer files in the Kingdom online records storage system (currently SharePoint), and the Kingdom bookkeeping system (currently QuickBooks).
- Ensure that they are familiar with Financial Policies, reporting requirements and processes, and any Exchequer responsibilities defined by Kingdom Law.
- Complete any appropriate training offered by the Society Exchequer and/or the Society Treasurer.
- Read emails sent to the email address associated with the office on the Kingdom webpage on a regular basis;

and respond to all requests in a timely manner.

#### Time Commitments


Workload will vary but expect to put in an average of 2 hours a week. Meeting travel is not required for this position.

Greetings unto the populace of Northshield,

I continue to be impressed by the few local newsletters Northshield still has. I had the pleasure of nominating three of the newsletters for William Blackfox Awards, the Society's publications awards. The winners should announced this winter.

We continue to have an number of open positions in the Chronicler's office:

Kingdom Chronicler: The office is officially open for letters of intent, for my successor to step up then. As a Great Office of State, the office has a voice and the responsibilities of being a member of the Stallari Council. It is largely an administrative position, overseeing the more specialized deputies and making sure those positions are filled. While experience as a chronicler, webminister, and/ or social media officer can be helpful, it is not required. If you have questions about the Kingdom Chronicler position, or would like to be a Deputy Kingdom Chronicler, to get a feel for the office, please contact me. Please submit letters of intent to chronicler@ northshield.org by September 1, 2023.

**Emergency Deputy Kingdom Chronicler**: This deputy should be ready to assume the duties of Kingdom Chronicler should the current officer be unable to perform the duties, and to assist in any other projects the Kingdom Chronicler may ask. Open until filled.

Kingdom Archivist/ Historian: They will maintain the archive of local group newsletters and other important items from Northhsield history. Open until filled.

Media Relations Deputy: This deputy serves as a liaison between Northshield and modern media outlets, and as a resource for local groups when dealing with media outlets. Open until filled.

**Deputy** Northwatch Editor: They assist the Northwatch editor as needed. Open until filled.

Western, Central, and Eastern Regional Deputy Social Media Officers (SMO): Deputy SMOs act as a resource for local SMOs in their region and assist Kingdom SMO with oversight. Open until filled.

#### DRAFT PROPOSAL FOR COMMENTARY – INVESTMENT AUTHORITY DELEGATION

CORPORATE POLICY XIX. DELEGATION OF INVESTMENT AUTHORITY POLICY

The Board of Directors is currently considering the following addition to the SCA's Corporate Policy:

#### XIX. Delegation of Investment Authority Policy

The Board shall ensure that fiduciary responsibilities concerning the proper management of SCA, Inc.'s institutional funds are fulfilled through appropriate investment structure, internal and external management, and portfolio performance consistent with all policies and procedures. Based on the advice and recommendations of the Treasurer and its external fund manager(s), the Board shall approve investment policies and objectives that reflect the long-term investment-risk orientation appropriate to the organization. The Board may, at its sole discretion, create or eliminate committee(s) to advise the Board in furthering its duties and may select, appoint, and remove members thereto.

The Board hereby delegates supervisory responsibility for the management of its invested funds to the Corporate Treasurer, subject to the financial limitations specified in Corpora, as noted below:

- determine that institutional funds are prudently and effectively managed with the assistance of management and any necessary investment consultants and/or other outside professionals, if any.
- recommend the retention and/or dismissal of investment consultants and/or other outside professionals
- receive and review reports from management, investment consultants and/ or other outside professionals, if any
- periodically meet with management, investment consultants and/or other outside professionals management, investment consultants and/or other outside professionals
- report to the Board (as needed) whether this policy, investment activities, risk management controls and processes continue to be consistent with meeting the goals and objectives set for the management of institutional funds
