

Call for Applications for Lawspeaker

Meisterin Siglinde has indicated that her time as Lawspeaker is nearing its end. If you think this is something you'd like to do, or find out more about what being Lawspeaker entails, feel free to reach out to Siglinde at ealdormere.lawspeaker@gmail.com

Lawspeaker Selection Process and Timeline:

- 1. The Lawspeaker selection process will be published for two cycles of the Tidings, and the deadline for nominations is 28 February 2024.
- 2. To be nominated to be Lawspeaker must be nominated by 12 armigerous subjects of Ealdormere. Those nominated must be confirmed as per Kingdom Law.
- 3. Please forward nominations to the attention of the Kingdom Seneschal. Please send nominations electronically to ealdormere.kseneschal@gmail.com Any nominations received after 11:59PM on 28 February 2024 will not be taken into consideration.
- 4. Confirmed nominees names will appear in the February Tidings.
- 5. Should there be more than one nominee, there will be a vote by the Seneschals of the Kingdom. The list of names shall be brought forward by the local Seneschals to discuss amongst the membership and the Seneschal will vote on behalf of their membership. They will act as a representative of their group.
- 6. Should there be only one nominee, there shall be a vote of confidence. The name shall be brought forward by the local Seneschals to discuss amongst the membership and the Seneschal will vote on behalf of their membership which shall reflect the confidence of their branch in the nominee. The nominee must receive no less than a 50% vote of confidence. If a 50% vote of confidence is not met, the process will begin again.
- 7. Voting by the Seneschals will open on 1 March 2024 and close at 11:59PM on 25 March 2024.
- 8. Results will be discussed with the Royal Family and then shared with the Candidate. The outgoing Lawspeaker will then publicize the successful candidate to the populace.
- 9. The Office is anticipated to change over in April/May 2024.

Lawspeaker Continued

Please consider the importance of this position within the Kingdom. All nominees must be ready for the burden of the office.

ARTICLE IX – Lawspeaker of Ealdormere

IX-100 The Lawspeaker shall be an experienced member of the Society who commands the respect of the subjects of Ealdormere. This person shall possess the capacity to mediate, arbitrate and provide counsel. The Lawspeaker will act as a mediator and ombudsman and as a councilor to the Crown. The Lawspeaker will stand as a deputy to the Kingdom Seneschal and will be appointed, and removed from office, as detailed in these Laws.

IX-101 Due to the nature of the work required of the Lawspeaker, the position of Lawspeaker will be a warranted deputy of the Kingdom Seneschal, for the purposes of Legal and Insurance coverage. This warrant is to be enacted by the Crown, and Kingdom Seneschal when the Lawspeaker takes office, to be renewed for the entire term of office of the Lawspeaker. The only process by which this warrant can be revoked is outlined in section IX-600. It is hereby noted that while the Lawspeaker is a warranted deputy of the Kingdom Seneschal, the Lawspeaker is not a Seneschal and does not report to the Kingdom Seneschal, nor does the Kingdom Seneschal have any influence on the Office of Lawspeaker. The Lawspeaker stands outside the formal reporting structure of the Kingdom, the better to act as a mediator, ombudsman and councilor to the Crown and people of Ealdormere.

IX-200 No Sovereign, Consort, Heir to the Crown, Territorial Baron or Baroness, Kingdom Officer or member of the Seneschalate may be nominated for the position of Lawspeaker.

IX-300 The Lawspeaker will be selected in the following manner:

IX-301 Nominations for the position will be solicited in the Kingdom newsletter and submitted in writing to the Seneschal.

IX-302 Those people who receive nominations from 12 armigerous subjects of Ealdormere and are confirmed by either the outgoing Lawspeaker, the Sovereign, the Consort, the Crown Princess, or the Crown Prince will be approached privately by the Seneschal and asked if they accept the nomination. Upon acceptance of the nomination, that person shall be declared a candidate for the position.

IX-303 If there is only one nominee, the Kingdom Seneschal shall call for a vote of confidence. All warranted branch Seneschals of Ealdormere shall be allowed one vote that shall reflect the confidence of their branch in the nominee. The nominee must receive no less than a 50% vote of confidence. If a 50% vote of confidence is not met, the process will begin again.

IX-304 In the event there are two or more candidates, the Kingdom Seneschal shall call an election and the names of the candidates shall be made public.

- (i) The Kingdom Seneschal shall oversee and conduct the election.
- (ii) All warranted branch Seneschals of Ealdormere shall be allowed one vote that shall reflect the wishes of their branch.
- (iii) The candidate receiving the most votes shall be declared Lawspeaker.

 The term of office for the Lawspeaker shall be three years. The outgoing

Lawspeaker may be considered an eligible candidate assuming he or she receives the required nominations and is confirmed by the Sovereign, Consort, Crown Prince, or Crown Princess.

Lawspeaker Continued

IX-500 In the event the Lawspeaker is unable to fulfill his/her duties; he/she shall appoint an interim replacement subject to ratification by the Crown. The Crown may choose to allow the interim replacement to act for a stated period of time. At the end of this period, the Lawspeaker may resume their duties. The period of absence shall be included as part of the Lawspeaker's term in office. Or the Crown may choose to ask the Kingdom Seneschal to proceed with the selection process upon ratification of the interim replacement. The selection procedure as outlined in IX-300 shall be initiated immediately.

IX-600 In the event that the people of Ealdormere are dissatisfied with the performance of the Lawspeaker, a removal process may be initiated. A petition signed by 30% of the warranted branch seneschals of Ealdormere will be cause for the Kingdom Seneschal to call for a vote of confidence in the Lawspeaker. All warranted branch seneschals of Ealdormere will participate in this vote. The Kingdom Seneschal will initiate the selection procedure to select a new Lawspeaker only if directed to do so by a majority vote of the seneschals.

IX-700 Due to the nature of the position and the selection process, the Lawspeaker may not fight or be fought for in Crown Tournament.

IX-800 Duties of the Lawspeaker

IX-801 The Moot – In consultation with the Crown, the Lawspeaker shall ensure that a Moot is called at least once per reign.

- (i) The Lawspeaker shall ensure that the time and location of the Moot are published in advance in the Kingdom newsletter.
- (ii) The Lawspeaker shall ensure that one section of Kingdom Law is read at the beginning of each Moot so that the people may be familiar with their Laws.
- (iii) The Lawspeaker shall chair the Moot and ensure that records are maintained and published.

IX-802 The Lawspeaker shall investigate concerns brought before him/her and mediate disputes as required. In the event of a conflict of interest, the Lawspeaker may appoint a mutually acceptable mediator in his/her stead.

IX-803 The Lawspeaker shall administer and chair Courts of Inquiry following the guidelines detailed in the Kingdom Operating Policy, Section Four – Courts of Justice.

There will be Moot at Tournoi de Glace on February 3 2024, currently scheduled for 10 am.

Future Possibilities For The SCA By Rua Lupa

Morikawa Rei had written a quality thought piece on the SCA (Society for Creative Anachronism) being an aging social organisation struggling with recruitment and retention, called "Why the SCA has a Recruitment Problem" published on November 11th 12023 Holocene Era (2023 Current Era).

Most things were familiar topics that have been discussed thoroughly in many places that covered the issues better than I could or am willing to do here.

But some things, while similar in familiarity, had hit differently than before. They made a connection that felt like kindling on what brings out the best of the SCA.

I have been a member of the SCA since age 27 in 12014 HE (2014 CE), so for near a decade at this point. For that entire time having lived far from major population centers in Ontario, Canada and thus SCA events in the Kingdom of Ealdormere. The typical driving time to any event being approximately 7+ hours. Pre Pandemic we attended about 5 events a year, 4 of those multi-day camping events to justify the travel. Most of the year the SCA for me is online, working in book heraldry, the 'SCA Celts / Early Period Cultures (600BCE-500CE)' Facebook group, running the 'Ancient Celts SCA' Pinterest Page, and doing SCA inspired crafting at home to use at the next event. I have genuinely had a great experience for my circumstances.

I believe that positive experience was because a lot of what is suggested in Morikawa Rei's piece was already being done in Ealdormere. There are events that are historically themed and immersive, most conversations I have pertains to a historic subject, the Arts and Science is very alive and welcoming with periodic group experiments / projects beyond just classes and competitions, the Kingdom website is very well managed, are doing a lot of work reaching out to recruit, on being welcoming to new attendees, and retaining new members.

That said, no group is free from problems, but that does not mean we should not try to address them and always work to improve. Most everything mentioned by Morikawa Rei is worth taking into consideration and mulled over with discussion with members no matter how successful your area appears to be. Different perspectives and experiences need to be found to avoid bias.

What is the SCA really about?

The SCA is to many members primarily a martial club, especially since the society decides who the royalty is from a heavy combat tournament. This has led to a slim category of people representing all of the SCA – older fighting men. Primarily because of time and resources to equip and train to even reach the potential to enter. Ealdormere has slightly bucked this trend by having a Queen by Right of Arms – Queen Kayla in Anno Societas 54 / 12019 Holocene Era (2019 Current Era), having been only the second to have done so in all of the SCA. The first was Queen Rowan of Ansteorra, in AS 25 / 11990 HE (1990 CE).

With this as the main feature and function of SCA importance, it is not all that surprising that the society struggles to attract young people. Then consider how the SCA is not the only organisation that offers historical combat. HEMA (Historical European Martial Arts). An organisation that is successfully attracting young and diverse people.

Compared to HEMA, the SCA fighting system certainly looks like it is falling behind with the tech available for more immersive kit and access. If the SCA wants to make any headway in changing the heavy combat demographics, rattan needs to be re-examined as possibly being a legacy burden. And if the SCA wants to in general attract younger and more diverse people, that it mostly revolves around martial heavy combat should in itself be reconsidered as there already is a lot of history based martial arts organisations. The SCA simply cannot compete in that sphere, and probably should not.

Letter to Editor con't

This is where Morikawa Rei's piece hit home for me,

"What we really don't have competition for is a pre-1600s re-enactment group. We're pretty much the only one in America, and certainly the largest with the biggest swath of cultures and times. I personally think this is a much greater, and far more interesting aspect of our identity than any one type of fighting or discipline. I think we should own this particular aspect and really double down on it; I think committing to more immersive events would only enhance all the other things we do"..." I hope in the future, we can have more events that are not just Fighting+, but Immersive History+." - Morikawa Rei

What appealed most to me and compelled me to join the SCA was Experimental Archaeology and Historically Inspired Craft. Things that I could apply to my modern "mundane" life. Most of my fun moments are immersive events and activities. Often just walking by a space where I get invited to join in doing a historical thing – no previous skill or equipment required! And that keeps me coming back. It is a niche the SCA could definitely expand on and emphasize more if not realigning to make that central. While we're at it, we can relax a bit on accuracy expectations and highlight Historic Inspiration – being a game For Creative Anachronism.

Instead of major events themed on activities for peerage tracks (a Fighter event or Arts and Science event, or some combination), have the major events be about a Historical Activity being Recreated,

- Seasonal Festivals
- Traditional Communal Projects
- Historical Daily Life Activity
- Feasts themed on different periods and cultures
- Different Historical Court Structures:
 - A Thing / Folkmoot
 - Ard Ri Court
 - High Medieval Court
 - Mongolian Empire Court
 - Roman Republic Senate, etc.

We could learn a lot from Renaissance Fairs where the SCA would be the Educational sibling. Think pre1600 open air museums with Renfair level interactive engagement. Where learning can be really fun and immersive, and everyone is able to play to the full extent of the game, not just those with the means. Where awards and Peerage tracks are bonus side quests, not a primary function or goal.

SCA ROYALITY

Morikawa Rei mentions "pre 1600s forms of egalitarian government" that could work for updating the SCA system.


I am all in favour of updating the governing system to be more balanced in representation as has often been discussed for some time already. Let us consider what the SCA governing system could look like if realigned to be 'Immersive History+'

Maybe instead of the New Rulers choosen solely from a martial tournament and them choosing the historical theme – make the historical theme be what the potential Rulers compete to represent.

The populace could submit periods of interest, and then vote on what an up coming year should be themed. Potential Royals then compete via showcasing the breadth and depth of their knowledge and skills in that time and place of the theme, and how they could apply that knowledge and skill to making that year's events as immersive as possible for everyone. The population could view their submissions in person or online and then vote for who they think would represent that historical time period best.


