



Laurel is the principal heraldic officer of the Society and the head of the College of Arms, and is responsible for fostering the study and practice of heraldry, supervising the processing of submissions, and overseeing the heraldic activities of the Known World.

Laurel is an unpaid position, currently requiring approximately 20 hours a week. The position requires considerable tact and patience, armory and onomastic knowledge, supervisory ability, the ability to work within tight deadlines and coordinate closely with Wreath, Pelican, and other staff to produce a Laurel Letter of Acceptance and Return monthly, computer literacy and word processing skills, reliable e-mail and telephone access, and time and ability to travel.

#### Greetings,

My term of office as rapier marshal for Wyvernwoode is coming to a close, so I'm beginning the search for a Deputy, ideally to take over at the end of the year.

The rapier Marshal reports currently to both the Armored Marshal for Wyvernwoode and the Kingdom Rapier Marshal. The Rapier Marshal is responsible for rapier activities in the Barony of Wyvernwoode and the administrative activities relating to the office. This includes but is not limited to:

- Scheduling and running Baronial rapier practice, currently held on Sundays from 10AM-noon at MacFarlane Park in Tampa.
  - Distribution and processing of waiver forms during practice as needed.
- Maintaining the rapier portion of the Baronial calendar.
  - Practice places and times are at the Marshal's discretion, and may be moved if needed or desired.
- Maintain, transport, and facilitate use of the Baronial loaner rapier armor.
  - This currently comprises one large duffel bag.
- Report as requested to the Baronial Armored Combat Marshal, and submit quarterly reports to the Kingdom Rapier Marshal.
- Read and respond to the office's email address.
- Prepare and submit an annual budget to the Baronial Exchequer, as well as any needed reimbursement requests.

Access to an internet-capable device is necessary for responding to email and filing reports. Promotion of practice is primarily through social media, so Facebook and Discord presence is encouraged though not required.

The Baronial Rapier Marshal is not a member of the Baronial Financial Committee and does not exercise a vote in financial meetings.

Outside of practice, the position generally requires about an hour a week.


