### **Blackstone Raid**

Court of Andreas and Kallista April 22nd, AS 57

Here begins the report of the Court of Andreas and Kallista at Blackstone Raids in the Barony of Blackstone Mountain April 22, 2023, jorundr hinn rotinn Silver Buccle Herald reporting, Sumayya al Ghaziyah Ætherial Herald.

In the morning on the battlefield.

Their Majesties called THLord Lothar Hügelman. They spoke of his prowess on the field and his hospitality. They called for the Order of Chivalry and issued him a writ to contemplate entry into that order. Scrolls by Kieran MacRae and Forveleth Dunde.

In evening court, joined by Their Excellencies of Blackstone Mountain with the assistance of Gwendolyn the Graceful, Salvadore de la Torres, and Arias Beltran del Valle Sigil of Æthelmearc Herald.

Their Majesties invited His Highness Louis of the Middle to join Them.

Their Majesties called for the youth of the Kingdom and set them off after the Kingdom toy chest.

Their Majesties called for the newcomers to the Society to join Them, and presented them with mugs in welcome.

Their Majesties summoned Baroness Adelyn Idesbourne. Her growing skill with tablet weaving has impressed Their Majesties, and so They inducted her into the Order of the Sycamore. Scroll by Juliana Delamere.

Lord Rikardr in blakki Bjarn was called before Their Majesties His skill as a thrower keeps growing, so Their Majesties made him a Companion of the Golden Alce. Scroll illuminated by Juliana Stafford with calligraphy by Jon Blaecstan.

Their Majesties called for Anjuli de Foljambe. She moved into Blackstone Mountain and quickly became a driving force in the arts and sciences community. For Their Majesties inducted her into the Order of the Keystone. Scroll by Kathryn MacLuing.

Their Majesties called for Baroness Sybilla Detwyller. Sybilla creates beautiful Viking garb for herself and her husband, she captures the most minute details and they always look the part, so Their Majesties inducted her into the Order of the Golden Mirror. Scroll by Kolfina Jodisdottir with words by Po Silvertop.

Their Majesties called for Lady Róis inghean uí Dhubhshláine. She always exudes kindness and a we got this attitude that lifts the spirits of those around her, so Their Majesties inducted her into the Order of the Cornelian. Scroll by Robaird Michael Patrick Timothy James O'Suilleabhainn.

Their Majesties called for Rannveig Hrajshvelgsneys. Her skill with sewing and costuming has been heard of around the Kingdom. So Their Majesties inducted her into the Order of the Fleur d'Æthelmearc. Scroll by Gesa von Wellenstein with words by Caleb Reynolds.

Their Majesties called for Baroness Kara Ivarsdottir. She always pitches in to help out, often being noted completing tasks that need to happen just as those around her are realizing they should be done. This service has caught the eyes of the Kingdom and Their Majesties inducted her into Their Order of the Millrind. Scroll by Briary Rose with words by Cormac.

Their Majesties called for Count Andrew MacFarlan of Wigan. His County scroll that had lingered as a backlog for 21 years had finally been completed, and was presented to him in Court. Scroll by Shirin of Susa with words by Arias Beltran del Valle.

Their Majesties called for THLady Máirin Ó Nialláin. She had been inducted into the Scarlet Guard in abstentia by Their predecessors,

so Their Majesties wished to recognize her publicly and present her scroll by Arden Scot.

Their Majesties called for THLady Kathryn MacLuing. Her long service as a heald and scribe has had a huge influence on her Barony and region. Their Majesties decided to recognize this by naming her a Baroness of Their Court. Scroll by Amalie Reinhardt.

Their Majesties called for THLady Astridr vigaskegg. Her skills in the arts, especially kitchen arts have gathered great renown. Their Majesties called for the Order of the Laurel and issued her a writ to contemplate entry into that order. Scroll by Ian Kennoven and Jon Blaecstan.

Their Majesties called for Duke Gareth Kincaid. His generosity and constant service to the Kingdom and Society have caused the Order of the Pelican to speak up. Thus Their Majesties issued him a writ of summons to contemplate entry into that order.

Their Majesties called for the scribes, wordsmiths, and regaliawrights who provided for Their Court and allowed them to pick from the scribal goodie box.

Her Majesty named Lord Cedric de Lothian as her inspiration for the day.

The rolls of the Royalty of Æthelmearc were read.

The officers of the Kingdom of Æthelmearc renewed their oath of service.

The Royal Peers spoke their oath

The Order of the Chivalry renewed their fealty.

The Order of the Laurel renewed their oaths.

The Order of the Pelican swore their oaths

The Order of Defense renewed their vows

Baronial Fealty was sworn by The Barony-Marche of the Debatable Lands, The Barony of the Rhydderich Hael, The Barony of Delftwood, The Barony of Blackstone Mountain, and the Barony of St Swithin's Bog.

Their Majesties invested Their Reign Coordinator Lady Ascillia Attebroke.

They invested Their Head Retainer Baroness Aine ny Allane along with Their retainers.

They invested the Co-Captains of Her Majesty's Guard THLord Tiberious Hostilous Maleus and Baron Christian Goldenlock.

They invester Her Majesty's Privy Secretary THLord Angelino the

Bookmaker.

Their Majesties called for Count Andreas Morgan and Countess Kallista Mogunova. They spoke of the hard work that comes with the job of Royalty and were pleased to name them the 14th Duke of Æthelmearc and the 15th Duchess of Æthelmearc. Matching scrolls by Murdoch Bayne.

Court Suspended.

#### Evening Court

Here continues the Record of the Court of Gareth IV and Juliana IV, King and Queen of Æthelmearc, upon the day of Their Coronation, September 16, AS LVIII in Their Shire of Misty Highlands; as reported by Baron Arias Beltran del Valle, Jewel of Æthelmearc Herald, with the assistance of Lærifaðir Jorundr hinn rotinn, Silver Buccle Herald, and His Lordship Angellino the Bookmaker.

After greeting the gathered populace, Their Majesties asked those newcomers present to attend them in Their Court. Since none remained present at the time, They encouraged the populace to welcome newcomers to the Society whenever possible.

Their Majesties then summoned Benjamin of Ballachlagan to Their Court. Word had reached Their ears of the work Benjamin does in kitchens around the shire and the kingdom, celebrating his skill even at his young age. For his efforts and labor did They award him a Silver Sycamore. Scroll is a work by Baroness Katherine Kearsey.

Clive Shattershield was summoned to Their Majesties next and given the children's toy box, before being bid to run from Court.

As has been tradition, the children of the kingdom then gave chase to receive a gift.

Their Majesties then invited the autocrats for the day, Baron Arias Beltran del Valle and Baron Salvadore de la Torres, to speak about the event. They thanked those who assisted them on the day, including Mistress Shirin al-Sussiyya and Baron Cunedda Kell, as well as all those who assisted in creation of the dayboard for the event, and Baroness Adelyn Idesbourne for her work crafting a delicious feast.

Baron Arias was bid to return by Lærifaðir Jorundr as Silver Buccle Herald, who invested him as the Jewel of Æthelmearc herald for Their Majesties' reign.

With leave of Their Majesties, Silver Buccle remained to complete further business, calling for Baroness Kathryn Mac Cluing who wished to retire from her post as Millrind Herald. Silver Buccle thanked her for her service in that role, and divested her of the tabard of her post, bidding anyone interested in the role to consult with him.

Sir Marek Viacheldrago was invited into court to speak about the Heavy Weapons Championship held on the day. While many competed for the honor of the champion's title, His Lordship Gareth Whytebull had emerged victorious, and Their Majesties bid him take his place in Their Court, thanking Sir Marek for his time in that role. Scroll was a work by Mistress Roberta McMoreland, Master Po Silvertop and Lady Murdia Drusilla Vettia Portia.

Baron Salvadore was once again called into Court to speak on the

Bring Your Best fencing tournament also held that day by the wishes of Her Majesty Juliana. Dozens of fencers had answered her call that day and Master lago Benitez was acknowledged as the victor. He and Master Clewin Kupferhelbelinc were invited before Their Majesties, both to be recognized for their prowess that day, and to recognize Master lago's victory. Scroll limned by His Lordship Angellino the Bookmaker and Her Ladyship Ylaire Sainte Claire.

Their Majesties then called for Giovanni Alberici to attend Them in Their Court. Despite only recently becoming a subject of the Kingdom, his skill in fencing had already earned him renown, including high placement in both the cadet and novice tournaments at Pennsic, as well as being recognized the latter as most chivalrous. For this were Their Majesties minded to Award him Arms. Scroll done by Lady Kolfinna Jodisardottir and Master Po Silvertop.

Their Majesties next called for the members of the incipient Æthelmearc Forester's Guild. They asked those members to share with the populace the guild's activities and work, and found it worthy of recognition, signing the Guild's petition for recognition and entrusting them with the task of educating the populace about the forest lands that give the kingdom its name.

Their Majesties then summoned one of the Captains of Her Majesty's Guard, His Lordship Tiberious Hostilious Malous. While Tiberious has earned renown on the heavy field, They were also impressed by his leather crafting work, creating armor for many across the kingdom and embellishing his work with artistic skill. So did They add him to Their Order of the Sycamore. Scroll by her Ladyship Lisabetta de Rossi.

Lady Marsaili mac Lochlainn was next called to Their Majesties' Court. Marsaili is yet another in the Kingdom whose renown on the fencing list field has grown of late. Having achieved several tournament victories of her own, Their Majesties were minded to add her to the Order of the Golden Alce. Scroll by Master Christofano and Mistress Sadira.

Their Majesties then invited members of the Kingdom Moneyer's Guild to join Them in court, where They were presented with a first run of coins created to commemorate Their nascent reign. Their Majesties thanked the Guild for their largesse and looked forward to seeing them and their work again at the coming Crown Tournament.

Lady Birna Rikardskona in blakki bjarn was summoned to the Royal Presence, escorted by her Lord Rikardr in blakki bjarn. Their Majesties noted that while many may not be familiar with Birna, her work behind the scenes of many an event and project has been indispensable to both Themselves and the Kingdom at various times. Such service deserved recognition and so did They Grant her Arms and name her a Baroness of Their Court. Scroll was a wooden (usable!) serving platter created by Mistress Shirin al-Susiyya, with text composed by Baron Arias Beltran del Valle.

Before Lord Rikardr in blakki Bjarn was able to depart Their presence with his Lady, he was called to return to Their Majesties. They

noted the long and growing list of Rikardr's activities in the SCA, including Archery, thrown weapons, heavy fighting and marshaling of all three, as well as being a problem solver to whatever challenges may be thrown his way. This too did They deem worthy of recognition, and so was Rikardr, too, Granted Arms and made a Baron of Their Court. Scroll was a serving tray created by the hand of his Lordship Sasson de Sancta Victoria, with text composed by Baron Arias Beltran del Valle.

Next, Their Majesties called for the attendance of Don Markus Skalpr Grimmson. Their Majesties, having stalled slightly for time earlier so her Ladyship Sumayya al Ghaziyah could be present, commented on his clear skill upon the rapier field and spoke of how his mastery of the blade had drawn their attention. So, too, had his prowess drawn the attention of Their Most Noble Order of Defense, who were also invited into Court, confirming their wish that Don Markus be added to the number of that august Order. Thus did Their Majesties issue him a writ to consider elevation to the same. Scroll was a work by her Ladyship Lisabetta de Rossi.

Mistress Olyf Moorcroft was then invited to Their Majesties presence, however, she was laboring in the kitchen, and so did Their Majesties then call for those who had contributed work to a scroll issued that day. In gratitude for the scribes' continued service were they offered a gift on behalf of the Kingdom.

Mistress Olyf, having been retrieved from the kitchen, did then attend Their Majesties. Her Majesty had been told of certain generous acts performed for newcomers that very morning, and was moved by her kindness, that she should help those unknown to her on the day of their first event. For this did Queen Juliana name Mistress Olyf her inspiration for the day, granting her a token and a note of gratitude.

His Majesty then addressed the populace and encouraged those about to join him in the coming year to attend Gulf Wars.

There being no further business before Them, Their Majesties' Court was thus closed.

On the thrown weapons range.

For this Their Majesties named her a Companion of the Keystone. Scroll by Kolfina Jodisdottir with words by Po Silvertop.

Their Majesties summoned Lady Logan Latta de Kent. Logan has shown prowess on the fencing field, especially with katana.For this Their Majesties inducted her into the Order of the Golden Alce. Scroll by Roberta McMorland with words by Po Silvertop.

Lord Marcos Baltanas was called to present himself before Their Majesties. Marcos has shown himself to be a force on the fencing field. His skill with the blade and leadership on the melee field impressed Their Majesties so They

inducted him into the Order of the Golden Alce. Scroll by Robaird Michael Patrick Timothy James O'Suilleabhainn with calligraphy by Gwen Cooke.

Their Majesties called for THLord Abdullah al- Rashid. They spoke of how well put together his garb always is, and how he strives for accuracy in his dress. They were pleased to make him a Companion of the Golden Mirror. Scroll by Abigail Kelhoge with words by Dorinda Courtenay.

Their Majesties demanded the presence of Lady Genevieve O'Connor. Her presence had not gone unnoticed. She serves her Kingdom and Barony in many ways, such as holding offices, running troll at events, retaining, and running hospitality at the Æthelmearc Royal Encampment. For this a group of people brought her to Their Majesties' attention. Thus Their Majesties inducted Genevieve into the Order of the Millrind. Scroll by Katherine Kiersey.

Baroness Rosemund von Glinde was called to present herself before Their Majesties. She has been serving the Barony of the Rhydderich Hael for quite a while. She has served as Chatelaine, she has hosted many workshops, and served as event staff countless times. For this Their Majesties named her a Companion of the Millrindd. Scroll by Jon Blaecstan.

Their Majesties called for Baroness Dubheasa inghen Dubgaill. Dubheasa has been serving her Kingdom and Barony for a long time, as tollner, as a volunteer at Æthelmearc Royal Hospitality, and many other ways. For this Their Majesties issued her a writ of summons to contemplate entry into the Order of the Pelican. Scroll by Zosia Kowalewska.

Her Majesty called for Baron Caleb Reynolds, who had survived the sacrifice. Her Majesty spoke of how he always makes those around him have fun, and supports people, for this she named him Her inspiration and awarded him a Golden Escarbuncle.

Their Majesties called the scribes, wordsmiths, and regaliawrights and bid them take a gift from the scribal goodie box.

His Majesty spoke of how good the day was, and that it was a pleasure to see the hospitality of the Rhydderich Hael and Canton of Beau Fleuve, Their Majesties really felt quite welcome as They visited. #### **Crown Tournament**

Sept 30th, AS 58 Court of Court of Gareth IV and Juliana IV

Here continues the Record of the Court of Gareth IV and Juliana IV, King and Queen of Æthelmearc, at Their Crown Tournament, September 30, AS LVIII in Their Barony of Blacktsone Mountain; as reported by Baron Arias Beltran del Valle, Jewel of Æthelmearc Herald, assisted by His Lordship Angellino the Bookmaker, jorundr hinn rotinn, Silver Buccle Herald, and allegedly by His Grace Duke Timothy..

In the morning before the proces-

sion.

Their Majesties called for The Kingdom Seneschal, Mistress Illadore de Bedagrayne. Mistress Illadore has served for many years, and had reached the end of her term. She called for letters and was ready to step down. Their Majesties thanked her for her service and called Baron Pádraig Ó Branduibh before Them. After confirming it was still Baron Padraig's wish to continue, Illadore gave him a personal gift of regalia, and Their Majesties took his oath as Seneschal of the Kingdom of Æthelmearc.

Court Suspended.

On the list field after the Crown Tournament finals.

Their Majesties called for Sir Murdoch Bayne and Mistress Rioghnach ny Rise. They took their oath as Heirs of the Kingdom of Æthelmearc and simultaneously Crowned Them Price Murdoch and Princess Rioghnach.

After reopening Their Court, Their Majesties called for Jocelyn de Brienne to attend Them. Despite her young age, her works to support the kingdom were seen by many and known to more as those of a helpful and industrious youth. So did Their Majesties award her a Silver Buccle. Scroll was a work of THL Gwen Cooke.

The youth of the kingdom were then summoned to court and sent on to find a toy with which to amuse themselves from the kingdom's toy chest.

The Ladies of the Rose were then invited into Court to speak of the combat they had witnessed today,

and to honor those fighters whose deeds brought them both honor and glory. THL Hrafn, Lord Samuel of Great Oaks, and Lord Atrox of Hibernia were honored with tokens for their deeds and courtesy on the day.

However, one combatant had risen above the rest, and so did the Ladies of the Rose ask THL Halfdan to bear the Shield of Chivalry on their behalf. His Lordship did accept this honor and took his place in Their Majesties' Court, relieving His Excellency Cunedda of that duty. The gathered Roses also thanked His Excellency for his time in bearing the Shield of Chivalry as well.

Dagny Skaldadottir was also called to Their Majesties' Court. Word of the range of work she completes for her home Barony of Blackstone Mountain, whether wrangling children or cooking in kitchens, had also reached the King and Queen and so were they, too, minded to Award her Arms. Scroll by Baroness Katherine Kiersey.

Lady Ascilia Attebroke was then called to appear. Their Majesties had seen her grow in martial skill, despite having to overcome significant physical challenges to do so. Equally important was her willingness to help shepherd newer fighters as well. For this did They add her to the Order of the Golden Alce. Scroll was a wood work by His Majesty Gareth, His Lordship Tiberious Hostilious Malous and Baron Christian Goldenlok.

Their Majesties then called for the attendance of Lord Ulryck Volckhart. Ulryck's skill with thrown weapons has only been growing, and Their Majesties had both heard stories of his prowess and of his title of Thrown Weapons Champion for Blackstone Mountain at the last Seven Pearls event. Therefore did They see fit to add him as well to Their Order of the Golden Alce. Scroll is a work by Lord Chahagan Ghunan and Lady Christina Mary Lowe.

Their Majesties bid Lord Ulryck stay a moment, as They then called for his Lady Verena Talhain to attend them as well. Verena's service in kitchens in the Barony was well-known, but of perhaps greater import was her friendly countenance and welcoming demeanor, especially to those new to the Society. For this did Their Majesties add her to Their Order of the Cornelian. Scroll is by Mistress Zofia Kowalewska.

Their Majesties called for His Lordship Bjarki Rikarðarson. His skill with archery and his support of that community have caused a certain order to speak to Their Majesties. Thus Their Majesties called for Their Order of the Scarlet Guard and named Bjarki a Companion thereof. Scroll by Kolfinna Jodisardottir with words by Jehan LeBlanc.

Next was THL Deirdre Scot of Clan Scot called to Their Majesties' presence. Those who knew Dierdre knew well of her skill in the kitchen of the kingdom, and knew also that anyone leaving hungry from an event where she was in the kitchen would do so with only themselves to blame. For her skill and devotion to the culinary arts did Their Majesties add her to Their Order of the Sycamore. Scroll is a work by Baroness Zafira.

As her ladyship departed, Their Majesties invited Sir Arden Scot to join Them. Word of the growth in his artistry had spread for and wide through the Kingdom, as had the many scrolls he had contributed to recognize members of the populace.
