Submission Guidelines for The Pale

ARTICLES on period topics, history, art, puzzles, SCA life, bardic stories and the like are welcome additions to *The Pale*. A 500- to 1000-word article will usually fit in one issue; longer articles will be split into multiple parts to appear in successive issues. Submit the file in MS Word .doc format along with an SCA Creative Release form. Send the images used in the article as separate files using the format described below.

You must cite all references, quotations and sources in your article using the Chicago Manual of Style format. Sample citations are located here: www.chicagomanualofstyle.org/tools_citationguide. html. Citing sources is very important to avoid accusations of plagiarism and legal action for copyright violation.

IMAGES, such as line art, calligraphy, illumination and photographs are also welcome. Scan any artwork at 300 dpi and save it at the highest quality JPG setting. Photos should also be 300 dpi, high quality JPGs. All images will appear in print as black and white, but the online version of *The Pale* is in color. Images can also be submitted as high quality TIF or PDF files. Any artwork or photography submitted to *The Pale* must have a signed SCA Creative Release or SCA Photographer Release form from the artist sent in with the work. Any person identifiable in an image must submit a signed SCA Model Release form with the art work. This is a requirement of SCA Inc. for print publication. All release forms are available at www.midrealm.org/chronicler.

EVENT PREVIEWS: A free event preview of 50 words is available to all events. The listing **MUST include the name of the event, sponsoring group, site address, date, times and event steward contact information.**

EVENT NOTICES (ads) must be published in *The Pale* for events at which any of the following occur: crown and coronet tournaments, coronations and investitures, appointment of kingdom or principality officers, presentation of awards and titles, proclamation of law, establishment or advancement of branches. **These activities cannot take place unless a complete event notice appears in** *The Pale*, the Middle Kingdom newsletter, at least once before the date of the event. The publication requirement may only be waived in extraordinary circumstances, such as a natural disaster.

Events must **already** be listed on the Middle Kingdom Calendar prior to advertising in *The Pale*, but an event listing on the Middle Kingdom Calendar does **NOT** constitute "official publication". Incipient groups must submit a scan of the sponsorship form to the Editor. Event submissions to the Kingdom Calendar should be submitted through the **online form** available on the calendar

page. Any issues contact the Middle Kingdom Calendar Secretary at calendar@midrealm.org. Middle Kingdom events receive free event ads that run in the next issue unless otherwise specified. Out-of-kingdom events and merchants pay the listed rates.

Ad templates for the quarter and half page ads are available at http://midrealm.org/chronicler/thepale/. All ads must be submitted to *The Pale* via e-mail attachment in DOC, PDF, JPG, or TIF format.

WITHOUT EXCEPTION, EVENT NOTICES MUST INCLUDE event name, sponsoring group, dates, times, site address, site registration, website URL, NAME (SCA & modern), email address and phone number of the event steward. Simple driving directions to the event site are useful but not required. All clip art images in event notices must have a source listed and be used in accordance with the terms of use. All artwork MUST include an SCA Creative Release form from the author(s) or artist(s). SCA Model Releases are required for identifiable persons in any image. Submissions are edited for grammar, spelling, space constraints, inflammatory or explicit language and compliance with Middle Kingdom Law. Editorial decisions are final. "Letters to the Editor" are not permitted per SCA Inc. regulations.

PLEASE NOTE THAT MIDDLE KINGDOM EVENTS NO LONGER NEED TO PAY FOR ANY EVENT ADS AS OF OCTOBER 2016.

I also plan to contact many of my Deputy offices and have them provide a write-up of what their office provides to the populace. The first such letter I have is from our Escutcheon Herald, Lady Marketa z Prahy.

Greetings!

I'm Lady Markéta z Prahy, your Escutcheon Herald (internal submissions). What is that? My job is to receive submissions, via snail mail or electronically. I receive the payment, review the paperwork to make sure it makes sense (follows basic SCA naming and heraldry rules, isn't on the wrong form, has the appropriate payment) and put it into OSCAR. I answer submission questions to the best of my ability and try to keep up with changes in SENA.

When your submission gets sent in, it's not just me who looks at it. The process just starts with me (internal submissions). When I hand off a month's submissions, commenters (heralds, former heralds) can make notes on the submissions; commenters (heralds, former heralds) can make notes on the submissions; some comment on names, some armory, some both, depending on

their knowledge base - and the knowledge our commenters bring is both Deep and Wide. Then Rouge sends the submissions, with commentary, up to the Laurels. They get more time to review, and their final decisions (the Letter of Acceptance and Returns 'LoAR') are posted online in multiple places. It's a bunch of steps, but it gives local, regional, and potentially Society-wide folk opportunities to help with the process, and keeps it from being too much on any one person.

Submissions, registration - I have a blue card (membership) with my SCA name on it, isn't that registration? Sorry, no. The membership card is a statement that you've paid fees to help run our little game. It does not 'protect' your name, which registering via OSCAR will do. If you register your name in OSCAR, no one can register a name which claims a relationship to you or comes too close to yours (conflict!) without your approval (Permission to Conflict). The same policy holds for devices and badges which are registered.

So that's what the Escutcheon Herald does. As for me, I do a little of a lot; a little spinning, a little illumination, a little ring-making, a little sewing... I like to try new things and learn something I didn't know. At an event, I might be in class, or helping out in the kitchen; if you sit feast, I may be your server. Like being Internal Submissions (behind my computer), I like working in the background to help make events run smoothly.

That, in a nutshell, is what I do, and what the job of Escutcheon Herald does. Any questions? Feel free to e-mail me at submissions@midrealm.org. I'll help as much as I can, and when I don't know, I'll find someone who does.

From the SCA Board of Directors

DRAFT PROPOSAL FOR COMMENTARY

CORPORATE POLICY XIX. DELEGATION OF INVESTMENT AUTHORITY POLICY

The Board of Directors is currently considering the following addition to the SCA's Corporate Policy:

XIX. Delegation of Investment Authority Policy

The Board shall ensure that fiduciary responsibilities concerning the proper management of SCA, Inc.'s institutional funds are fulfilled through appropriate investment structure, internal and external management, and portfolio performance consistent with all policies and procedures. Based on the advice and recommendations of the Treasurer and its external fund manager(s), the Board shall approve investment policies and objectives that reflect the long-term investment-risk orientation appropriate to the organization. The Board may, at its sole discretion, create or liminate committee(s) to advise the Board in furthering its duties and may select, appoint, and remove members thereto.

The Board hereby delegates supervisory responsibility for the management of its invested funds to the Corporate Treasurer, subject to the financial limitations specified in Corpora, as noted below:

- determine that institutional funds are prudently and effectively managed with the assistance of management and any necessary investment consultants and/or other outside professionals, if any.
- recommend the retention and/or dismissal of investment consultants and/or other outside professionals.
- receive and review reports from management, investment consultants and/or other outside professionals, if any.
- periodically meet with management, investment consultants and/or other outside professionals management, investment consultants and/or other outside professionals.
- report to the Board (as needed) whether this policy, investment activities, risk management controls and processes continue to be consistent with meeting the goals and objectives set for the management of institutional funds.
- execute such investment transactions as are necessary to ensure that SCA, Inc.'s investment portfolio reflects the asset allocation, investment-risk orientation, or other direction regarding the investment portfolio as has been established by the Board.

Middle Kingdom Law Changes and Proposals

Changes to Middle Kingdom Law are not only published in The Pale, but also available on the Middle Kingdom website at http://midrealm.org/seneschall/lawclerk, the page for the Middle Kingdom Law Clerk. A link to the direct page for each change will also be available on the Law Clerk's page, as well as any information available for proposed law changes.

The following to be removed from Kingdom law:

ARTICLE V - Requirements for Authorizations for Combat Activity

2-V-100 All persons shall be formally accepted, tested, and approved for combat activities as defined in Governing and Policy Decision 12 before entering any lists held within the Middle Kingdom. Authorizations for the lists of the Middle Kingdom shall be conducted by the Crown or heir designate.
