SCA CORPORATE ANNOUNCEMENTS

APPLICATIONS EXTENDED – SOCIETY SENESCHAL

Applications for the next Society Seneschal/ Vice President for Operations have been extended and are being accepted until 31 March 2024.

This vital role is key in the Society's operations and functions and will be supported through a significant handover process.

The Society Seneschal is considered both a Society and Corporate officer, and is responsible for coordinating the administration of the Society's historical re-creation. This involves directing the activities of the Kingdom Seneschals and of Society-level deputies. Where questions arise concerning the intent of Corpora, the Board specifically authorizes the Society Seneschal to make interpretations and clarifications. The Society Seneschal is also responsible for reviewing all sanction related activities.

This is a part-time stipend position requiring a minimum of 25 hours per week, often more.

Applicants must possess strong communication skills and be capable of interacting with unique SCA personalities without regard to rank or position in the organization. The ability to process and distill large amounts of information from multiple sources is required. Organizational and problem-solving skills are essential. Having held a Kingdom Seneschal position, while not required, is preferred. Applicants must be capable of maintaining a home office space, have access to internet, PC/ tablet, printer, and possess word processing skills. Proficiency with Microsoft Office and Adobe Pro is a plus. Ready access to postal service for the mailing of trackable documents is required.

Required skills or background:

- · Prior experience in positions of leadership within the SCA or in leading volunteer organizations
- · Excellent working knowledge of current SCA corporate documents and handbooks
- · Ability to research issues surrounding kingdom and Society rules and policies
- · Understanding of how the SCA's sanction and investigative procedures work; direct experience with these procedures is preferred
- · Ability to maintain confidentiality of investigations and other confidential material
- · Ability to manage multiple projects and oversee volunteers on both Society and Kingdom levels
- · Excellent communication skills, both written and oral
- · The ability and willingness to communicate via email, phone, and videoconferencing on a regular basis
- · Ability to explain policies, delegate projects, and build consensus

The Society Seneschal is responsible for the following duties:

- · Oversee directly and indirectly the planning and implementation of all "game side" activities.
- · Deal with large amounts of correspondence with many individuals, including but not limited to all kingdom seneschals, royalty, and corporate/Society level officers, especially the President, VP for Corporate Operations, and Executive Assistant to the Board of Directors.
- · Meet via videoconference and/or phone with kingdom seneschals, Directors, and other corporate and Society officers several times a month.
- · Provide training and advice to kingdom seneschals on a regular basis.
- · Present sanction packets to the Board and provide oversight of investigations related to possible sanctions.
- · Interpret Corpora and other SCA policies as needed; revise policies and create new policies as needed to facilitate SCA activities.
- · Evaluate and create documentation as needed to facilitate a positive experience for SCA participants.
- · Quarterly review of all Kingdom Seneschal reports, respond to reports, and refer Kingdom Seneschal requests or questions to the appropriate Society or Corporate officer for assistance as needed.
- · Submit detailed quarterly reports to the President and Board, and supplemental reports as needed.
- · Attend all quarterly meetings of the Board of Directors, mid-quarter conference call meetings, and other meetings as required.
- · Other duties and projects may be assigned by the Board or President.

The Society Seneschal must be available for the four quarterly Board meetings, typically held over a Friday and Saturday or a Saturday and Sunday. These meetings may be held via videoconference or in person. In-person meetings require travel, typically on a Thursday and Sunday. In addition, the Society Seneschal must be available for conference call meetings of the Board four to twelve times a year, typically on weekday evenings, and meetings or calls with officers or directors on an as-needed basis. Additional travel besides the quarterly meetings may be required, typically around SCA events.

PATRON MEMBERSHIP – CORPORA COMMENTARY REQUEST

As part of the upcoming addition of a Patron membership, we invite you to provide commentary on the language changes in Corpora that this update will require. This commentary will assist the Board in forming further decisions relevant to its consideration of this matter.

What is the Patron Membership?

 It is a membership tier that offers the option of a greater financial contribution to the organisation. Many non-profit organisations offer tiers of membership.

What is the proposed cost of a patron membership?

• The proposed cost of the patron membership is \$150 a year.

Is it linked to titles or in game recognition?

• No. Some Kingdoms require paid annual memberships rather than an

event membership (non member rate) for awards but this is not a Society wide requirement.

Is it mandatory?

No.

Who asked for it?

 The Corporate Office has received feedback from members at times that this is an option people would like available.

What are the benefits of a Patron membership?

 The main benefit is knowing that you are contributing to the ongoing administrative functioning of the Society in a way that you prefer. The organisation is providing a small range of options as a gesture of its appreciation for your generosity.

Commentary regarding this proposed Corpora change must be received by the Board no later than May 3, 2024.

Add #6 to Corporate Policies below. In bold.

Corporate Policies, I.B, 1-4—Membership Types-Non-Statutory Members:

B. Non-Statutory Members

The Board of Directors has designated the following categories of advisory membership. Such advisory members are not members within the meaning of Section 5056 of the California Corporations Code. California law supports the SCA's use of the terms "member" and "membership" in the common English meaning, referring to persons who have paid to be associated with the organization.

- 1. Sustaining Membership conveys eligibility to hold office in the SCA, a subscription to a Kingdom newsletter, the option to subscribe to other Corporate publications, and any other privileges designated by the SCA or its subdivisions as accruing to members of the SCA. This type of membership is considered a subscribing membership.
- 2. International Membership conveys the privileges of Section I.B.1. This membership type is available only in locations outside the United States which are part of the SCA, Inc., and not subject to an affiliate corporation. This type of membership is considered a subscribing membership.
- 3. Associate Membership conveys eligibility to hold office in the SCA, except where other membership categories are required Governing Documents. Associate membership also entitles the holder to any privileges designated by the SCA or its subdivisions as accruing to members of the SCA, except where another membership type is specifically required by the organization defining the privilege. This type of membership is not considered a subscribing membership.

4. Family Membership extends the privileges of Section I.B.1 to one additional adult and any children aged 21 or younger who live at the same physical address as a member defined in paragraphs B.1-

B.2 of this Article. This type of membership is not considered a subscribing membership.

- 5. Institutional Membership allows a library or school to subscribe to Tournaments Illuminated and The Compleat Anachronist without acquiring the regional newsletter, and without any of the other privileges of membership. The Board reserves the right to determine whether or not a given organization qualifies for this membership type
- 6. Patron Membership conveys all privileges of 1.B.1. along with additional privileges as designated by the SCA. Corpora, including the By-Laws, can be found in its entirety here: https://www.sca.org/resources/document-library/govdocs/.

PayPal Deputy Job Description - approved by Stallari 5-1-2021

The PayPal Officer is a Lesser Officer to the Chancellor of the Exchequer and is responsible for administration, setup, education and transferring of funds for every event that uses PayPal. These duties also include delivering and meeting deadlines for the following:

The PayPal Officer is responsible for the maintenance of the Kingdom PayPal account, and is the primary contact for local groups wishing to use PayPal for event registration. This requires that they:

- Ensure that PayPal business account paypaladmin@northshield.org remains active, and that the password is current and known by the PayPal Officer and the Kingdom Chancellor of the Exchequer.
- Ensure that all funds collected in the Kingdom PayPal business account are transferred into the Kingdom PayPal checking account in a timely manner.
- Compile a list of all payments made to the Kingdom PayPal account, and the total of fees paid to PayPal for the use of the account.
- Read emails sent to the email address associated with the office on the Kingdom webpage on a regular basis; and respond to all requests in a timely manner.

When local groups within the Kingdom choose to use PayPal for event preregistration, the PayPal Officer is responsible to facilitate those registrations. This requires that they:

 Ensure that a link is created for use on the event page for any event wishing to use PayPal that will allow a registration request to be submitted to the Kingdom PayPal Officer.

- Ensure that all individuals requesting registration are issued a PayPal invoice for the appropriate amount for the services requested.
- Compile a list of all individuals registering for an event using PayPal, the services they requested, the amount they paid into PayPal, the fees collected by PayPal, and the net amount to be paid into to Kingdom PayPal checking account for that individual's registration. The compiled list of all individual registering for a given event will be submitted to the Kingdom Exchequer and the Event Steward within 48 hours of the close of preregistration.
- When local groups within the Kingdom choose to use PayPal for registration at the event gate, the PayPal Officer is responsible to facilitate those registrations. This requires that they:
- Ensure that, when a local group submits a completed authorization form to use PayPal, any individuals from that group who will be accepting credit card payments at the gate are given instruction in how to use the tools to successfully complete the PayPal charges.
- Ensure that the local group are aware of and responsible for necessary requirements to accept credit card payments at the gate, including a secure internet connection, a smart phone or tablet, and a PayPal-acceptable credit card reader.
- Ensure that a unique PayPal login is created for each Exchequer taking cards, and that said login is disabled after the event.

• Compile a list of all individuals registering for an event using PayPal, the services they requested, the amount they paid into PayPal, the fees collected by PayPal, and the net amount to be paid into to Kingdom PayPal checking account for that individual's registration. The compiled list of all individual registering for a given event will be submitted to the Kingdom Exchequer and the Event Steward within 48 hours of the close of the event.

Time Commitments

Workload will vary but expect to put in an average of 4 hours a week, with more time being required prior to or during events using PayPal registration. Meeting travel is not required for this position.

This is a warranted position that requires approval of the Crown and the Kingdom Exchequer. Warranted officers must be paid members of SCA, Inc.

Dependable phone access.

Dependable internet access capable of supporting Zoom or similar meeting software.

Moderate proficiency with Microsoft Excel and similar spreadsheet applications.

Moderate proficiency with Microsoft Word and similar word processing applications.

Ability to clearly communicate verbally and in writing, i.e. in person and via email, phone, and in written reports.

Working knowledge of relevant procedures and processes, including the Northshield PayPal Policy.

DEAR ABBESS:

As a traveling merchant, my caravan ranges widely and I often hear tales of fantastic beasts, terrifying monsters, giants, dragons, and the like. Occasionally I encounter locals who point to strange bones as evidence that such creatures are real. Most recently, passing through the vast desert on my way to do business in the lands of the Great Khan, I was shown the bones of a creature like a great beaked lion. I believe it to be a griffin, but was curious whether you knew of the habitat and range of such a creature, since I had only heard of it from the Greeks up until this point and none of them had ever seen a living one. Is it possible that such a beast may still roam the earth to the east? Should I be worried enough to increase the number of caravan guards in my employ?

DEAR SOJOURNING,



To my knowledge, no one has ever reported seeing a living griffin with their own eyes. Tales of such a creature in the region you mention date back many centuries, however. A Greek traveler by the name of Aristeas is known to have recorded stories of the griffin as told to him by the Scythians, who described beaked, lion-

sized monsters that lived in the desert far to the east. In more recent years, the people of those lands (now conquered by Genghis Khan) still fear this desert, which is littered with large strange bones that resemble no living beast. So while you may indeed have seen the bones of a griffin, the creatures are likely long extinct and you need not fear this particular wild beast.


