

Greetings unto the populace of Northshield,

It's that time of year again. All local chroniclers, webministers, and social media officers need to submit their annual Domesday reports, due by Saturday, November 25th. All chroniclers, webministers, and SMOs must report to maintain their warrants.

I want to welcome our Once and Future Kingdom Webminister, Baron Abelard die Elster, to the office and I want to thank Bâro Iohannes Glenfidanus for his years of service in the office.

We are now twelve issues away from Northshield's twentieth kingdom anniversary. We are planning a series of articles to commemorate our history, starting with Master Caradoc's history on the Principality of Northshield. I encourage people to submit articles, photos, artwork, songs, and poems commemorating not only our twenty years as a kingdom, but also eight years as a territorial principality, almost three years as a crown principality, and a decade and a half as a region.

With all this history being commemorated, I am looking for a volunteer to serve as kingdom archivist/historian. The **Kingdom Historian/Archivist** office is a deputy to the Kingdom Chronicler and is responsible for processing, cataloguing and preserving the collection of Northshield's history: written documents, newsletters, oral history, and artifacts from Northshield's past, present and the future.

In addition to the kingdom archivist/ historian office, we still have a number of kingdom deputy offices open. They include

Media Relations Deputy – Serve as a liaison between Northshield and modern media outlets, and as a resource for local groups when dealing with media outlets.

**Deputy** *Northwatch* Editor – Assist the *Northwatch* editor as needed. (Editor's note: Please! I could use the help.)

Western, Central, and Eastern Regional Deputy Social Media Officers (SMO) – Serve as a resource for local SMOs in their region and assist Kingdom SMO with oversight.

**TikTok Deputy SMO** – Help to promote Northshield and the SCA via TikTok.

Lastly, no one has applied to serve as Kingdom Chronicler by the initial September 1st deadline. Therefore, I intend to serve out the remainder of my term to June 1, 2024. Laurel is an unpaid position, currently requiring approximately 20 hours a week. The position requires considerable tact and

patience, armory and onomastic knowledge, supervisory ability, the ability to work within tight deadlines and coordinate closely with Wreath, Pelican, and other staff to produce a Laurel Letter of Acceptance and Return monthly, computer literacy and word processing skills, reliable e-mail and telephone access, and time and ability to travel.



#### **DEAR ABBESS:**

I run a workshop in London, and every time I call either of my apprentices to their work, they are absent. I took them to task, only to learn that the mercer next door has been sending them to make his daily deliveries and they did not want to show disrespect for a craftsmaster. I told my neighbor I don't mind doing the occasional favor, but he has three apprentices of his own to do the work. Now the mercer has stopped "borrowing" my apprentices, but his journeymen, senior apprentices, and even his wife still command them about. And while they are doing his work, my workshop is running behind on commissions and they are not learning their trade. How do I end this imposition without risking my supplier?

#### DEAR CHOLERIC,

Believe it or not, the law is probably on your side – or, I



should say, on your apprentices' side, as they are the ones doing all the hauling. You do not mention your specific guild affiliation, but since you mention that the mercer in question is your supplier, I would infer that you are likely a tailor. You may wish to investigate the rules put in place

by the Mercers' Guild, as these regulations often include a prohibition against forcing (or inducing) one master's apprentice into laboring for another without permission. Poaching another person's apprentice may come with a stiff penalty, so you could remain within your supplier's good graces by gently reminding him that even though he himself has desisted, other people within his workshop are continuing to engage in a forbidden practice and that you have refrained from reporting him, but that others are bound to notice eventually. Especially since he runs the risk of angering the Guild of Porters if his workers are using your apprentices instead of porters to haul his goods around. You might also remind him that his wife ought to take care as well, since she may one day rely on the Mercer's Guild to provide for her if she outlives him. However you choose to play it, I suggest leaning into the letter of the law rather than taking him to task personally, especially since he has shown willingness to refrain from the practice himself.

Many medieval guilds had extremely strict guidelines that went beyond regulations on who was permitted to do what types of work. These rules frequently dictated standards for behavior as well as charitable requirements. For an example, take a look at the Ordinances of the Trade Called Whittawyers (people who prepared a type of soft white leather, usually alum-tawed) from London in 1346, which can be found online at https://www.british-history.ac.uk/ NO-series/memorials-london-life/pp230-234#H3-0002.

# From The History of Windhaven

Long ago by the shores of the Forgotten Sea was a land of wealth and plenty. The people of this land were strong, industrious, and loved their leaders dearly. The leader of the land was Lord Tamarack, who was wise and just. His wife died in child-birth, so his daughter, Horcon, ruled by his side. Together they ruled the land with a sense of justice and fairness that was otherwise unheard of in this time. Throughout the land, all were happy and nary a complaint was heard.

Tamarack's neighbors, however, complained a great deal. When Tamarack fell severely wounded, the Staff of Leadership passed to Horcon. Looking around her at the mass of refugees, mostly children, the elderly and the wounded, she resolved to escape with all of them, rather than allow them to be taken by the evil outside the walls. Leaving behind a volunteer rear guard, she led her people thru a long escape tunnel into the night. Over his protests, Tamarack, far too wounded to fight, was taken along.

The rear guard fought on for two more days, but in the end were killed to a man and woman. It was another day before the invaders realized that any had escaped, and two days more before the trail was found. Then the pursuit began in earnest.

Horcon had pushed her people as far as she dared, heading north into the wilderness. Several times she led ambushes against scouting parties that came close to discovering them. Finally, after many days, their path was blocked by a great marsh. Travel was impossible to the west or north, so they followed the marsh eastward until they found that way blocked by a large lake, many miles wide. Exhausted, they collapsed here to await the end. Alone among them, Horcon still had the strength to fight, and she strode forward, grimly determined to make her enemies pay dearly...

Within the marsh dwelt Bo-tii, an ancient amphiptere (a giant winged serpent and distant cousin to the imperial dragons), and she had been here for centuries. Her last children had long since grown and flown away, often to be killed by marauding humans. aka "Samia should be careful what she asks for" (to the tune of *Sweet Betsy From Pike*)




